 - a. To ensure that Congress maintains the status of the arts as a CORE ACADEMIC SUBJECT in any reauthorization of the Elementary and Secondary Education Act (ESEA).
 - a. In order to provide students with a comprehensive education and to support music's key role in contributing to that goal, Congress must maintain the status of the arts as a core academic subject in any



- reauthorization of the Elementary and Secondary Education Act (ESEA).
- b. Music educators should be EVALUATED by qualified individuals utilizing reliable measures germane to their field.
 - a. Congress and the U.S. Department of Education should offer guidance language recommending that music educators be evaluated on how well their students learn and perform in their respective discipline. Barring extenuating circumstances preventing the implementation of such a system, all arts educators should be evaluated on how well students acquire skills germane to the field, with accountability directly attributable to individual teachers. New evaluation systems should be developed in the context of the number of students being taught and instructional time available, limiting the use of data to reliable measures. Likewise, observation-based teacher evaluations should be limited to those conducted by individuals with adequate expertise in the arts.
- ii. The U.S. Department of Education should collect RESEARCH to support the field of music education.
 - a. Congress should stipulate that the U.S. Department of Education develop and carry out the process of collecting and disseminating federal data pursuant to the status of music education and other arts programs in order to generally benefit the field, and to assist associations working to accurately gauge the landscape and provide support to educators in jeopardized areas of the country.
- iii. ACCOUNTABILITY provisions, which include a measurement of music success, are essential.
 - a. Congress should include in any reauthorization of the Elementary and Secondary Education Act (ESEA), accountability provisions which include a measurement of music and other arts programs' success, to be implemented in a manner that ensures fairness to all students.
- iv. FUNDING should be made available to music programs in all appropriate ESEA-authorized programs.
 - a. Congress should ensure that all appropriate federal funding streams under the Elementary and Secondary Education Act (ESEA) are made available to music education and other arts programs.
- v. School day ACCESSIBILITY to music education programs should be maintained and increased across the country.
 - a. Congress should offer guidance language speaking to the reduction of school day classroom time for music education



and other arts programs and recommending that this trend be reversed, however possible.

- vi. CHARTER SCHOOLS, consistent with all public schools, should provide students with a comprehensive education, including access to sequential, standards-based music education.
 - a. Congress and the U.S. Department of Education should offer guidance language to charter schools, recommending that curricular decisions be made with an eye toward providing all students with a comprehensive education, including music.

- 7) October 1st KMR Deadline for District President's Article. This must be submitted on time and given to Cathy Hunt.
- 8) October 1st All KMEA Awards Dues to Mike Quilling. Vice President Mike emphasized that it is very important that the paperwork is prepared for outstanding teacher nominations, including all letters of recommendation, and he reminded the board that each district may submit one candidate to the state for the Outstanding Teacher Award. He also requested that a high resolution picture is attached for the website. On behalf of Cathy Hunt, Troy Johnson expressed the need for pictures to be posed and of professional quality. President Craig reminded District Presidents to fill all award spots in elementary, middle school, and high school, and he cited that only the Northwest has a University Teacher Award. Vice President Mike reminded District Presidents that they may send in nominations for the Honored Administrator Award, but it is separate from the teacher award. Anyone can nominate Honored Administrators (parents, students, etc) The nominations then go into a pool from the entire state.
- 9) Oct. 6th ISW scheduling meeting President Craig explained that this is when the clinics are scheduled for the Inservice Workshop. He will have more specific directions in the future for this date, but he hopes the advisory board and affiliates can be there, as it helps the board tremendously to have their input. If anyone cannot be there, he asked that someone else be present to fill the clinic session spots. District Presidents do not attend this meeting, and it will start at 10 am and go until around noon.

ISW 2013

NAfME Executive Director, Michael Butera, will be at this year's ISW. President Craig commented on the great things he has done for the organization in the short time he has been Executive Director. The keynote address for the ISW will be given by Dr. Tim Lautzenheiser. The President's Kansas Concert will be "Storm Front," a barbershop quartet whose members also play brass instruments. President Craig said that he was greatly looking forward to their performance and supplied the following link to their website:

- NAfME Music in Washington Week. The KMEA Executive Board will be attending this year, and some of highlights of the week include:
 - 1) NAfME National Honor Ensembles President Craig indicated that he would like more of a push for this in the schools so that Kansas could have 10 or more students attending as members of these ensembles. He assured the board that all students who have participated in past years have called it a wonderful experience and a chance to meet other students from across the nation.
 - 2) NAfME Academies President Craig encouraged all of the membership to attend and described it as similar to the ISW but at a national level, as it is in the Baltimore-D.C. area.
 - 3) Visits with Kansas Legislators President Craig announced that preparations for these visits will be finalized next week, and they are planning discussions they hope to have with legislators on music education issues. They will also spend extensive time with the presidents and presidents-elect from other states' MEA's from across the country. President Craig is excited about Kansas being a leader in the country with the KMR online and looks forward to sharing the journal with other states.

IV. KMEA BOARD REPORTS

IV. a – Executive Council

Please go to the Board Book for the ISW Board Meeting to read all reports in full. Only new and or updated notes will be included in the minutes.

- President, Craig Manteuffel Report stands as written. He added that he participated in the webinar "Teacher Evaluation and Assessment in an Era of Education Reform." He considers the webinar very timely, as teacher evaluation will be discussed in August, and he asked the board to please watch the webinar. Dr. Taylor also encouraged the District Presidents to watch so they can be experts or at least informed in their districts. President Craig encouraged the board to check into the advocacy-based social media outlet sponsored by NAfME called Groundswell. He explained that anyone can join, and NAfME answers questions about music education. One can also find out information about what is happening at the national level much more quickly on this site. It is a great place to stay informed, and the membership is encouraged to join and invite parents, administrators, and community business owners to join as well.
- President Craig asked the representatives of the affiliate organizations that were present at the meeting to introduce themselves, and he thanked them for the amazing work they do and

- President-Elect, Avian Bear Report stands as written. President-Elect Avian informed the board that the listening rooms are ready, and she thanked everyone for helping with listening to the submissions for the ISW 2013. President Craig thanked Avian for all her work and planning sorting through the recording submissions.
- Vice President, Mike Quilling Report stands as written. Vice President Mike wished to highlight the "Arts' Day at the Capital" from his report. He indicated that this is the 3rd time he has gone with the KMEA delegation to participate in this event in the effort to continue receiving support for the arts. This past year, instead of going to every office with a packet of information, they scheduled meetings with legislators ahead of time to discuss fine arts. Mike was excited to report that they were received in these meetings and found the legislators very supportive. They scheduled new meetings with the Commissioner of Education Dr. DeBacker and with the Assistant Secretary of Education, and found them both very receptive. Mike was happy to say that there are proponents of fine arts in office, including Steve Morris, who graciously met with them. They were also invited to Floor of the House, where they were introduced and invited to speak with legislators and provide them with information. Mike felt it was a really important day for KMEA, and it was great to have those experts, like Fred Burrack, right in the room to give all the facts. Mike expressed that he looks forward to doing it again in the future. President Craig thanked Mike for his passion when dealing with legislative visits and for this work at the capital where he does a phenomenal job.
- Executive Director, John Taylor Report stands as written. Dr. Taylor reported that attendance was slightly up at ISW this year. Dr. Taylor highlighted an issue KMEA is having at the ISW with respect to KMEA members booking rooms at the Hyatt. He explained that people are reserving a large block and then canceling rooms very late, as close as 2 weeks before the convention. This causes the Hyatt to appear booked when, in actuality, it is not, and KMEA can only get a discount on rooms if a certain number of rooms are booked. Dr. Taylor asked the District Presidents to remind members in their districts not to book too many rooms, and any extra rooms should be canceled immediately after the live audition results are posted. Dr. Taylor also informed the board that all buildings are contracted for the ISW, including the new Fairfield Inn as a place to stay. The Broadview Hotel is also a hotel that can be stayed in for the convention, and Dr. Taylor commented that he is not involved in the actual booking of any rooms at any hotel. They are on reserve, and

individual directors may book rooms by calling, but directors need not call Dr. Taylor in the process. He reported that as KMEA ends its fiscal year, it will be with money in the bank, but he will not have any details until the books are reviewed, and that will be in his extensive report at the August Board Meeting. Dr. Taylor noted that everything is becoming more expensive, and he will likely request a small increase in ISW fees at a later meeting. He explained that due to the end of the Kansas Art's Commission, KMEA has had to operate with about \$10,000 less this year, but he hopes that new funding will come out of the Kansas Creative Industries Grant. While it has funding, it is still unknown how much funding it will receive from the National Endowment for the Arts and what the application process for the funding will entail. Dr. Taylor expressed hope that KMEA will be able to apply for funds from this grant in the next fiscal year. All of the conductors and clinicians for all state groups have been booked, and they can be announced to the district memberships. In the Elementary Room, Dr. Taylor is pleased to have Leigh Ann Garner, David Frego, and Artie Almeida all booked. Dr. Taylor encouraged the District Presidents to talk with their district executive directors about staying active in the district executive organization that was formed 2 years ago. He reminded District Presidents that the District Executive Directors are invited to the August Board Meeting, where they will meet ahead of time for an auditor meeting. Dr. Taylor indicated that in August, he will have to ask the board for an increase in the fee to cover the cost of the Friday lunch for the Middle Level Choir and High School All State Musicians. Finally, Dr. Taylor wished to thank the 8 other employees of KMEA for their hard work for this organization. He also reminded everyone to check the front of the boardbook to ensure information is correct for the website and to send Troy an email if anything is incorrect. President Craig noted that Chad followed the right procedure for dealing with filling this position by first contacting his district leadership and then contacting the state leadership to make sure

	SW District, Erica Fleeman – Report stands as written. Erica described the overall newness of her board, with new chairs, president, and executive director. She also mentioned that all clinicians for the mini-convention are secured.
	 NAfME Collegiate President, Kelsey Scheuerman – Report stands as written. Kelsey highlighted that her big goal for this year is working with Tri-M chapters to create more chapters and more involved chapters. President Craig mentioned that this is also part of his strategic plan and thanked Kelsey for this work. He also thanked Past-Presidents Emily Foreshler and Mary Rose Biltz for their work for NAfME Collegiate.
IV. c – Administrative Personnel	Webmaster, Troy Johnson – Report stands as written. Troy made one change, noting that there are now 25 proposals in the system for ISW 2013. Troy expects the number of users online to increase with the KMR online. He mentioned that he participated in many KMR meetings this year, and a new design will be launched at end of August. There will be 3 ad sizes online: The largest at \$170, next in size at \$110, and the smallest at \$50. She projects that KMR can sell approximately 25 of the 1 st position large-sized ads. Cathy also described an editors' survey she put together to compare print and online advertisement costs and sizes. Cathy announced that the submission dates have been adjusted. August 1, October 1, and January 1 content is due, and it goes up 30 days later. In the spring issue, the due-date is March 15 to accommodate camps and goes up April 15. Because the fall and spring issues are traditionally 'focus' issues, this fall's focus is teacher evaluation. Cathy would like each district to submit a paragraph from anyone in the district about his/her experience with evaluation.
	• KMR Advertising Manager, Robert Lee, Jr. – Report stands as written. Bob mentioned to the affiliates that advertising information with a rate card and descriptions will be coming via e-mail. He also gave the most current information on advertising information, changing the following information from his report: The Fall 2011 issue is now paid; The Workshop issue now at \$430 unpaid; In billing, he has received \$6875.50 and \$1835.00 remains unpaid. Bob expects all accounts to be paid by end of month.
	• Festival Ensembles, Randy Fillmore –. Randy reported that festival planning is progressing well. The auditions are posted online, and they are scheduled for January 5, 2013. All deadline dates have been posted as well.
IV.d – All State Chairs	Middle Level Choir, Deb Hill – Report stands as written. The Middle Level Choir is moving from cds to mp3's that can be submitted online only. They will not accept late entries, and the specific guidelines are being revamped. All clinicians are scheduled through 2015.
IV. e – Advisory Board	 Advocacy, Frederick Burrack – Report stands as written. Fred could not be at the meeting, but President Craig strongly encouraged members to go to the advocacy section of the website to view the data Fred has collected on the music positions being lost in the state of Kansas.

- KMEA Fund, Gayle McMillen Report stands as written.
- SMTE Representative, Marie Miller Report stands as written. Marie reported that there has been much exploration and discussion within SMTE about the group being absorbed by KMEA. She mentioned that the one large event that is put on by SMTE is KCOMTEP, which is already partially funded by KMEA. After the Collegiate NAfME board meets, SMTE will use recommendations from them to secure the guest speaker for this coming fall. Marie expressed that the membership of SMTE is very supportive of becoming an organization under the umbrella of KMEA and feels they can be more active and do more for music teachers by making this change. Dr. Taylor commented that a partnership between SMTE and KMEA is natural, and both sides would benefit. He thanked Marie for continuing to work to make KCOMTEP a great event the last few years.
- Festival Committee/Exhibits, Dana Hamant Dana brought to the board an idea of using the internet for adjudicator training. He described it as an idea that would take 2-3 years to put into place, but it would allow judges from long distances to have training without having to drive so far. The judges, who participated in the online training, would receive preference in calling for judging. Dana believes this would be a valuable tool if the training were meaningful and thoroughly explained the new rubrics being used. Dana also brought forth the possibility of increasing the number of entries into large group festival sites by allowing three orchestras and bands and changing the entries at solo/ensemble festival by either adding entries or lumping together the solo/ensemble entry numbers to be entered at the director's discretion. Dana commented that this becomes logistically difficult for placing schools and booking judges who are already judging long days. He also reported that small school participation is remaining constant, though some participate at solo/ensemble festival instead of large group. Dana informed the board that an error was discovered in the rubric math in matching the table to the actual rubric, and it is being adjusted. He also reported that some of the wording in the large group and solo/ensemble sheets is being tweaked under the advice of the affiliate groups, and some cosmetic changes are being made to the sheets to make them clearer – particularly in the memory caption. Dana reported that after talking with exhibitors, he would like to propose changing the exhibition times at next year's ISW to Thursday from 4:00pm to 6:30pm, Friday from 9:00am to 5:00pm, and Saturday from 9:00am to Noon. President Craig commented that if the exhibits open at 4:00, they won't be exclusive until 4:30. Vice-

Since the June Board meeting, I have the following items to report.

- 1. In June, I attended the NAfME NEB National Assembly in Baltimore Maryland. In July I hosted the NAfME Southwestern Division Board Meeting in Wichita. Since I am a member of the National Executive Board, my expenses for MENC meetings are covered by MENC and not KMEA.
- 2. The fiscal year ended on June 30. The books for the fiscal year 2011-2012 have been reviewed by our CPA, and found to have been completed with appropriate accounting procedures. I anticipate that we will finish the year with more expenditures than income due to the KMR costs and increasing costs during the ISW. A complete financial report for fiscal 2011-2012 will be given during this Board meeting. I will request approval of that report.
- 3. Our investments have grown slightly this year. The KMEA Fund is volatile, but it continues to increase annually in value. For the first time, we used income from the Fund to pay for three KMEA student scholarships. We are keeping an eye on the replacement organization for the Kansas Arts Commission to see how we can qualify for these opportunities. I have not made any deposits into our investments from the KMEA general fund this year.
- 3. The fiscal year review includes a review of the books from the six Districts. The Executives can present a review of their books to the District Boards. Our report to the IRS includes all State and District funds under one umbrella and one EIN not-for-profit number. This past December, I completed 1099s for the State and for the Districts. W9s are being completed for all State and District salaried and fee transactions (both income and expenses). We now hold two annual meetings with the District Executives one before the August KMEA Board meeting and one on Thursday evening of the ISW in February.
- 4. All facilities booking for the 2013 ISW is completed, including booking for the Garvey Center and the Metropolitan Baptist Church. In addition, a number of hotel rate contracts have also been negotiated and signed. We plan to continue using buses to transport students from the Metropolitan Church and to transport convention attendees to Old Town during the lunch hour. Costs continue to rise for use of the facilities and all the other services to the ISW. I am asking the Board to increase the registration fee for the ISW by \$5 for KMEA members (no increase in student or retired registration fees). In addition, several years ago we added \$10 to the All-State student fees to pay for a box lunch served on Friday of the ISW. At the time, I mentioned that, when the cost of the box lunch passed the \$10 mark, I would return to request an increase. The lunches were just over \$10 for the 2012 ISW. I am asking that either 1) The Board approve a \$5 increase in the All-State fee to cover this cost or; 2) The Board cancel the plan to serve lunches to the All-State students on Friday of the ISW.
- 5. Contracting for guest artists and clinicians for the 2013 ISW is complete (some final paperwork is being secured). The Assistant Chairs have been contacting conductors and



clinicians for 2014 and 2015. All conductors for 2014 and all but the 56A Band conductor for 2015 have been selected. The files are in various states of process – some files are complete.

8. Our KMEA employees continue to do excellent work. Dana Hamant has done a great job in his first year as Exhibits Manager. The KMR team, including Cathy Hunt, Bob Lee, Troy Johnson, and Desiree Kelsch, has done remarkable work during the year as we have considered and then transitioned to an online magazine. Sara Stecklein has resigned as Recording Secretary because she has started a family, and I am thrilled to announce that Mary Rose Biltz has accepted the Recording Secretary position. As members of the KMEA Board, please take time to thank our employees for their service when the opportunity presents itself.



Middle Level Choir Manager

The new Middle Level Choir Manager (online audition system) is ready to host auditions for the 2012-13 school year. There are some additional tweaks still in progress on the Admin side, but the Teacher and Judge sections are operational. Teachers will record their auditions to mp3 format and upload them to the KMEA web server via a web interface. Judging will also be handled online via web interface. This new system eliminates KMEA's costs of having judges travel to a central site to rate the auditions. Also, judges will be able to listen to recordings at their own pace. They are not pressured to do all judging in one day. However, as a safeguard, the state chair is able to view the progress of each judge to ensure that judging is completed in time.

Teachers will...

- record their students' auditions to mp3 format files.
- register their students in our online database.
- upload the mp3 audition recordings to the database.

Judges will...

- login and listen to the auditions.
- score the auditions using the established rubric.
- be able to listen to each entry as many times as needed.
- identify disqualifying factors found in the recordings.

Judges will not...

- know who they are listening to.
- have access to any identifying information for each entry.

The KMEA All-State Middle Level Choir Chair will...

- login and verify completion of judging.
- validate disqualifying factors as identified by judges.
- be responsible for taking questions regarding policy of the ML Choir
- generate the final roster for publication.
- notify teachers of selected students.

The KMEA Ensembles Manager will...

• receive audition and participation fees.

The KMEA Webmaster will...

- monitor data processes during the registration and judging timeline.
- be responsible for taking questions about using the ML Choir Registration site.
- post the final roster online when it has been released.



Kansas Music Review

A new version of the online KMR is currently under development. We are using the Joomla Content Management System as the platform for the new site. I hope to have some screenshots ready for viewing at the board meeting.

Clinics Proposal Manager

As of this writing we have received 34 proposals for the 2013 ISW, up from 18 in June.

Get Acceptd (online audition service)

On July 24 I spent an hour on the phone with the executive team from Acceptd. The discussion centered on how KMEA handles online registration and auditions. They also gave me a real-time web demo of their current set-up so I could see how their system works. It is fairly straight-forward in concept, but it is geared towards a direct connection between the student and the institution. KMEA puts responsibility for registration/auditions on teachers, not students. Due to that difference in concept, I do not recommend using Acceptd's service for KMEA at this time. Based on our discussion, they might pursue some programming changes so they would be able to accommodate how state MEAs operate. We can revisit this subject at a later time should that happen. I think they are wanting into the MEA market very badly since there is very little competition in that niche right now.

Music Education Week @ Baltimore

Last, and mostly definitely not least, I'd like to thank the KMEA board for the opportunity to attend NAfME's Music Education Week in Baltimore in June. I think I brought back more than I contributed, as that was my first experience at the national level, but it was not from lack of effort. My half-hour presentation to the state editor's group was titled "Why Your MEA Journal Should be Web-based." I reviewed our experiences with the online KMR over this past year and showed some of the features that we have built, such as the Article Index for researchers. It was clearly a timely topic, and I believe it is safe to say that Kansas is leading the way.

Website Policy Revision Proposal

Attached to my report is a proposal for revising the KMEA Website Policy, which was last revised at the June 2006 board meeting.

KMEA Website Policy - Revision Proposal

Original Policy - August 2002 Revision 1 - June 2006 Revision 2 - August 2012

Change Summary

Language updates

Back in the day, it was considered proper for websites to be called "Web sites." This term has evolved over time to the point that "website" is probably more commonly used than the original form. This change is reflected throughout this revision.

Compatibility & Service

This change reflects current web browsers and versions. Noticeably absent is Apple Safari, but that's only because I do not own any Mac devices. Given the ubiquity of the Apple iPad and other tablet models, one might argue that I should be testing new web features on that platform. I am currently unequipped to do so.

Mobile Devices

This section is new in its entirety. Web/tech delivery platforms have evolved greatly in the past six years since this policy was last revised. I currently test features using Safari on an iPodTouch and Google Android's browser on a smartphone.

Privacy

Consolidation of language to allow greater flexibility in what is posted. We don't post exactly the same data fields for all officers. Case in point: we do not post personal info for the Collegiate President. We always use the mailing address of the music department at their college/university. Also, some officers have specific requests for which phone numbers are posted. So this change simplifies the policy to cover all cases.

Visitor Tracking

Also a new section. This specifies that we do not share usage data with outside entities. This is important in that it indicates that we do not sell that data.

Districts

This is re-written here given that there is currently only one district webmaster who is not me. Also the previous language needlessly referred to the webmaster(s) when the policy itself is about the websites.

Links

Previously this policy stated, without exception, that we would not link to commercial or university sites. Given that we are serving ads online (KMR) as well as trying to promote increased participation for ISW Exhibits, this revision narrows the policy to apply only to our main website and its versions (ie, mobile), but still gives us flexibility without violating policy. This represents a recommendation that we change from past practice in order to link to exhibitors on the main website and its versions, so please be aware of this distinction.

As a general rule, interactive web forms will not be included on the mobile website.

SOFTWARE

The Webmaster will hold and maintain all KMEA-owned software licenses, **service accounts**, and media which will be registered and licensed in the name of the Association.

PRIVACY

KMEA leaders will have their name, mailing address, home phone, work phone, fax number (if available), and email address appropriate contact information posted in appropriate locations. Any of the above, with the exception of the email address, may be removed upon request. KMEA intends to respect and protect the privacy of members and students while allowing members to freely share information. Student privacy will be protected; the only information permitted online will be their full name and the school they attend. Only students involved in KMEA-affiliated programs will be listed. If KMEA is contacted by a parent or guardian, their student's name will be removed from the website.

LINKS

KMEA does not necessarily endorse Web sites websites that link to KMEA. KMEA will not be held liable for the content of any site from which its site is linked. KMEA is not responsible for any links on any Web site website which is linked from KMEA. The following criteria must be met in order for a Web site website to be linked from KMEA.
