The commissioner of education will be there, discussing accreditation changes that are occurring. They are also bringing in Kim Leavitt from the Tennessee Arts Commission to assist in developing a policy for arts education in Kansas. The conference will have break-out sessions in theatre, are, dance, and music. Ms. Warady invited the KMEA Board to attend and asked them to promote the conference to educators, parents, and administrators. She mentioned that Vice President Mike Quilling is also a member of the KAAE board, serving as advocacy chair, and the research and data KMEA has been able to provide KAAE is invaluable. The Kansas State Board of Education has just passed a resolution recognizing KAAE, and they have been very supportive. Ms. Warady also announced that individuals may join KAAE for \$25 and businesses, schools, and organizations may join for \$50. They will be taking nominations for their 2013 board and having elections. Ms. Warady said she looks forward to the partnership between KAAE and KMEA and also working with Kansas Citizens for the Arts. She emphasized the strength in having an organization that promotes the arts as one. As KAAE is developing, Ms. Warady expressed that she is open to ideas and suggestions. President Craig thanked her for her presentation and also stated that board should discuss the possibility of KMEA joining KAAE as a business. Vice President Mike asked if attending the conference could go toward professional development points or college credit, and Ms. Warady said they will be able to offer PD points but they do not yet meet continuing education requirements.</li> </ul>
	2) Lori Supinie, Kansas Music Merchants Association (KMMA) Lori Supinie described the 3 issues that the KMEA Executive Board asked KMMA to discuss in their meeting. The first was that KMEA wanted to offer KMMA a breakfast at the ISW on Friday morning, now that the hours for exhibits have been adjusted. KMEA also proposed the idea of having showcase clinics sponsored by members of KMMA at the ISW, but in talking with the membership, Lori explained that they would rather do a KMMA sponsored clinic session focusing on advocacy with tips for success and teacher retention put on by Marcia Neel. Dr. Taylor remarked that we have a wonderful MMA in Kansas – that they would rather provide a clinic for the membership than sell their services or products. He clarified that in order to be a member of KMMA, the requirements are that the group have a physical location and address in Kansas. It was originally formed for retail or school music dealers but it was

Vice President Mike also stated that having the breakfast at KMEA ISW would allow KMMA members to meet with special guests at the ISW. Dr. Taylor reiterated that KMEA and KMMA need one another and having a relationship makes both stronger. Robert Lee asked if there was anything the KMR could do to help KMMA. Dr. Taylor brought forth the idea of having a reduced price to advertise in the ISW programs if organizations had also advertised in all 4 issues of the KMR that year. He also mentioned that the KMMA members listed in the KMR needs to be updated so that all 9 of the current members are listed. Bill Thomas asked that the executive board keep the affiliates informed as to the evolving relationship between KMMA and KMEA because the affiliates also wish to show support to KMMA. President Craig said he was excited to give exhibitors at the ISW, some of which are KMMA members, more time on Thursday with the opening of the exhibits at 4 instead of 4:30, and he thanked Dana Hamant for his vision on that.
	3) Holly Taylor, KMEA Elementary Chair Holly thanked KMEA for allowing her to speak today. She reminded the board that when MENC (now NAfME) was doing a national elementary conference, the board would send the elementary chair there 1 of the years of his or her term. She greatly appreciated KMEA sending her to the Kodaly conference last year. She said there were eight teachers from the Wichita area there, and it was a great time of collaboration. She mentioned that some of her personal highlights were the sessions by Henry Leck on artistry and Dalcroze. She was able to bring that right back to her classroom. Holly also noted the high-level performances she heard at the conference, where children were performing very difficult literature very well because of the expert teachers working with them. She mentioned that at a time when literacy is being pushed so hard, Kodaly's approach to teaching music supports that literacy push because its focus is music literacy. She also stated how valuable it was that she could get handouts from every session, even the ones she could not attend at the conference. She thanked the board for allowing her to go to the conference and hopes they will continue to sponsor elementary chairs in their attendance there.
	4) Bryan Kirk, KMEA Historian President Craig reminded the board that Bryan Kirk came onto the board just a few months ago and he has already done some amazing work. Bryan Kirk reported that he has been going through the massive amount of artifacts in the KMEA Historical

He stated that he has found about 80% of the Hall of Fame Records, some with cassette tape interviews and hand written letters of recommendations by staples in the music education profession. Bryan mentioned that he has also discovered 22 books ranging in publication dates from 1837 to 1981. Additionally, he found several pamphlets and the first ever standardized music test in the state of Kansas. He also has several dissertations on the history of music in various parts of Kansas. Bryan distributed and described the first draft of his KMEA timeline. He explained that he plans to try to get at least two sources for each entry to verify its accuracy. He plans to have it completed by ISW 2014 and would like to have it displayed alongside the KMEA Hall of Fame and available online for the purpose of research. Bryan also noted that he is in communication with Lori Supinie about making Senseney Music the permanent home of the Hall of Fame. It is ideal because of its high traffic of teachers, students, and parents. Bryan expressed how valuable it would be to have the help of some of the retired members in verifying facts and labeling unmarked photographs. Vice President Mike suggested that Bryan might be able to give a clinic to the retired members at the ISW. Finally, Bryan mentioned he hopes to have inventoried the entire contents of the KMEA Historical Center by ISW 2013. President Craig thanked Bryan for his work again and remarked that he was definitely the right person for this job.

2) Dr. Tim Lautzenheiser President Craig remarked that he always looks forward to hearing Dr. Tim, and he is especially excited for the young people to hear him for the first time. He noted it is always good to have Dr. Tim back to Kansas.
3) Possible Guest Speaker: Senator Jerry Moran
<ul> <li>a. NAfME MIOSM National Advocacy Award- KMEA President Craig took the opportunity to share with the board why he especially would like Jerry Moran to be able to attend the ISW this year. While the Kansas delegation was at the National Assembly, KMEA was awarded and presented with a plaque and the flag that flew over the capital building during "Music in Our Schools" month. He explained that KMEA won it for the work done with advocacy that stemmed from Fred Burrack's and Phillip Payne's work and the doors it opened at the KSDE and in the legislature. President Craig explained that he would like Jerry Moran at the opening ceremony of the ISW when the award will be displayed. Dr. Taylor gave a special thanks to Vice President Mike Quilling for filling out the application to make sure KMEA was in the running for this award. Now, NAfME is using Kansas as a model for collecting of advocacy data across the country. Mike also commented that Kansans are getting attention from the Associated Press, who picked up stories on teacher cuts this year. That attention is good for the cause. Introductions and Announcements (continued)	Presidents, affiliates, and the All-State Chairs will all have to be involved in the process and must keep all data from the auditions and send it to the KMEA President. President Craig remarked about how lucky Kansas is that the MEA has a great working relationship with all the affiliates. Dr. Taylor commented that KMEA will need the actual data from the auditions – not just names of quartets. He further explained that some students from each state will be invited to participate in the ensemble, and others will be able to register and audition for the remaining spots. Teachers should note that they are to register their students and they must be a NAfME member to do so. Dr. Taylor recommended that the District Presidents give an informational handout to teachers during the talking points of their next district meeting. President Craig asked that all the All-State musicians be sent to Avian, and then she will remove the graduating seniors from the list. Dr. Taylor commented that each of the 6 districts has a unique way of selecting their choirs, so they will have to determine how to rank them as a state. President Craig said that NAfME does not yet know how the seating order will be determined for the instrumental esembles, nor what the total number in each group will be. Dr. Taylor could provide the minimum number of slots that Kansas is guaranteed the ensemble: a total of 15 (4 in band, 3 in orchestra, 8 in choir, and up to 1 in the jazz band). He also commented that Kansas has been averaging 4 students per year the last couple of years, and he hopes we can more than fill the 15 slots Kansas is guaranteed.

Cathy commented on the general change in perspective about going to online journals in Baltimore. She noted that Kansas is ahead of many other states by going through this conversion process from print to online right not. She observed that many online journals still very much have the format of a print journal that you "flip through" online. The KMR is taking on a very different look and is very interactive even now in its early stages. IV. c – Administrative Personnel/ Advisory Board (continued) that will take users through the KMR online to teach them to navigate through the online journal. NAfME Collegiate President, Kelsey, asked if the KMR had ever considered taking on a college intern, and Cathy responded that she would be very open to this and that it would be great for a young person to watch this transition of print to online occur. Troy walked the board through some of the changes to the online journal. He showed them some changes in the basic elements of logos, issue selection, navigation, content, advertising, color gradient, and graphic expansion. He also showed how the changes made room for a search box that is already fully functional and operates only within the KMR. Troy explained that one of the benefits of the current format of the KMR is that it does not require downloading massive files and reloading when a person wants to change pages. There is also the potential for imbedding video or audio content via YouTube or mp3 files. Cathy also commented that several articles have works cited pages and if there are domains listed, those links will be live so that readers can click on them and go to the website. Advertisers also can have live links if they provide the KMR staff with a URL. Cathy reminded the board that the KMR will be available online to anyone and will not require a username or password. President Craig expressed his excitement about the limitless of the online KMR. He indicated how great it is to think beyond the 60 pages and to have a truly interactive journal.

Advertising, Robert Lee – Robert reminded the District Presidents that there are not sidebars anymore, so he does not need them to send information. He reported that all accounts are paid except one, and it has been cyclical for several years. He anticipates being able to pay that final account in September. Robert stated that he was happy with advertising for the year He has been in communication with advertisers about the new forms in which he needs advertisements (JPEG, PNG, not PDF) Dr. Taylor commented that he had anticipated going into the red considerably this year due to the double issues of the KMR in both print and online versions. However, because of Robert's hard work, KMEA was only about 66% of the anticipated number in the red.

Troy thanked the board for sending him to Baltimore this summer, and mentioned that in the 5 hours that the state editors met, Kansas had the floor for about an hour and 15 minutes. Troy reminded the board about registration deadlines in October. He explained that last year there were 19 forms all due the same day, but he hopes the districts will allow him to spread those deadlines out over 2 weeks so he has time to process them. ## Executive Director John W. Taylor

I am pleased to report the following activity.

- 1. The arrangements for the ISW have been completed. Venues have been booked, scheduled and paid. Contracts for various artists and arrangements have been signed. Arrangements for performing groups and student musicians have been finalized. All food service arrangements have been made. The KMEA employees have completed preparations for their work during the ISW.
- 2. All all-state ensembles are in the same locations as last year. This is the first time in several years that I can report this fact.
- 3. Several successful transportation services from last year are again available. A bus will run from 11 AM to 2 PM on Friday, Feb. 22, between Century II Convention Center and Old Town so that registrants can go there for lunch without moving their cars. A school bus service will operate on Friday morning and noon times to transport 56A Band students from the Hyatt and the Broadview to the MBC. Both bus services are free.
- 4. I continue to monitor the KMEA finances. The 2011-12 year was very tight with two version of the *KMR* and increased costs for the ISW. Some fees that were increased by the KMEA Board this past summer should help in 2012-13. The KMEA Fund continues to grow at a slow pace. The funding from the Kansas Commerce Department will likely not be available to KMEA. Because of additional spending, increased prices, and limited grant funding, we will probably not add any funds to our investments or the KMEA Fund this fiscal year.
- 5. Our *KMR* staff has done stellar work to create a very successful and high-quality online journal. We continue to receive comments and requests for information from other state MEAs about our process.
- 6. We continue to have a positive relationship with WichitaTix, who handles the sales of our all-state concert tickets. They also provide an ushering service which is invaluable to the success of these concerts. They continue to tweak their processes.
- 7. The organization of the KMEA District Executive Directors continues to function. We have set a regular schedule of meetings. The 2011-12 fiscal year review of the KMEA books at both the state and the District levels was completed. All District Executives now function under the KMEA not-for-profit status, and District Executives have year-end financial reports to share with their Boards. We have aligned much of the paperwork that is common among the state and the Districts, and all Districts are now reporting as required by law to the IRS. The KMEA accountant, Lindsay Williams, has helped guide us through this transition. I mailed all 1099s and W2s for the state and the districts in January. All year-end taxes were completed and filed.
- 8. I will finish my term as President of the Southwestern Division of NAfME in June. The only regret that I have is that this work has drawn me away from some representation of KMEA. Thank you for your patience as I complete my term on the National Executive Board of NAfME.



9. We have the most wonderful employees working on behalf of KMEA. Dr. Catherine Hunt has done a remarkable job leading the *KMR* staff. Troy Johnson has taken on additional work to get the online *KMR* in place, and Bob Lee has been working hard to continue a relationship with advertisers on the online *KMR*. Dana Hamant has worked hard as Exhibits Chair, and the Exhibits Hall is sold out. Michelle Postier and Amber Ives continue to efficiently handle the myriad of nightmares for ISW registration. We welcome Mary Rose Biltz, former Kansas NAfME Collegiate President, as our new Recording Secretary, as Sara High has left this position to raise her young family. Please take a moment to thank the KMEA employees when you have a chance. They are paid a minimal amount for their work, and they provide excellent service to our organization. I live in constant fear that they will grow weary and leave their posts!

#### Site Stats (Feb. 1, 2012 - Jan. 31, 2013)

31,682 unique visitors, 85,094 visits, 265,792 page views. Compared to the same time-frame from one year earlier, we had fewer visits and page views during this past year. This could suggest a plateau had been reached after multiple years of increases. Our visitors came from all 50 states and 100 countries/territories around the world, 12 more than last year. These stats only indicate traffic to our public informational pages. Visitor traffic to web applications, such as the All-State Manager, is not included in these numbers.

#### Kansas Music Review

The *Kansas Music Review* went online on August 30, 2011 (kmr.ksmea.org). We now have seven issues available online with the issues for 2012-2013 school year being online only. Using the same time-frame as above, here are the site stats for the *KMR* over the past 12 months, with stats from the previous year shown in parentheses: Visits: 4,134 (1,154); Unique visitors: 2,753 (714); Page views: 17,305 (5,498). Of these, 523 visitors (13%) used a mobile device to attempt to access the *KMR*. However, the *KMR* does not yet have a mobile-optimized version. Those who used a larger device, such as an iPad would probably have no problem viewing the site, with the possible exception of Flash-based content. Other hand-held devices would have a difficult time navigating the regular format.

#### Twitter

Our Twitter handle (@ksmea) reached 380 followers when ILA results were posted. We are currently at 370. Anyone may receive our Twitter feed on a text-enabled phone without having a Twitter account simply by texting **follow @ksmea** to 40404.



## Middle Level Choir Manager

The new Middle Level Choir Manager (online audition system) hosted auditions for the first time during the 2012-13 school year. Teachers recorded their auditions to mp3 format and uploaded them to the KMEA web server via a web interface. Judging was also handled online via the web. This new system eliminated KMEA's costs of having judges travel to a central site to listen and score auditions. Judges were able to listen to recordings at their own pace from the comfort of their homes. Also, they were not pressured to do all judging in one day. With this system they had approximately two weeks. For the inaugural running of this system there were a few issues, but each problem or help request was resolved quickly, usually same day. By the end of the registration deadline, 137 teachers had entered 845 students, for whom 805 mp3 auditions were uploaded.

#### Hosting account info

There are no concerns regarding disk space usage on the web server. Even with the ML Choir mp3 files still parked on the server right now, we are currently using only 6% of our disk space quota, and monthly bandwidth transfer is less than 1% of our allotment.

#### What's next?

This has been the most interesting year, given the challenges of continuing the development of the online *Kansas Music Review* and creating the new Middle Level Choir online audition system. The code base for the *KMR* was started two years ago, so the ML Choir Manager was last summer's major project. The next "big thing" that has been on hold since last fall is the KMEA Rolodex (www.ksmea.org/rolodex), which will facilitate communication throughout the state in granular fashion (content area, grade levels, KMEA districts, etc). I look forward to the upcoming off-season so more time can be spent working on it.

## Advocacy Frederick Burrack & Phillip Payne

Results from the survey to identify the impact of budget cuts on school music programs across Kansas were presented at the annual KMEA In-Service Workshop in February. These data were organized into a brochure that was share with each legislator during the Arts-At-The-Capitol day in March. Indicated from the 69% of responding school districts, 224 music teacher positions were lost between academic year 2011 and fall 2012. Adding to the 220 positions accumulatively lost over the three years prior, 444 music teaching positions no longer exist in Kansas' schools (over 500 if inferred across the entire population). Even with this loss of positions, 98% of the school districts report over twenty percent of their student population participates in music programs. Of these programs, 47% lost an additional portion of their funding during the past year and 20% added fees for participation. An article was published in Teacher Music featuring this research encouraging more states to join in their own research on the current state of music education across the country. It was replicated in Nebraska and Missouri and currently in Iowa, Indiana, New York, and Florida.

Data from the 2012 survey will be presented at the KMEA In-Service Workshop on Friday, February 22, 8:30 am 206 Oak.

In June, more than 100 leaders of the National Association for Music Education (NAfME) spent a day on Capitol Hill meeting with Members of Congress and their staff members. It was the largest group ever for the annual visits. Chris Woodside, NAfME assistant executive director for advocacy and public affairs, told the leaders, "We are standing at the brink of a very important moment for our cause. As music education advocates, you have all taken tremendous steps in your movement to protect the profession of music education, which you hold dear, to ensure the next generation of students has access to certified music education in America's schools."

Phillip Payne was added at co-chair for the advocacy committee to assist in furthering the scope of impact of the advocacy committee. A meeting of all state advocacy chairs will occur at the KMEA In-Service Workshop on Friday, February 22 in Room 102 at 2:45-3:35pm.

# Composition Competition Darren Jenkins

This year there were two entries for the composition competition. One entry was from a high school composer and the other was from a middle school composer. One middle school and high school were represented. Both of the student composers did not submit entries last year.

Entry names and titles are as follows:

**Scott Hershberger**, *On a Sunny Day* **Grace Baugher**, *Vita Solis* 

This year's adjudicators were Chris Bernotas, Brant Karrick, and Todd Stalter, all prominent music educators and featured composers with Alfred Publications. Each adjudicator rated each composition and wrote constructive comments. Each composer received his or her respective comments from these adjudicators.

The following composition was selected as the winning entry; Scott Hershberger's *On a Sunny Day*. The last time I contacted our KMEA President, I believe that there will be a performance of Scott Hershberger's composition at KMEA. Scott will also be awarded an official certificate and recognized at the Convention in February 2013 (either during the performance or at a separate event designated by the President).

Continuing to enhance submitted entries at the younger grade levels (especially elementary and middle level) is still a goal for future composition competitions. Fostering a greater awareness of this program through the various resources available will help achieve this goal.

The number of entries this year was down from the previous year. I'm not sure whether this was just an outlier year and entries will return closer to the number of the previous years in the future, but continuing to increase awareness of this program to our music educators in Kansas is still a continued goal.

In previous years, a recommendation from the adjudicators was to look at the possibility of rewording some of the tiers of the judging rubric, specifically the use of the words "Poor" and "Ineffective" for category headings. In my conversations with them, they felt since there are only two divisions currently (K-12 and Collegiate) that it was difficult to judge high school and middle school composers with the same scoring system and word usage. Since the purpose is to also encourage young composers, they felt those word choices might be too discouraging and that there could be an alternative wording to communicating the same criteria in that category. I did not take that into consideration with this year's contest rubric, but will look toward recommending this to our new composition contest chairperson, Dr. Jeff Jordan.

All three adjudicator's this year indicated how much he enjoyed and appreciated the opportunity to be a part of this program. I believe that it speaks to how important this program is for our students and the impact it can have on the young composers in our state.



I wanted to take this last opportunity to thank KMEA for allowing me the chance to be the chairperson for the past few years. I know that it is very capable hands with Dr. Jeff Jordan, and I'm sure it will continue to grow and be very successful.

#### Festival Committee Dana Hamant

The last meeting of the festival committee was June 2012. We will soon start looking at the feasibility of beginning adjudicator training with the help of KMEA. When the process begins we hope to borrow as many ideas as possible from any state that already has training in place. Below is a synopsis of additional topics covered at the last meeting.

#### 1. Some large group festivals were becoming exceptionally long

Through relocation of some schools and some creative scheduling this issue is being addressed. It will take a year or two to see if these approaches will at least to some degree, alleviate the problem.

# 2. Scheduling 2<sup>nd</sup> bands into the orchestra room every year

The committee recommends that Reg talk to the festival manager about rotating bands between the band room and the orchestra room every other year. This has worked fine in Wichita.

#### 3. Feedback from directors about the adjudicators and host sites

We will see if more directors are fulfilling their obligation and completing the form on the website to help keep the festivals at a high level

# **4.** Shortage of adjudicators Everyone help KSHSAA by contacting prospects and relaying that information to KSHSAA

#### **5. Expanding large group festivals to allow three bands and three orchestras** This of course is only an issue in the NE. Each site will have to be looked at to see if it is

possible. This does add logistical problems for host schools and could cause the festival day to lengthen too much.

6. **The rules regarding orchestra literature selection have been clarified.** An orchestra may perform one full orchestra piece and one string piece. No problems have been observed.

#### 7. Is there room to add a few vocal and string entries at solo/ensemble festival?

This issue is mostly centered in NE Kansas. KSHSAA has allowed vocal program to combine their total ensemble and solo entries into one number to use how they choose. This will help virtually every program that is bumping up against the allowable numbers. This was done several years ago to help string programs. Festival sites will be monitored to see if it is feasible to add any more entries to the sites. It is both a logistics issue if more rooms are needed and an adjudicator issue if more judges are needed.

#### 8. Attendance at festivals

The committee wanted to know if attendance (particularly at large group) was holding steady or declining. The members from the more rural areas say it changes from year to year. We believe part of that is smaller programs electing to have their groups participate some years in the ensemble festivals as opposed to attending large group festival.



- 9. We corrected point totals on the rubric to make the point columns and ratings table match. The state string solo and vocal solo sheets have been improved by making the memory caption and the scoring within that caption clearer and typos on the percussion sheet have been corrected.
- 10. The committee decided to entertain suggestions from the affiliate groups on tweaking wording or possibly point distribution to the forms. It does appear that virtually everyone is happy with the rubric format.

**Teacher Licensure: Status Report to the State Board of Education** 

#### Introduction



The State Board of Education approved the formation of the Teaching in Kansas Commission II (TIKC II) during their June 2012 meeting. The Commission was formed to address the requirement of Principle 3 of the Elementary and Secondary Education Act (ESEA) Flexibility waiver. Principle 3 required the State Education Agency (SEA) to develop and adopt guidelines for teacher and principal evaluation systems which include student growth as a significant factor. Meeting the first part of the Principle 3 of "developing and adopting guidelines for teacher and principal evaluation" has been well underway with the Kansas Educator Evaluation Protocol (KEEP). The Kansas State Department of Education (KSDE) began the process of developing a statewide model evaluation system in 2010 with the assistance of Educational Testing Services (ETS). KEEP was piloted in 16 districts in the 2011-2012 school year. Pilot 2 began in August 2012 with a total of 23 districts.

The second part of Principle 3 required the evaluation system to include student growth as a significant factor. This has been the focus of the TIKC II. Multiple valid measures have been discussed including achievement on state assessments, observations, peer observations, professional growth, self-reflection, student voice, parent voice and others.

The Commission consists of educators from Pilots 1 and 2, board member appointees, representatives from educational organizations and representatives from higher education. The total number of members on the Commission was limited to no more than 30 to allow for rich dialogue. Membership was carefully selected to represent all constituencies. Members were encouraged to communicate to their respective groups as to the progress of the work of the Commission.

Final recommendation will be given to the State Board of Education in late spring/early summer of 2013.

**Members** include superintendents, principals, classroom teachers including the fine arts, physical education, special education, retired, and teacher unions. A list of all members can be found at <u>http://www.ksde.org/Default.aspx?tabid=5211</u>



#### The Work of the Commission

The Teaching in Kansas Commission II was created to address the requirements of the ESEA Flexibility Waiver as outlined in Principle 3. Kansas received a waiver from the U.S. Department of Education, in part, by proposing to include student performance measures in the professional educator evaluation system. The Commission's deliverables will be reports to the Kansas State School Board and a waiver response to the Department of Education regarding the recommendations of the Commission by June 2013.

The Commission members were invited to participate in August 2012. The TIKC II met three times in full-day, face-to-face work sessions and individual and task group work assignments occurred between sessions. The meeting dates were September 14, October 19 and December 7. The work sessions were facilitated by Susan Toft Everson, an associate professor at Saint Louis University, who is familiar with the Kansas educational system. Dr. Everson was a senior director at McREL from 1978 to 1998, at which time she worked on numerous projects with Kansas educators. From the beginning of this initiative, Dr. Everson has worked with a planning team to review the Commission's progress, make adjustments as needed, and plan for each of the three sessions. ## **Next Generation Core Arts Standards**

#### Background

The National Coalition for Core Arts Standards (NCCAS) is preparing to begin the review of drafts of the national standards in the arts. National standards are being developed in dance, drama, music, visual arts and media arts. State level teams of internal reviewers are being developed to provide state level and individual input into the standards writing process.

## **Review Team Criteria:**

Review team members have been selected by their State Department of Education Director of Arts Education to best represent the diversity of arts education and arts learning in their state.

## Individual Review Team Member Responsibilities:

Each member of the review team agrees to perform the following duties:

- 1. Sign a confidentiality agreement. These will be kept on file at KSDE. Review team members will be seeing drafts and later revisions of the standards that are not public or published. Confidentiality is needed to preserve the process.
- 2. Take part in a professional development webex and/or podcast to familiarize themselves with the Conceptual Framework and organizing Framework Matrix for the national arts standards.
- 3. Current timeline:
  - a. Review of early draft standards in March, 2013
  - b. Released draft of standards for public review in June, 2013
  - c. Review of publicly released draft standards in June, 2013
  - d. Review of final revisions of draft standards in October, 2013
  - e. Completed Standards documents available in December 2013
- 4. Reviewer comments will be captured via an on-line survey tool.
  - a. Review teams may be asked to meet virtually (via Webex or other platform) to share their review findings.
- 5. The state will aggregate review findings from the on-line survey tool as well as any meetings held with the Review Team.

# Revision of Kansas Curricular Standards for Music are still scheduled to begin during the summer of 2013.

#### KSHSAA Consultant Reggie Romine

KSHSAA continues to sponsor 5 Piano Regional contests with State at Tabor College in Hillsboro. We had 389 students participate which is up 13 students from last year and up 21 from two years ago.



59

We also sponsor 18 Solo and Small Ensemble Regional Festivals, 15 State Large Group Festivals and 6 Solo and Small Ensemble State Festivals in April. The above contests require a total of 290 adjudicators. This is the seventh full year that we are completely web based concerning music adjudication updates and assignments. Priority is given to those adjudicators who update their files in August. <u>As you hear of excellent teachers who retire please encourage</u> them to contact me and apply to become an adjudicator for our state. Adjudicator fees were raised to \$180 per day. This is a 9% increase.

We continue to have a shortage of <u>Choral and Orchestra adjudicators</u>. In the band area, woodwind adjudicator assignments are the toughest to fill as we have a greater number of student entries in this area. We are finding that when teachers retire they are less likely to put their name in our judging pool than in the past.

Developing **adjudicator training and certification** is the next immediate goal of KSHSAA. We have begun to work with KMEA to combine efforts and address this important need. We are researching other states and working with NFHS to encourage development of an online option for this training.

Spring 2013 is the <u>fourth year</u> all regional and state music entries will be done online through a program called "Festival Manager". This program has tremendously reduced the work load of hosting a KSHSAA music festival. Most directors have been very pleased with how this new system works. One challenge is communicating with new directors or directors that have changed schools registered. In an attempt to address this challenge, the 2012-13 music manual had registration instructions printed on page 4. We have 7 new festival site managers this year. I will travel to their site and provide on-hands training regarding this online program.

This year for the first time KSHSAA is hosting a Manager Only workshop at the KMEA inservice to help brainstorm and support our current directors who step up and host our various music festivals.

In Spring 2013, this will be our second year to use the "new" solo & small ensemble rating sheets. We have published these on your KSHSAA music web page so all directors and adjudicators may download these forms. We have cleaned up a few inaccuracies with total points regarding tabulations.

In 2006 KMEA requested that we record and track all ratings given at festivals in order to monitor trends over the coming years. In 2007 we began using Large Group Rubric ballots. In 2012 we began using Solo & Ensemble Rubric ballots. We are working hard to shift this mentality from "the rating means everything" to "the educational critique and learning experience is the #1 outcome from a quality contest".

This year we combined the solos and ensembles maximum entry number as a total in winds & percussion and in vocal like we did a few years ago for strings. This hopefully will allow greater flexibility for directors to maximize their entries without being limited to so many solos and so many ensembles.

Last year the NFHS and NIAAA teamed up and made 3 professional public audio announcements which were distributed to every radio station in Kansas. They promoted the value of high school athletic and academic standards. These received a lot of play time and were highly received by our schools across all regions of Kansas. This year they have produced 4 new PA's and I am happy to say one is an "activities-fine arts" announcement. These can be uploaded via our web page under "media" and used by any school.

KSHSAA is pleased to announce that Jean Ney, Kansas City Kansas Public Schools, has been selected as the 2012-13 NFHS Kansas "Outstanding Music Educator Award" recipient. Also, Dana Hamant, Wichita Public Schools, was named the 2013 recipient of the prestigious NFHS Outstanding Music Educator "Citation" Award. He will represent 50 states and the District of Columbia at this year's Denver NFHS National Conference where he will be honored and receive his award. He is only the 25<sup>th</sup> music educator to receive such recognition and the third Kansan.

The KMEA Mentor program does not want new music teachers to feel as though they cannot find answers to the many questions they may have their first year of teaching. We don't want new music teachers to rely on luck, nor do we want them to feel alienated and lost when they have to look outside of their school district for help. The Mentor Program continues to seek out ways to find new teachers (especially in rural areas of Kansas), and get them connected with a qualified mentor teacher. The addition of the six district mentor chairs (listed below) has had a major impact to locate new teachers now in its fifth year of operation. Networking and technology continue to enhance the mentor program. The website for KMEA has valuable information for both new teachers and mentors.

The Ninth Annual First year Teacher Luncheon is scheduled for Saturday, February 23<sup>rd</sup> at 11:30AM with the following speakers: KMEA President Craig Manteuffel and President-Elect Avian Bear, NAfME Executive Director Michael Butera, KSHSAA Consultant Reggie Romine, and representing the Kansas Music Merchants Association, Senseney Music President, Lori Supinie.

We are expecting a good group of new teachers this year, at the time of the publication deadline, we have 21 new teachers enrolled in the New Teacher Luncheon. Although, that means we have more teachers new to their positions in the state. All six districts in the state of Kansas have new music teachers joining their districts. Northwest has two, North Central has two and North East with six. In the Southern half of the state, South East has one, South Central has six and the South West district has four new teachers. We understand that there are more new teachers in these districts who have not enrolled in the luncheon. Therefore, we cannot reach them the same way these 21 will be reached. Once again, one can calculate that music still has a promising future in the state of Kansas. This year the new teachers coming into the state education books are split quite evenly as holding high school, middle school or elementary positions. Several are teaching the K-12 gamut though.

This session has been popular with new teachers in past years and CMENC students. Last year we had the largest group of the past 4 years attend this session.

A Mentor article appeared in each issue of the Kansas Music Review. The articles were titled: "You Have Almost Made It!" "Can We <u>TALK</u>?" and "Do Not Rely On Luck Alone!" Below is a list of the current district mentor chairs. Kelly and Holly are most appreciative of the ongoing worked that the six district mentor chairs do to promote the mentor program. We look forward to the program continuing to grow under their leadership and commitment. Some of the names will change upon the completion of this conference. We are very thankful to all who have given time and effort to make connections this year on behalf of the KMEA Mentor Program.

# Middle Level Lance Quilling

In August, KMEA leadership approached me asking to have more representation from the middle level disciplines in the state. My focus was to contact teachers from different parts of the state and have them put together a presentation for Band, Jazz, Choir and Orchestra in order to address issues specific to middle level groups. Here are some of the clinics that I wanted to highlight for the board:

Dan Wooge will share tips for improving a young band's intonation, instrument technique, percussion section and classroom management. He has a great track record for dealing with these issues and will present new ideas to improve percussion participation. His attention to the fundamentals and discipline will be beneficial for new and veteran teachers alike.

Todd Wilkinson has great ideas on incorporating jazz into the middle school band class. Most middle schools around the state do not have the opportunity to have a separate jazz class or are too intimidated to try jazz at the middle level. This session will enable the teacher to give the students a chance to learn new and exciting charts, while at the same time learning essential jazz techniques. His high energy, knowledge and passion for music will be both enjoyable and informative.

Amy Norris will present a clinic focused on dealing with an issue that many female directors face...the middle school boy syndrome! She will discuss and give tips on techniques, dealing with voice changes and general motivation strategies. Amy comes highly recommended and should give directors more ideas to add to "their bag of tricks".

My goal as the middle level chair is to increase the involvement of junior high instructors in KMEA I believe this can be accomplished by:

- 1. Increasing the number of middle level clinics at the ISW.
- 2. Providing opportunities for more middle level performances
- 3. Collaborate with KMEA leadership to find the amount of middle level teachers attending the ISW and discuss strategies to increase attendance at the workshop.

## Research Christopher Johnson

The Research Poster Session at the last in-service conference featured 23 projects. Attendance was estimated at 250 people. Poster submissions for this year look similar. The total number accepted for presentation will be available at the meeting. The General In-Service Workshop Session last year featured Amy Hanson, from The University of Kansas; Elaine Bernstorf and Steve Oare, from Wichita State University; and finally, Jeremy Manternach from the University of Kansas. This year's presenters features three presentations of recent research in music education and the psychology of music. As in all years, the research arm of KMEA seeks to identify and include research from the very best the state has to offer.

This year's presenters features three engaging presentations that I am sure will inform and engage. The first presentation features Teddi Ricketts, Nancy McKellar, Randall Ellsworth, and Elaine Bernstorf discussing Relationships Between Instrumental Music Participation and Academic Achievement in Low Socioeconomic Students. Their results showed a statistically significant relationship between sixth grade instrumental music participation and reading scores, as well as math scores, and also suggested that duration in a string instrumental music class may be important to increases in academic achievement on state assessments. The second presentation in this session will feature Sheri Cook-Cunningham who will discussing a project entitled: University Singers' Hearing Dose and Voice Use During a Choir Concert: A Case Study. The purpose of this case study was to document sound doses acquired by female university singers (N = 4), simultaneous voice use and sound doses acquired by 2 participants, and to solicit participants' perceptions of hearing and singing effort during a college choir concert. Finally, Frederick Burrack and Phil Payne will be discussing a pilot study identifying if there is a relationship between success in university Engineering programs and number of years involved in arts in secondary school (5-12 band, choir, orchestra, theater, visual art). These presentations represent the best research efforts of researchers in this state, and discuss topics that are pertinent to what is going on in society today.

The General Research Session scheduled for 12:55 to 1:45 pm on Friday morning. The Research Poster Session is scheduled for 3:00-3:55pm on Friday as well.

After a very successful Research Commission Seminar and set of research presentations at the World Conference of ISME in Thessaloniki Greece, I have rotated out of the position of Chair of the Research Commission for that organization. Also, after two terms (twelve years), I have passed the editorial torch of the *International Journal of Music Education: Research* to Dr. Ruth Brittin and Dr. Beatriz Ilari. In the past twelve years, this journal has grown from 9 submissions per year to over 70 per year, and is ranked as the premier research journal in music education in the world by Excellence in Research Australia Commission, which is the only entity in the world doing this work, and who's work has been adopted by more than 100 countries worldwide. I am looking forward to picking up the pace on my own work now, and having a life.

# Society for General Music Jana Fallin

Kansas continues to recognize the importance of general music opportunities for the school children of the state. Along with NAfME, we believe that all students in our schools deserve to have music instruction. We acknowledge that students can be highly engaged in music through many different venues.

Courses such as guitar, drumming and music technology are offered in many secondary schools in the state, as well as the traditional performing arts courses in choral and instrumental music. Some schools have opportunities for students to engage in recording and production opportunities through the music departments.

The elementary schools still include music in the curriculum, although the need for more collaboration between the music specialist and the classroom teachers would be very helpful in designing curriculum which includes music. In a survey conducted by faculty from the College of Education at Kansas State University, classroom teachers reported a desire to collaboratively plan with the music specialist, but the time is not allocated to support this collaboration. Most music classes occur during the planning time for the classroom teachers.

Exciting developments in the field of neuroeducation exist for music teachers today. An expanding body of evidence based on cognitive neuroscience provides music teachers with information regarding the interaction between music instruction and brain development. The pedagogy of this type of music teacher is grounded in research-based insights regarding how the brain learns and responds to experiences in the music classroom. This information can impact the importance and need for general music in the schools.

As I leave my position as Society for General Music chair at KMEA, I see the progress we have made, and I see the needs to lie before us. We have needs yet to be met.

- More colleges and universities need include general music offerings in the music education curriculum. We all know the issues of so many hours required for a music education degree. Where can one carve out more time in the methods courses? However this is important for the future of music education in Kansas and in the nation.
- Administrators in the schools need to provide time for music specialists and classroom teachers to plan together.
- We need to educate ourselves, our administrators and our students in the field of neuroeducation, which is informed by the study or neuroscience, psychology, and education. Concepts such as brain plasticity, activation of attention, mufti-sensory instruction, memory, and interdisciplinary collaboration affect us as music teachers.

Kudos to the music teachers who continue to educate our students and strive for excellence in teaching and learning.

#### **Festival Bands Chair Re-Audition Process**

Students will perform excerpts selected from the Festival band concert literature. The musical excepts will be posted at the re-audition rooms at the Thursday registration time.
 Students will have assigned audition times. All students from each musical part (i.e. 3rd Clarinets) will audition together. Only door monitors and festival chairs will have the student names. Auditions will be "blind" – judges will not see the student performing.
 Chair auditions will be scored using portions of the KSHSAA/KMEA wind instrument solo performance rubric. The 3 criteria used will be Technique, Rhythmic Accuracy, and Note Accuracy.

4. Each rubric descriptor will be equal to 1 pt. (Outstanding=5, Excellent=4, Average=3, Poor=2, Ineffective=1).

5. Each judge will award a maximum of 15 pts. (3 Criteria x 5 possible pts).

6. Five directors will judge in each room allowing a possible score of 45 points and we will drop the high and low scores if I can get enough volunteers to judge the re-auditions.



#### Scoring Scenarios

Any student scoring 36-45 pts will remain in the chair position from the Salina Instrumental Live auditions.

His compositions have been performed and recorded world-wide, including performances by the Tokyo Kosei Wind Orchestra (national tour), the Birmingham Symphonic Winds (UK) and the Klavier Wind Project's recordings with Eugene Migliaro Corporon. The University of Notre Dame world-premiered his "Siorai September" at Carnegie Hall in New York. Additionally, numerous titles of Mr. Hazo's works are included in the series "Teaching Music Through Performance in Band." He has served as composer-in-residence at Craig Kirchhoff's University of Minnesota Conducting Symposium and has also lectured on music and music education at universities and high schools internationally. In 2004, Mr. Hazo's compositions were listed in a published national survey of the "Top Twenty Compositions of All Time" for wind band. He is a member of ASCAP and recipient of multiple ASCAPlus Awards. Mr. Hazo has been a music teacher at every educational grade level from kindergarten through college, including tenure as a high school and university director. He has been asked to guest conduct over 50 university ensembles and, as of 2013, one third of the High School All-State bands in America. Mr. Hazo was twice named "Teacher of Distinction" by the Southwestern Pennsylvania Teachers' Excellence Foundation. He received his bachelor's and master's degrees from Duquesne University where he served on the Board of Governors and was awarded as Duquesne's Outstanding Graduate in Music Education. Mr. Hazo serves as a lecturer and clinician for Hal Leonard Corporation. He is also sponsored by Sibelius Music Software.

KMEA members from across the state served as judges and helpers at the event and the process went very smoothly. We were finished with the string portion of auditions before noon. A slight glitch in the Excel spreadsheets used in tallying scores resulted in the addition of five cellists a week later. This was an isolated issue and after thorough review, the tabulators are confident in future results.

Mark Russell Smith, Music Director of the Quad City Symphony Orchestra and Director of Orchestral Studies at the University of Minnesota, will conduct the 2013 All-State Orchestra. The literature selected is: "Tragic Overture" by Brahms and the fourth movement from Symphony No. 5 by Shostakovich.

Martha Barnhill, current assistant chair of the All-State Orchestra, has already booked conductors for the 2014 and 2015 orchestras: Daniel Long will conduct in 2014 and Steve Amundsen will conduct in 2015.

I am very proud of the work done by Kansas instrumental music educators and their students in preparation for the 2012 and 2013 All-State Orchestra performances. I am especially proud of the work done in preparing a new set of rotating string audition excerpts. During the 2011-2012 academic year, I formed a committee of university studio faculty and school orchestra teachers to select new excerpts for the All-State Orchestra (strings) audition process. ## Auditions

110 schools submitted a total of 805 auditions (8% increase)

160 singers were selected from 64 schools (approximately 20% of submissions) Dual auditions continued to be disallowed this year (i.e. submitting the same singer to both the KCDA Treble Choir AND the KMEA Middle Level Choir); reducing lag time in notifying singers and decreasing the amount of coordination required between the two organizations

#### New for 2012-2013 Online Audition Process

Troy Johnson, KMEA Webmaster, wrote a program for an online audition process. This required several hours of coordination between the chair and the Webmaster. It required many more hours of work on the part of the Webmaster. This new process saved a great deal of time for the chair and decreased the amount of work for teachers submitting auditions. The new process allows teachers to upload recordings of auditions. Teachers complete the entire process online, with the exception of mailing registration fees by the postmark deadline. Teachers received information regarding this change through: a presentation at the KCDA Summer Conference, emails with guidelines and step-by-step instructions, information in the KMR. The KMEA Webmaster was available and quick to respond to any technology concerns teachers contacted us about.

#### New for 2012-2013 Online Adjudication Process

Carefully selected and highly respected choral professionals from throughout the state adjudicated recordings throughout a three-week period. Adjudication was done from their homes on their schedule. Adjudicators did not have access to any identifiable information regarding the submissions. All submissions were scored. The chairperson, who made the final determination regarding disqualification, reviewed all disqualified submissions.

#### New Online Rehearsal Tracks

Rehearsal/Learning tracks were uploaded to the Middle Level Choir Manager site for teachers to download. Rehearsal CDs were not mailed to participating students; representing significant savings in both cost and time.

## Proposals for future consideration

1) Supply an invoice for participation fees which can be downloaded from the website.

- The majority of participating schools require an official invoice in order to process any type of payment.
- This year an invoice was designed and attached to an email for teachers to complete.

2) Move the participation fee postmark deadline to February 1<sup>st</sup> of the performance year.

- Since the KMEA ML Choir became an auditioned group, postmark deadlines have been aligned closely to the KCDA Treble Choir deadlines. This was an effort to make the process simpler for teachers submitting to both choirs. Most teachers submit to both choirs.
- These dates have not changed in many years. There is approximately a one-month turn-around from audition submission to selection notification. And a one-month turn around from notification to the participation fee deadline.
- The one-month turn-around time is proving to be difficult to manage for some schools in adhering to the payment requisition guidelines their districts have in place.

New chapter activities: We designed and ordered KMEK t-shirts this fall. Also, we are reviving our quarterly newsletter, keeping our Facebook page more up-to-date, and developing online registration for all workshops. Finally, KMEK is starting a scholarship fund in honor of beloved charter member, Sharon Parks, who passed away in September 2012. Scholarships will help teachers receive Kodály certification at WSU. All 3 levels will be offered at WSU in summer 2013 as well as 2 hours continued credit for those interested in refresher courses.

Goals: update chapter by-laws and set calendar and activities for next two calendar years. Support summer certification program at Wichita State University and grow membership.

## Workshops:

On September 22, 2012, we had a fabulous day-long workshop attended by 27 college students, 40 teachers, a 29-voice student honor choir, and tons of parents. It was standing room only – on a Saturday! In addition to working with the honor choir, clinician **Deborah Lamb** demonstrated effective warm-ups, rehearsal techniques, and ideas for pre-reading activities to be performed before students even open an octavo for the first time. For door prizes, we gave away Organization of <u>A</u>merican <u>Kodály E</u>ducators memberships: one for a full-time student and another for a teacher.
