III. Introductions and Announcements (continued)	President Avian discussed the Music in Washington Week. She noted that the presidents, along with Dr. Taylor, Mike Quilling, and Erin Funk would be traveling to D. C. to visit with the Kansas Senators and Representatives. She expressed her gratitude to the affiliate organization for helping make Kansas a strong state for music education; she mentioned this makes Kansas different from many other states' MEAs who do not have a close working relationship with their affiliates.

IV. a – Executive Council	Please go to the Board Book for the June Board Meeting to read all reports in full. Only new and or updated notes will be included in the minutes.
	• President, <i>Avian Bear</i> – Report stands as written. President Avian noted the date correction of the Southwest Division Meeting. She commented how much she has enjoyed going to the KSHSAA board meetings, which are interesting and very informative. She brought to the KSHSAA board the request by KASTA to remove the memorization requirement from the state solo festival, and she will have an answer in the coming weeks. Avian also mentioned that she has not yet been able to fill two advisory board positions: General Music Society and SMTE.
	• President-Elect, <i>Martha Gabel</i> – Report stands as written. President Elect Martha commented on the phenomenal job that Avian did representing KMEA at the KSHSAA board meeting. She noted that she has been receiving applications and recordings for performance groups at the ISW and expressed her appreciation to all involved in organizing the listening rooms
	• Vice President, <i>Craig Manteuffel</i> – Report stands as written. Vice President Craig added that the Facebook, "Call to A.R.M.S.," page is up to 1836 members. He announced a goal of reaching 2000 by the end of summer. Craig also noted the October 1 deadline for awards and articles.
	• Executive Director, <i>John Taylor</i> – Report stands as written. Dr. Taylor noted some additions to his report. Everything is booked for 2015 ISW, including hotels and all building. He has signed 2017 contracts at both the Hyatt and Century II. There are some groups that are moving around this year, such as the ACDA choir and the 1234A band. Dr. Taylor announced that there will be a bank of laptops available at the ISW for onsite registration and for online voting. He explained some the plans for the remodeling of Century II and how that might positively affect the ISW. He noted that, financially, the organization is doing well and will end the year with money in the bank. He plans to move \$10,000 into reserve, splitting



IV. a – Executive Council (continued)	between the emergency fund and the KMEA fund. Dr. Taylor will attend the executive director's meeting in D.C, where he can gain valuable information from executive directors of MEAs across the nation. He mentioned the success they are having with gathering the 6 district executive directors twice a year and giving them opportunities to meet with the KMEA CPA and legal counsel. Dr. Taylor thanked Troy Johnson and Bryan Kirk for the continued work on the Hall of Fame. He gave permission to Randy Fillmore to purchase sets of audition music for each instrument for the live auditions. He also expanded on an idea for an all-state parents event, which would be a small clinic, just for parents, to bolster advocacy efforts and maintain the support that music receives from those parents. He noted that staff evaluations were done at June board meeting and thanked the executive committee for doing that.
IV.b – Presidents	 Northeast District President, <i>Curtis Mulvenon</i> – Report stands as written. Curtis mentioned that the NE District is currently without an advocacy chair, and that he is working with Chad Coughlin on distributing information to his membership about the NE District split Southeast District, <i>Mark Gard</i> – Report stands as written. Mark added that he is looking for a new ML band chair and looking at moving the mini convention to Pittsburg State once their new fine
	 North Central District, <i>Bob Haselhuhn</i> – (report given by Joel Gittle) Joel noted that the district is financially solvent and that their annual summer meeting is coming up, where he will work with Bob on moving forward in the NC District.
	• South Central District, <i>Shawn Knopp</i> – Report stands as written. Shawn added that the SC District has moved to having Troy Johnson manage their website. Troy mentioned that the transition was smooth due to Jeff's work on the old website. Shawn also announced that the SC District is looking for a new place to host the mini convention in Wichita, due to calendar issues.
	• Northwest District, <i>Vesta Jo Still</i> – Report stands as written. Vesta Jo called attention to her report about Randy Sauer, who won an award for his children's song this year. Dr. Taylor suggested he do a clinic at the ISW about children's music composition.
	• Southwest District, <i>Lynn Unruh</i> – Report stands as written. Lynn commented that she is learning a lot about KMEA processes.
	• NAfME Collegiate, <i>Erin Funk</i> – Report stands as written. Erin noted



IV.b – Presidents (continued)	that she worked on updating the contact list and that a few chapters have gone inactive and some have just been established this year. She thanked the board for sending her to participate in collegiate events in D.C. Avian commented that the college students have a one year term, which make little to no time for training. She thanked Billy for helping Erin with the transition.
IV. c – Administrative Personnel	• Festival Ensembles Manager, <i>Randy Fillmore</i> – Report stands as written. Randy corrected the 2017 rotation of performance groups and announced he has a suggested rotation complete for all the years up to 2025. He introduced the ensemble chairs to the board and thanked them for their service. Randy also explained that he is in the process of writing guidelines for all the state auditions in order to make things more consistent from year to year. Justin Love described the issue that the band came across was deciding how many octaves all instruments can do of specific scales, as it varies so much from one instrument to another. Justin also suggested a change to the process of re-auditioning students once they arrive at the ISW. He proposed that instead of using the time to re-audition, students should have sectionals that would help better prepare them for the conductor.
	• KMR Editor, <i>Steve Oare</i> – Report stands as written. Steve elaborated about the meeting of the KMR staff. He asked the board's opinion on the distribution of a survey about the KMR. He explained that they are seeking ways to expand the readership.
	• Advertising Manager, <i>Robert Lee</i> – Robert submitted new numbers as of June 6, 2014. He noted that almost all bills are paid and brought a concern about dissatisfied advertisers to the board. He proposed changing the current layout of the ad options so that there is only one ad position in the KMR with one cost. He commented that if KMEA can maintain roughly the same number of advertisers, the KMR can maintain their current financial status under this new advertising plan. He noted that he believes many advertisers chose to buy space in the online KMR because they believe in the work KMEA does, regardless of the number of hits they get on their website.
	• Web & Technology Manager, <i>Troy Johnson</i> , - Report stands as written. Troy described the process by which he can gain information about membership in migrating it from the NAfME site. He is using this information for the assembling of the KMEA Rolodex. Troy elaborated on his development of a membership password as a way to force authentication of the members before they can vote online for KMEA President-Elect or any other election. He also expanded on his work with Elastic Mail, a service



 KMEA is using to allow for larger rate limits in email distribution. Troy explained that domain names for all 6 districts are still available, and recommended that all 6 districts use a different Twitter handle for information that pertains only to each district. ISW Exhibit Manager, <i>Dana Hamant</i> – Report stands as written. Dana commented that the exhibits are near capacity for the room. He announced plans for tripod signs with maps of the layout of exhibitors to aid in finding specific booths.
 Festivals, <i>Dana Hamant</i> – Report stands as written. Dana reported that the KSHSAA judges' training is in the development stages. He discussed a script that will be used for a session at the ISW; it will be filmed and go online. They have selected a panel of expert teachers who will listen to selected recordings and discuss how they would adjudicate those groups in a festival situation. He expressed hope that this will give people training who might otherwise feel unqualified to judge. Dana also anticipates eventually developing a solo and ensemble judges' training video in the future.
 KCDA, <i>Laura VanLeeuwen</i> – Report stands as written. Laura noted that their convention is July 10-12 at Ramada for the 4th time. She announced that KCDA is trying something new in inviting back 17 Harry Robert Wilson award winners to discuss choral music and strategies and reminisce. KBA, <i>Dennis Kerr</i> – Report stands as written. (report given by Courtney Williams) Courtney announced that the KBA Summer Convention is July 16-19 at the Marriott. She noted that Michael Map will be taking over as intercollegiate band coordinator. KASTA, <i>Eric Crawford</i> – Report stands as written. Eric pointed out one change; the new President-Elect is Brigid Mayer from Olathe East. He acknowledged the 2014 award winners, and is looking forward to continuing with the solo competition. Eric noted that the Intercollegiate Orchestra was this year, and it was great. There is some question as to whether it will continue in the future, due to lack of buy-in from college strings teachers. Avian commented that she very much sees the merit in an intercollegiate orchestra and hopes KASTA will continue to sponsor it. KMEK, <i>Hannah Northerns</i> – Report stands as written. (report given by Lindsay Jervis) Lindsay announced that this is the 10th year of certification program at WSU, and they have 3 scholarships given to a teacher at each level. In 2015 KMEK will host the Midwest OAKE conference in October.

Since the June Board meeting, I have the following items to report.

- 1. In June, I attended the NAfME NEB National Assembly in Washington, D.C. In July I attended the KBA convention. I will attend the NAfME Southwestern Division Board Meeting in Oklahoma City in November. Since I am a member of the National Executive Board, my expenses for NAfME meetings are covered by NAfME and not KMEA.
- 2. The fiscal year ended on June 30. At the writing of this report, the books for the fiscal year 2013-2014 are being reviewed by our CPA. We will finish the year in the black. Even with increasing costs during the ISW (use of facilities, adding additional facilities, etc.), I will not be recommending additional fee increases for the 2015 ISW. We will have some new technology to purchase during this fiscal year, including a new computer for me, new technology for the President-Elect, and some new technology for the ISW (including equipment to create an interactive station for the KMEA Hall of Fame and Retired Members Directory). We are also paying for an update to the KMEA website. A complete financial report for fiscal 2013-2014 will be given during this Board meeting. I will request approval of that report.
- 3. Our investments have grown moderately this year. The KMEA Fund is volatile, but it continues to increase annually in value. In June, I transferred \$5000 from the checking account into the KMEA Fund and an additional \$5000 into our Wells Fargo investments. We can now pay for all 5 of our \$500 scholarships to college students through the Fund, and we are working on the organization of how grants for research might be submitted and approved which will be funded by the KMEA Fund. I have been discussing grants from the State of Kansas with Mike Quilling, and we are looking at some possibilities. These would be different grants than we received previously from the Kansas Arts Commission. These new grants will have to be for specific projects, and they will require demonstrating how the grant results in additional income for the State of Kansas.
- 4. The fiscal year review includes a review of the books from the six Districts. The Executives can present a review of their books to the District Boards. Our report to the IRS includes all State and District funds under one umbrella and one EIN not-for-profit number. This past December, I completed 1099s and W2s for the State and for the Districts. W9s are completed for all State and District salaried and fee transactions (both income and expenses). We hold two annual meetings with the District Executives one before this Board meeting and one on Thursday evening of the ISW in February. We are all indebted to our District Executives, who do excellent work to keep the District finances solvent. A special thanks to Gary McCarty as he retires as the Southeast District Executive Director and Alan Paxson assumes that position.
- 5. All facilities bookings for the 2015 ISW are completed, including booking for the Garvey Center and the Metropolitan Baptist Church. The sanctuary of the Metropolitan Baptist



Church, where the 56A Band rehearses in the Fellowship Hall, has been booked for the ACDA Unchanged Voice Choir so that the size of that ensemble can continue to grow. In addition, a number of hotel rate contracts have also been negotiated and signed. Costs continue to rise for use of the facilities and all the other services to the ISW. I will continue to monitor the progress by the City of Wichita on the renovation of Century II Convention Center.


- 6. Contracting for guest artists and clinicians for the 2015 ISW is complete (some final paperwork is being secured). Most of the clinicians for 2016 and 2017 have been booked for the Assistant Chairs. All files for 2015 clinicians are complete except the 56A Band. The 2015 All-State conductors are: Michael Parkinson, Jazz Band; Brad Holmes, High School Choir; Robert W. Smith, 56A Band; Brian Balmages, 1234A Band; Steven Amundson, Orchestra; and Ryan Board, Middle Level Choir. The Elementary Clinicians will be Martha Riley, Roger Sams, and Jill Trinka.
- 7. ISW on-site registration will change this year. A bank of laptops will be provided by NAfME, and those who will register on-site will do so electronically. This includes joining NAfME/KMEA, completing the ISW Registration Form, and the option of paying with a credit card (checks will still be accepted at on-site registration). Michelle Postier, Troy Johnson, and I are still working out some kinks, but we plan to have the process ready for the 2015 ISW.
- 8. Voting for the KMEA President-Elect will be online this year. This will solve the ethical issue of requiring attendance at the ISW to vote, and will be easier for our members. Troy Johnson is preparing the website. Members should be able to vote electronically at on-site registration as well as on all their internet-connected devices. Voting will require signing-in with your membership number. (Note we are not requiring a picture ID, such as a passport!) The timeline has not yet been established, but voting will probably being around February 1 and will continue through Friday of the ISW.
- 9. I have completed work on three new forms/policies for KMEA. These are the last of several new forms and policies that have been written in an ongoing process for several years to make sure we are compliant with the IRS as well as to protect ourselves legally. These last three include an Investments Policy, a Records Retention Policy, and a Records and Emergency Contingency (REC) Policy. At the writing of this report, the documents are being reviewed by the Executive Council, Jade Brown (our legal counsel), and our investment advisors. If the review process is completed by the Board meeting, I will be presenting these forms for Board approval. If not, I will ask for approval at the February Board meeting.
- We have wonderful KMEA employees who work for minimal salaries and dedicate countless hours to KMEA. Please thank these people when you have the chance. 


We are still working on getting all of our procedures/policies/guidebooks for all of the officers updated and put on our website.







CRM/API Membership Data

Following an email exchange and phone call with the NAfME IT department, I do not have a timeline for completion of an election module. NAfME is changing how states access membership data. The current method of data access, which was free (not to mention a disastrous design, but that's another story) is going away at some point, but they wouldn't say when.

NAfME spent the recent increases in membership dues on the Microsoft Dynamics CRM system (Customer Relationship Management) from 3rd-party vendor CogentPath. Membership data is becoming controlled by CogentPath. Each point of access will require a separate fee-based license per person (this is how Microsoft and CogentPath make their money). The first license is free, and subsequent licenses are \$1,000 each.

In order to have access to our own membership data for web programming purposes, we will be required to either:

- A) scrap our existing website and replace it with what CogentPath provides, or...
- B) pay a fee of \$1,600 to license our existing website to have access to the data via an API (Application Program Interface). This is in addition to the CRM license fees listed above.

Option A is less than viable. Our existing website is intertwined with multiple databases on our web server. These have been built out over many years and hours of work according to the specific needs of KMEA. NAfME seems to operate from the belief that MEAs don't know what they're doing with web programming and therefore all MEAs have to be forced into their one-size-fits-all package, or else pay up. Another major reason against Option A is the *Kansas Music Review*. I don't think this one requires much explanation.

For whatever reason, the package provided by CogentPath is the only option that does not include additional fees. According to NAfME, this is because it comes with a license that is included with the CRM. We apparently are not allowed to use that license with our existing website. So it would appear that we have no choice but to pay \$1,600 to access our own membership data.

MEA members nation-wide paid higher membership dues so that NAfME could purchase a system that MEAs can't access without paying more money. Bottom line... KMEA cannot have access to our own membership data without paying up. The free process by which Michelle and I have been accessing member data over the past several years will likely close soon, thus forcing us to pay CRM/API costs whether we like it or not. Without data access, a potential voting system might not be possible. Our ISW registration system would be negatively impacted, as it currently has the ability to not only notify Michelle and me of incoming registrations/payments, but it also immediately flags registrations from members who are not



current on membership dues. This function saves Michelle many hours of work. The state-wide membership email list that we're currently running on Rackspace is also derived from that data.

District Domain Names

SW, SC, and NC Districts are now set up with SWKMEA.ORG, SCKMEA.ORG, and NCKMEA.ORG respectively. Bookmarks with the old web addresses will continue to work normally.

District Twitter Integration

Twitter handles for each KMEA district have been secured (@nwkmea, @nckmea, @nekmea, @swkmea, @sckmea, @sekmea). The NW and SC District Presidents, so far, are now set up with access to their respective Twitter accounts. I've styled their avatars to have a look that is similar to the existing @ksmea avatar.
