President Elect Martha noted what a wonderful job Mike Quilling did in setting up appointments and organizing for the Capital Hill Advocacy Day. She again thanked all those who helped with the listening rooms and announced that 44 groups had been selected to perform at the 2014 ISW.

I am pleased to report the following activity.

- 1. The arrangements for the 2015 ISW have been completed. Venues have been booked, scheduled and paid. Contracts for various artists and arrangements have been signed. Arrangements for performing groups and student musicians have been finalized. All food service arrangements have been made. Awards plaques and presentation letters have been prepared. The KMEA employees have completed preparations for their work during the ISW. Contracting continues for all-state conductors for 2016 and 2017. I just paid the deposit on Century II for the 2016 ISW, and I recently met with the staff at the Hyatt Regency and signed the contract for the 2018 ISW. The only organizational change this year is that Corporate Caterers has replaced Premier Catering as the sole food service provider to the Century II Convention Center.
- 2. A bus will run from 11 AM to 2 PM on Friday, Feb. 27, between Century II Convention Center and Old Town so that registrants can go there for lunch without moving their cars. The bus service is free.
- 3. I again request that all KMEA Board members work your way through the Exhibits and personally thank those who have rented booth space. If you have a red Board ribbon, this is an important part of your responsibilities. The ISW would not exist were it not for fees paid by our Exhibitors.
- 4. I continue to monitor the KMEA finances. Costs for the ISW continue to increase. I will know by the KMEA summer Board meetings if we need to ask for any increases to ISW fees. We were able to add \$10,000 to KMEA investments this past fiscal year.
- 5. I continue to monitor the possible update of Century II Convention Center by the City of Wichita. They have finished the fact-finding process, but a final plan will not be available for some time. It appears that the most popular option is to remodel and add additions to the current structure. I am keeping the KMEA leadership informed on this process. So far, the plan will affect the KMEA ISW positively.
- 6. All the end-of-calendar-year taxes for the IRS and the State of Kansas were completed by the January 31 deadline. This included tax reports, 1099s, and W2s for employees and clinicians at the State and District levels. Conflict of Interest Forms and Whistleblower Forms are not being signed by all KMEA leaders at the District and State levels.
- 7. I am working on several long-range projects for KMEA. I am working to get copies of past ISW Schedule Programs and All-State Concert Programs on the website. KMEA now has an Investment Policy and a Records Retention Policy both requested by the IRS. These have been reviewed by KMEA legal counsel and approved by the Board.
- 8. The organization of the KMEA District Executive Directors continues to function. We have a semiannual schedule of meetings. All District Executives function under the KMEA not-for-profit status and District Executives have year-end financial reports to share with their Boards. We continue to align much of the paperwork that is common among the State and the Districts, and all Districts are reporting as required by law to the IRS. The KMEA accountant, Lindsay Williams, works with this group.
- 9. I am working with the District Split Committee and Chad Coughlin to facilitate meetings and provide counsel.




- 10. The KMEA Board has approved the process and expenses for our leadership of the Music Day at the Capitol in Topeka in March. Mike Quilling has done a remarkable job of making arrangement to improve this event, and KMEA will be providing financial support for travel to Topeka and for a breakfast for the legislators.
- 11. I complete my term as Immediate Past President of the Southwestern Division of NAfME in June. Thank you again for your patience as I completed my term on the National Executive Board of NAfME.
- 12. We have the most wonderful employees working on behalf of KMEA. Please take a moment to thank all the KMEA employees when you have a chance. They are paid a minimal amount for their work, and they provide excellent service to our organization. I live in constant fear that they will grow weary and leave their posts!

For the 2015 In-Service Workshop we are launching a new "ISW website" intended to focus primarily on ISWrelated information and functions, including the ISW schedule, exhibits, performances, and clinicians, as well as on-site registration and online voting for President-Elect. The KMEA Hall of Fame digital display will have a new loop script this year. Instead of running all 104 profiles in sequence, according to year of induction, the new script will pull random profiles from throughout the Hall of Fame timeline in order to provide a more frequent update to the display as well as juxtapose profiles from different segments of KMEA's history. The right pane will contain





upcoming ISW events and will refresh itself every several minutes as we go through the ISW. The next 5 or 6 events will always display on screen at any given time. Last year we experienced technical difficulties with the display screens in the Concert Hall lobby, thus we were limited to displays appearing only outside the WichitaTix office and in the Concert Hall entrance foyer. I've been informed that those glitches were resolved shortly after the 2014 ISW was over, so we should have more screens running for this ISW.

New Registration Elements

The following improvements were made to our various registration and manager systems this year:

- **Performance Groups** equipment requests and reports for Kevin Findley
- **All-State Concerts** comp tickets for registered attendees, including a management system for WichitaTix staff to use
- **ISW Program Advertising** KMR Ad history, for automated advertising rates in the ISW Program.
- All-State Manager Participation invoicing, HS Choir stats report, Jazz Lead Trumpet and Bass Trombone audition "options," generated email lists of All-State directors, parents & students, choral audition voicing changes.
- ISW Registration Manager convention badge ribbons, All-State concert ticket preparation and delivery status, registration category transfers, automated messages to members for registration and processing status updates (eliminated a good number of phone calls), API data updates from NAfME for membership renewal status, automated data import of entire KMEA membership database.
- **Middle Level Choir Manager** upgraded all mp3 playback screens from a flash-based player to an HTML5 browser-based player, continued improvements to selectee selection screens, reducing administrative time needed to develop the final roster.

Hosting account info

There are no concerns with our web hosting capacity for the foreseeable future. We are currently using only 7.8% of our disk space quota (4,679MB of 58GB), an increase of 0.8% from last year and 1.8% in the past two years. Monthly bandwidth transfer is currently at 3% of our allotment (25.17 of 750 GB).

Domain Name

Our domain name **ksmea.org** is due for renewal this spring. We will be shifting to a different registrar to take advantage of a lower rate. This transition will be seamless. Website visitors will likely not notice the change.

The 2015 ISW currently has 109 exhibitors using 172 booth spaces. The 2014 total included 106 exhibitors purchasing 172 booth spaces. This year there were four entries for the composition competition. All four entries were from high school composers. Four high schools were represented. One of the student composers submitted an entry last year which one the competition.

Entry names and titles are as follows:

Scott Hershberger, Tale of the Forgotten Logan Nelson, Spontaneous Accounts Krista Pojman, In a Child's Mind Isaiah Hastings, Two Heroes

This year's adjudicators were Dr. Kenneth Fuchs, Dr. Andrew Poor and Dr. David Holsinger. Dr. Fuchs is Professor of Composition at the University of Connecticut. His music is published by the Edward B. Marks Company and the Naxos recording label as recently released its fourth CD dedicated to his music. Dr. Poor is Director of Bands at South Forsythe Middle School in Cumming, Georgia, serves on the faculty of Columbus State University and is a staff member of the Phantom Regiment Drum and Bugle Corps. His works are published by Northeastern Music Publications and C.L. Barnhouse Company. Dr. Holsinger is a member of the Lee University Faculty in Cleveland, Tennessee. He is a two time winner of the ABA Ostwald Award for composition and is a frequent guest composer/conductor throughout the nation. Each of these adjudicators rated each composition and wrote constructive comments. Each composer received his or her respective comments from these adjudicators.

The composition was selected as the winning entry was Scott Hershberger's *Tale of the Forgotten* for solo piano. Scott will perform his work at the Thursday evening concert at 8:00 PM. Logan Nelson's *Spontaneous Accounts* for unaccompanied alto saxophone was selected as the second place winner. Logan's work will be performed on the Thursday evening concert by DMA Candidate Robbie Hervey from the University of Kansas.

The number of entries this year was down from last year, a trend which is hopefully an anomaly. Working to increase awareness of this program to our music educators in Kansas is still a continued goal as is continuing to encourage submitted entries at the younger grade levels, particularly elementary and middle level.

Based on adjudicator feedback and commentary, the following changes were submitted to the KMEA Board and approved to go into effect for the next round of submissions.

- 1) The Ensemble category is now divided into two sub-categories of small (2-6 players and/or solo voices) and large (7 players and up with choral works included in this category).
- 2) A fourth category for Jazz compositions was created. This category includes two subcategories of combo (up to 7 players) and large ensemble (8 players and up).



I would also request the board's permission to make the following change to the adjudicator's rubric:

Change the fourth category column label of the adjudicator rubric from "poor" to "below average."

Rationale: A primary purpose of the competition is the encouragement and development of young composers. As such, the term "poor" might be discouraging, whereas alternate wording would communicate the same criteria in a more educationally valid manner.

This change could immediately go into effect as it is only applicable to the post-deadline judging process and does not affect the guidelines to which submissions are subject.

I welcome any feedback, comments and suggestions from the board on this report and/or the competition in general. I appreciate the opportunity to serve our organization and look forward to our continued work together.

Some of these topics will receive more discussion since the number one priority of adjudicator training will have been taken care of.

The outcome of last year's election has resulted in fewer supporters of education in Topeka and many of those returning seem to be emboldened in enacting their agenda dealing with education. It is imperative that KMEA continues to be viewed as a nonpartisan organization "promoting the advocacy of music learning in schools and communities". With that purpose in mind, the leadership of KMEA provided written testimony to the Senate Education Committee for the February 2nd hearing on Senate Bill 60; Participation of home-schooled students in activities regulated by KSHSAA. The written testimony is included below.

The KMEA leadership has agreed to host the first annual "Music Day at the Capitol" on Thursday March 12th in Topeka, KS. The Kansas Citizens for the Arts has elected not to host their arts day this year. Although KMEA values the partnership with other arts organizations, it is important to have an event that focuses on the message of KMEA and NAfME. The theme for the music day events will be tied to the NAfME campaign – "Music – Broader Minded" www.broaderminded.com. In addition to musical performances at the Capitol, leaders of KMEA will meet with legislators and other decision-makers about the importance of music education.

Re: SENATE BILL No. 60

The Kansas Music Educators Association (KMEA) is an organization of music educators committed to the concept that the study of music is a positive influence in the lives of individuals and society as a whole. Whether children receive their education in a public, private, or parochial school, or at home, music education remains a core subject (as defined in ESEA) and KMEA maintains that adequate music education resources should be available to all students, regardless of how children obtain their education.

KMEA appreciates how music brings meaning and richness to our heritage and culture and we encourage the study and making of music by all. However, Senate Bill 60, in its current form, does present some questions and concerns that KMEA believes should be addressed.

1.) Under Senate Bill 60 "Any student who is a resident of a school district shall be permitted to participate in any activities offered by such school district regardless of whether such student attends a school in such school district on a full-time basis."

How would SB 60 address the co-curricular activities, such as band, choir, orchestra, that require daily instruction in the classroom?

- Could a student participate in a large group performance without ever rehearsing with the group as a member of the class?
- Should a student be required to enroll as part-time students in order to participate in music classes?
- 2.) Although Kansas tax dollars help pay for public education, including curricular and extracurricular programs such as music instruction, districts receive funds for education based on district enrollments.

Given that music instruction is often underfunded and understaffed, how would SB 60 insure that increased student participation in music classes would result in increased funding to cover expenses for materials, instruments, or fees?

• Could a student be required to pay fees before being allowed to participate in a music class?

Revising the Kansas Model Curricular Standards for Music Education

Revising the Kansas Model Curricular Standards for Music Education is underway. A committee was formed and face-to-face meetings are being held. Revisions will reflect the revised National Music Standards. The goal is to have the work completed by July of 2015 at which time the standards will go before the Kansas State Board of Education for their approval. National Core Fine Arts Standards

The National Core Arts Standards were released in June 2014. Work has been on-going regarding educating teachers about the format and content of the National Standards. The committee working on updating the Kansas Music standards is focusing on adopting the national standards and developing resources to help teachers align them to their district curriculum.

KSHSAA continues to sponsor 5 Piano Regional contests with State at Wichita State University this year. We had 351 students participate which was down 38 students from last year.

We also sponsor 17 Solo and Small Ensemble Regional Festivals, 15 State Large Group Festivals and 6 Solo and Small Ensemble State Festivals in March & April. The above contests require a total of 301 adjudicators. This is the ninth full year that we are completely web based concerning music adjudication updates and assignments. Priority is given to those adjudicators who update their files in August. As you hear of excellent teachers who retire please encourage them to contact me and apply to become an adjudicator for our state. Adjudicator fees were raised this year from \$180 to \$200 per day. Meal allowances were raised \$1.00 per meal.

We continue to have a shortage of orchestra and vocal adjudicators. In the band area, woodwind & percussion adjudicator assignments are the toughest to fill as we have a greater number of student entries in this area. We are finding that when teachers retire they are less likely to put their name in our judging pool than in the past.

It has taken a lot of collaboration between KMEA and KSHSAA, but we are excited to offer a 2hour adjudicator training session on Thursday from 2:00 to 4:00 at this year's 2015 KMEA In-Service. This training will be for Choral, Band and Orchestra current and potential adjudicators plus any current music directors who would like to learn more about what adjudicators look for at contests. These three training sessions will be videotaped and plans are to offer online training for future years to new adjudicators.

In spring 2015, this will be our fourth year to use the solo & small ensemble rubric rating sheets. We have published these on our KSHSAA music web page so all directors and adjudicators may download these forms.

In 2006, KMEA requested that we record and track all ratings given at festivals in order to monitor trends over the coming years. In 2007, we began using Large Group Rubric ballots. In 2012, we began using Solo & Ensemble Rubric ballots. We are working hard to shift this mentality from "the rating means everything" to "the educational critique and learning experience is the #1 outcome from a quality contest". This has been a slow process but a process that is worthy of continued effort to validate the overall purpose of our festivals.

In Fall of 2015 with KMEA's support, KSHSAA made it an annual requirement <u>for all head</u> <u>music directors to complete an online rule meeting.</u> This takes about 50 minutes and provides directors with important information regarding KSHSAA music festivals and KSHSAA services. Items covered included the KSHSAA manual, new rule changes, rule updates, deadlines, valuable resources, new director registration procedure, festival manager updates, etc.

This is the 3rd year the NFHS and NIAAA (National Interscholastic Athletic Administrator Association) teamed up to make professional public audio announcements which were distributed to every radio station in Kansas this December. They promote the value of high school athletic, activities and academic standards. This year one of the five features activities and is entitled, "Performing Arts". She is the sole recipient in the Nation. Congratulations to both of these fine Kansas music educators!

I want to express my sincere appreciation for all that music educators do year in and year out for Kansas students. As technology continues to make a major impact on our society, the KMEA Mentor Program is seeking ways to identify new teaches faster and make those connections earlier. Of course, we still find the most value in the "one on one" relationship of meeting face to face, nothing can improve the success of real life connections. This is particularly important in the first few years of teaching. One of the challenges continues to be in the rural areas of Kansas when a "face to face" is often a factor due to the distance between schools. It is our hope that going to workshops during the year and seeking out days to gather together will be an important part of the mentor program. Of course the addition of the six district mentor chairs (listed below) has had a major impact to locate new teachers now in its sixth year of operation. Kelly and Holly have very much appreciated the support of the mentor chairs to reach new teachers and make those connections. The website for KMEA also has valuable information for both new teachers and mentors.

The tenth Annual First year Teacher Luncheon is scheduled for Saturday, February 28th at 11:30AM with the following speakers: KMEA President Avian Bear. NAfME Southwestern Division President James South, Kansas State High School Activities Association Assistant Executive Director Reggie Romine, and representing Kansas Music Merchants Association is Senseney Music President, Lori Supinie.

We are expecting a good group of new teachers this year, at the time of the publication deadline, we have 16 new teachers enrolled in the New Teacher Luncheon. Although, that means we have more teachers new to their positions in the state. Five of the six districts in the state of Kansas have new music teachers joining their districts. Northwest has one, North Central has none whom we have had contact with and Northeast with five. In the Southern half of the state, Southeast has one, South Central has six and the Southwest district has three new teachers. We understand that there are more new teachers in these districts who have not enrolled in the luncheon. Therefore, we cannot reach them the same way these 16 will be reached. This repeated session each year continues to be a popular session with new teachers and college students.

The articles were titled: "The Defroster of Your First Year Windshield"; "The Technology Is There...But Don't Forget To Read Up"; "What Does A Twenty First Century Mentoring Program Look Like?"; and "Consolidation." Below is a list of the current district mentor chairs. Kelly and Holly are most appreciative of the ongoing worked that the six district mentor chairs do to promote the mentor program. We look forward to the program continuing to grow under their leadership and commitment. Some of the names will change upon the completion of this conference. - 3. Do More With Less in the Middle Level Ensemble *Clinician*: Jennifer J. Antonetti *Content*: This session will focus on several ways that a director can enhance the ensemble experience on a tight budget at the middle level.
- 4. Teaching Beginning Brass Players *Clinician:* Kyle Hopkins *Content:* This session will address common issues/problems encountered in teaching beginning brass players and provide practical and unique solutions for those issues.
- 5. Where the Wild Things Are: Recruiting, Retaining, and Motivating Middle School Singers *Clinician:* Nathan Dame
- 6. Drummers Driving You Ditsy? Here's Some Help *Clinician:* Ginger Zyskowski *Content:* This presentation of ideas and thoughts on how drummers think and learn will offer helpful techniques for the instrumental music educators.
- 7. Cultivating Critical Thinking Skills in the Music Classroom: Assessment as Learning *Clinician:* Phillip Payne & Ruth Gurgel

The Research Poster Session at the last In-Service Workshop featured 22 projects. This session was well attended.

This year we are moving the poster presentations to the second floor foyer (above the registration table). Posters can begin going up on Thursday, and remain on display through the poster session on Friday, when presenters will stand with their work to clarify their studies and respond to questions. We hope this will increase the accessibility and visibility of the work going on throughout Kansas.

The General In-Service Workshop Session last year featured Teddi Ricketts, Nancy McKellar, Randall Ellsworth, and Elaine Bernstorf discussing *Relationships Between Instrumental Music Participation and Academic Achievement in Low Socioeconomic Students*. Their results showed a statistically significant relationship between sixth grade instrumental music participation and reading scores, as well as math scores, and also suggested that duration in a string instrumental music class may be important to increases in academic achievement on state assessments.

The second presentation in this session featured Melissa Grady who discussed a project entitled: Effects of nonverbal gestures exhibited by multiple conductors on acoustical, visual, and psychoacoustical measures of choral music-making: A collective case study. This collective case study examined potential acoustical and psychoacoustical effects of conductor arm and hand gestural stimuli on the choral music-making of an established women's choir (N = 18), as it performed a previously learned composition under multiple conductors (the ensemble's regular conductor, whose nonverbal leadership constituted the baseline condition, and 5 guest conductors, whose nonverbal leadership constituted the experimental conditions).

Through all the changes made in the poster session this year, we have decided to not have a general session again until next year.

The Research Poster Session is scheduled for 3:00-3:55pm on Friday.

In 2014, Dr. Marie Miller retired as the Dean of the College of Liberal Arts and Sciences at Emporia State University and as the Kansas Chair of the *Society for Music Teacher Education* (SMTE). We wish her the best in all her future endeavors! Drs. Selim Giray and Jacob M. Dakon assumed the role of state chair(s) for SMTE and KCOMTEPS.

The Kansas Consortium of Music Teacher Educator Professors & Students (KCOMTEPS) met on September 28-29, 2014 at the Marcus Welcome Center on the Wichita State University campus. The clinician for the event was Dr. Leigh Ann Mock Garner, who gave two clinics: Nurturing Masterful Musicianship in Undergraduate Music Educators, and Playing Nice in the Music Sandbox: Meaningful Collaboration with Music Colleagues.

Student attendance for KCOMTEPS was up this year. Eighty-eight (88) students enrolled early, an increase of 20 students. Total, 108 collegiate students from eight of Kansas' collegiate institutions were in attendance. Institutions included Wichita State University, Baker University, University of Kansas, Washburn University, Friends University, Emporia State University, Southwestern College, and Hesston College. Initial registration data for 2014 and prior years were as follows.

2014 - 13 faculty, 88 students (Current year)

2013 - 16 faculty, 68 students

2012 - 13 faculty, 76 students

2011 - 13 faculty, 89 students

The KMEA Fund is growing. Our current market value is \$76,774.01 as of February 14, 2015, up \$14,160.71 from last year at this time. Dr. Holmes will also lead an interest session for choir directors entitled, "**Imagination vs. Taking Roll**: *How To Keep Artistry at the Forefront of Rehearsal*. This will take place on Friday afternoon. Susan Laushman, from Pittsburg, is our accompanist.

State Jazz Auditions were held Saturday, January 10th, in Salina. There were 127 scheduled auditions. We had 10 cancellations (auditions that didn't show up) this year. There were 100 auditions in 2014 and 112 in 2013.

Special thanks go to Jake Montoya and Lindsay Modin, who, along with several Salina Central students set up audition rooms. I would also like to thank Justin Love and Damian Johnson for their assistance after the auditions. They were pacesetters for getting the initial list ready for all the groups.

Our 20 member All-State Jazz Band has the following class representations: School size: 2A-1 student, 3A-1 student, 4A-2 students, 5A-5 students, 6A-11 students, and KMEA districts represented are: NC-1 student, SC-6 students, NE-13 students.

Jazz judges were involved with four audition rooms: Saxophone, trombone, trumpet and rhythm section. A lead judge in each room was responsible for securing three or more judges plus door monitor. Audition times were assigned and given to students at the registration table (names, times and room numbers were on mailing labels).

Our jazz clinician, Michael Parkinson, is a native of Cleveland, Tennessee. He received the DMA in wind conducting from Cincinnati, the MM in trumpet performance from Kent State, and the BM in music education from North Texas. All-State Wind and Percussion Live Auditions

The Instrumental Live Auditions were held at Salina-Central High School on Saturday, January 10, 2015. Thanks to all of the directors who served as judges, tabulators, and monitors. A special thanks to Damian Johnson, Bryan Kirk, Courtney Williams, Randy Fillmore, Troy Johnson, Ben Rohrer, and the parents and custodial staff of Salina-Central High School for their work in assisting with the audition process.

A total of 743 students registered for auditions, a decrease of 33 students from last year. Of these, 691 students (93%) completed their audition. For the past several years, audition registrations for Wind and Percussion averaged around 750 auditions. The chair feels that this average will likely remain consistent until the two new KMEA Districts officially form in 2018. At that time, it is likely that audition registrations will increase, as there will be more district band spots available through which students can qualify to audition for an All-State Ensemble. Please refer to the audition statistics below for more detailed information.

A rubric based upon the KSHSAA Solo and Ensemble Rubric was used again in the audition process. A copy of that rubric is included in this report. Each year there is some discussion regarding the distribution of points in each scoring category, but overall feedback regarding the use of the rubric remains positive. Some directors requested that the rubric be made public to share with students. The chair feels this certainly provides an educational benefit to auditioning students, but he would like to defer to KMEA Leadership input before doing so.

Again, a continued emphasis on professional decorum by directors during the audition process minimized any irregularities in the audition process. With any large event, there are always minor logistical enhancements that can be made to keep the process as fair and efficient as possible. Notes regarding those suggestions will go to the incoming chairs. Additionally a set of plastic tubs, folders, and notebooks have been prepared for the incoming chairs to assist in organization of all materials related to auditions. A detailed timeline of tasks and copies of all correspondence, forms, and instruction sheets are included in the notebooks to help establish some consistency for future chairs. It is our hope that this will also assist new chairpersons in their ability to more quickly understand their role and responsibilities.

Auditions to select members of the 2015 All-State Orchestra were held on January 10 at Salina Central HS. Orchestra directors from across the state helped with judging and running the auditions, and all auditions, including nearly 100 violin players, were complete by about 12:30 pm. We did not use an electronic scoring system this year, due to internet access issues. However, the team of data entry people did a great job and we were finished with the selection process by around 2:00. Many thanks to a great group of teachers who acted as judges, door monitors, runners and computer experts. Thanks most of all to my assistant chair, Wesley DeSpain, who has done a fantastic job of organizing the audition team, and in fact, a fantastic job of helping to run the all-state orchestra for the past two years. No one could have asked for a better assistant, and he will make a great orchestra chair.

One important change in this year's auditions was that we incorporated harp auditions into the live audition process in Salina. We used excerpts from the actual all-state literature for this year as audition excerpts and posted it on the web site in the fall. In the future we may need to make decisions about harp auditions on a year-by-year basis, due to the variance in the literature. This year it really made sense to have harpists audition just like the rest of the string section since all three of the pieces chosen for this year have extensive harp parts. In future years, we could conceivably not need harp at all for some concerts. One thing that I do recommend for the future is that special instrumentation needs be determined as early as possible and communicated to the band chairs as well as Randy Fillmore so that the auditions can reflect instrumentation needs.

Steve Amundson from St. Olaf's University will conduct the 2015 All-State Orchestra. He has been outstanding to work with and I am sure the students will have a wonderful experience working with him and performing the exciting and challenging literature he has chosen. The orchestra will perform Bernstein's "Overture to Candide," Amundson's "Longing for Your Return," and Tchaikovsky's "Capriccio Italien."

Next year's All-State Orchestra clinician will be Jonathan Shames from the University of Oklahoma. I know that he and Wesley DeSpain will provide another great experience for the outstanding young musicians in our state next February!

I know many of you might not be deeply familiar with the educational techniques collected and advised by Zoltán Kodály. The following quotes give a taste of the principles his work was founded and what we at KMEK have adopted as the mission of our classrooms and professional organization.

"We should read music in the same way that an educated adult will read a book: in silence, but imagining the sound." (1954)

"To teach a child an instrument without first giving him preparatory training and without developing singing, reading and dictating to the highest level along with the playing is to build upon sand." (1953)

"And I would advise my young colleagues, the composers of symphonies, to drop in sometimes at the kindergarten, too. It is there that it is decided whether there will be anybody to understand their works in twenty years' time." (1957)

-The Selected Writings of Zoltán Kodály, Boosey & Hawkes, 1974

Our big goals this year in KMEK are to reach more teachers (elementary to middle and high schools, whether new or seasoned, Kodály-certified or not) and then grow involvement of educators throughout the state and region by hosting a stellar conference in October. All of our Kansas Kodály happenings are at www.kmek.org.

The big event on the Kansas horizon is the 2015 MKMEA regional conference. We're planning a conference that will *enrich your roots* through folk music, insightful presenters, and choral music with heritage. *Branch out* to try on new ideas for teaching and thinking about education. *Shake those leaves* with our best local artists in the middle of our dining and culture hub! Come to Wichita this October for a regional conference that will send you home enriched and inspired for the coming school year. This conference includes a weekend of sessions for teachers (usually three concurrent sessions to choose from at any time) as well as an honor choir of 5th-8th graders from KS to Canada. To reach teachers hours away from our usual "professional development hubs" we've discussed but not progressed in an idea to have KMEK members drive to these areas to provide workshops on concept-based teaching methods. In an effort to fulfill Zoltán Kodály's vision that educators instill in their students "a thirst for finer music in him, a thirst which will last for a lifetime," we have secondary choral and instrumental chairs on our cabinet.*



KMEK started the school year with new cabinet members, and our first workshop featured a superb educator and all-around dynamite woman, Dr. Leigh Ann Garner. Of 76 participants, we offered free registration to the 31 college students in attendance. Dr. Garner shared joyful songs and games and many varied activities to focus in on conceptual learning.

KMEK President-elect, Lindsay Jervis makes accurate and engaging classroom visuals, both digital and physically manipulative. February 7 she hosted a workshop to show us how she does it! It was a computer-based session where we heard her tips and tricks, then got work time to try it for ourselves.

Amy Abbott is coming in from Colorado this April to engage KMEK friends in her workshop *Say, Say O'Playmate: Singing Games for 3-5 Grades*. We're excited to get some fresh ideas for upper elementary songs, games, dances, and literacy concepts.

KMEK has sponsored a portion of the expense to bring Jill Trinka to KMEA this year. We're thankful for the opportunity to have a voice in and support KMEA professional development.
