Here are some of the activities in which I have been involved.

- 1. All bills have been paid and paperwork completed from the 2017 ISW. I have also met with those business leaders who help us prepare for the convention, and thank-you gifts have been sent to several businesses that are key to our success. Also, all employees who are paid annually at the ISW have been paid. Registration at the ISW is holding steady.
- 2. The addition of Expo Hall for Exhibits was very successful. Every person I spoke to liked the move. Several offered ideas for improvement. We will need to move Registration to a new location within Expo Hall. Concessions in Expo Hall were successful, and the seating provided an opportunity for members to relax and have conversation. Helgerson's donated the carpet in the aisles, and we will continue to rent the carpet. It adds significantly to the look of the Exhibits area. Dana Hamant has some ideas on how to improve the Exhibits set-up, including adding more seating areas. We also must find a way to limit access to the Exhibits area, including people entering through the curtains. Dana also has a proposal to change the pricing process for exhibitors.
- 3. Contracts have been completed with Century II, the Hyatt Hotel, the Broadview Plaza Drury Hotel, the Garvey Center and the Metropolitan Baptist Church for the 2018 ISW. The Hyatt and Century II have signed contracts for both 2019 and 2020.
- 4. All-State Conductors and clinicians have been booked for 2018, and we are making good progress on finishing the bookings through 2019. With the appointment of new Assistant Chairs by President-Elect Phillips, we are just now beginning the booking process for 2020 and 2021. The 2018 conductors are Sophia Papoulis, Elementary Choir; Rollo Dilworth, Middle Level Choir; Dale Warren, 1-4A Band; Emily Threinen, 56A Band; Christopher Aspaas, High School Choir; David Becker, Orchestra; and Steven Owen, Jazz.
- 5. We have a crisis concerning All-State rehearsal facilities, which I am working to solve. It has been our philosophy to keep all honor ensembles within walking distance of Century II. I believe we have reached a point where that will no longer be possible. The addition of a second choir in 2019 makes this an appropriate time to look at facilities.
  - a. The Metropolitan Baptist Church is not available. The ACDA Unchanged Voice Choir rehearses there, and until 2017, the 56A Band rehearsed there.



- b. The 56A Band rehearsed in Exhibition Hall, and we had sound bleed-through problems with both the 1234A Band in Convention Hall and in the MJT Theater. Thus, we will need to move the 56A Band to a new location. Exhibition Hall may work for one of our choirs. Otherwise, this large venue will go unused at our convention.
- c. The Intercollegiate Band and Orchestra have been using the Founders Room in the basement of the Garvey Building. This is an inadequate facility for instrumental groups of this size. It could possibly be used by a choir.
- d. The bleachers used as choir risers for the All-State High School Choir are scheduled to be destroyed by Century II, and there is no company that still makes them.

I am researching several unused facilities downtown, and I am looking at the possible use of facilities at nearby universities and schools. Distance between Century II and All-State rehearsal facilities can make it more difficult or our members to manage their All-State students. This also means transporting conductors back to Century II for clinics, limits student access to the exhibits and other convention activity, and the possibility of running busses for students. I am also hoping to meet with staff at Century II before our Board meeting to discuss several concerns mentioned above. I should have a final list of rehearsal locations at our meeting in July.

- 6. As we look at the addition of a new All-State Choir, it is time to take a look at our All-State concert schedule. We may need to consider spreading out the rehearsal and concert schedules over the entire convention. This will be a major change for our members in many ways, including the availability of performance stages for performing groups and when All-State students will need to be in Wichita for rehearsals. Services provided (lunches, pictures, plaque/shirt sales, recording sales, etc.) will all be affected. I will be asking President Bixler to put together a committee to study this problem for possible implementation in 2019.
- 7. For two years, KMEA provided clinic sessions for school administrators at the ISW. Attendance has decreased, and we will no longer offer these clinics. Administrators will still be able to pre-register for the ISW online at no cost.
- 8. I am researching a way to provide Advocacy Receptions for the families of All-State students before their concerts. The plan this year is to hold one reception for 1-2 ensembles. The conductors would share briefly with the families, and an advocate for music education would share ways to support music education in their communities. I will have more information on this process in July.



- 9. We have terminated our use of PepWear to provide plaques and tee shirts to our All-State students. They have had poor service in recent years, and they created a major problem this year with shipping their items to the ISW. Many of our Districts and Affiliates have also used PepWear. I have been having conversations with a Kansas company to provide this service, and I should have a proposal at either the June or July Board meetings. I am encouraging our Districts and Affiliates to use the new company once we have an agreement. You are welcome to continue to use PepWear, but I cannot guarantee that I can solve problems for you with PepWear in the future.
- 10. I continue to monitor and assist with the process to form a new All-State Choir. Elise Peterson has served KMEA by providing quality information and expert leadership through this process. With the new Choir will come a new formula that will determine the membership in both Choirs.
- 11. I continue to monitor the progress of the City of Wichita as they discuss updates to Century II Convention Center. Nothing is decided yet, but the plan that seems to be most favored includes renovations and additions to the current facility.
- 12. KMEA will end the year with money in the bank. I was concerned about the additional costs of using Expo Hall, and last summer the Board approved raising fees for the ISW for Exhibitors, All-State fees, and Registration. We will end the fiscal year with a profit, and I may consider adding some funds to investments before the end of the fiscal year. I am not asking for any fee raises for 2018. I will have the 2016-17 Financial Report ready for the Late Summer Board meeting.
- 13. I will have a final fiscal report on the KMR by the Board meeting. This report comes at the end of the first year of using sponsors rather than advertisers. Steve Oare, Bob Lee, and Troy Johnson have worked diligently this past year to work within the web based format and manage sponsorships.
- 14. As reported to you, I spent a year researching other Community Foundations in Kansas. The Greater Salina Community Foundation, where the KMEA Fund is housed, had provided poor service and late financial reports for nearly two years. During that time, there was a change in most of the personnel who work for the GSCF, including the Executive Director and the Financial Manager. Gayle McMillen and I met with Bill Grevas, the new Executive Director. I informed the GSCF that we would continue with them for this past fiscal year to assess their level of service. At this point, I have decided to maintain the KMEA Fund with GSCF. Fund growth has done well, and reports have been more timely.



- 15. KMEA Board members, District leadership, and Affiliate Presidents may remember that KMEA decided to purchase liability insurance through NAfME. This insurance covers any lawsuits brought against leaders for decisions made as part of Board service. This is a gift KMEA is giving to the District and Affiliate Boards. Any person who is elected to the Boards and is a voting member is covered. The billing procedure has changed recently KMEA will have to pay NAfME for our portion of the coverage. Originally, we were to pay directly to the Insurer. NAfME told me last fall that the bill would be coming from them and it has not arrived yet. As soon as this insurance is in effect, I will notify all KMEA Board members and President of our District and Affiliates. I also hope to get a copy of the policy to review and share with leaders.
- 16. KMEA has decided again this year to not raise our portion of the membership dues. NAfME will raise their portion of the dues based on the national GNP.
- 17. I will be attending NAfME National Assembly in Washington, D.C. in late June. I will also attend the Southwestern Division meeting this fall.
- 18. We are drawing to the close of a 5-year process to split the Northeast District into two Districts. (The actual work began several years before a plan was adopted by the KMEA Board to split the District.) This plan has been named by NAfME as a model for other states who alter their District structure. On March 1, 2018, the current Northeast District process will cease to exist, replaced by the new Northeast and East Central Districts. The KMEA Board will increase from 10 to 11 voting members. The final Northeast President, Elise Peterson, will preside over the last Northeast District convention in December. In December 2018, the two new Districts will host their first conventions. Many people have invested countless hours in the process of splitting the NE District. Chad Coughlin has led the entire process, joined by Damian Johnson in the last several years. Two District Split Committees have met to guide the process. Elise Peterson, the NE District President, and Cliff Manning, the NE District Executive Director, have provided leadership throughout the transition. Boards are now in place for the new Districts. On March 1, Justin Love will be first President and Matt Bradford will be the first Executive Director of the Northeast District; Will Cooper will be the first President and Mike Jones will be the first Executive Director of the new East Central District. I will bring a plan to the KMEA Board at the July Board meeting to vote on the final step in this process – how the money held by the current NE District will be split into the accounts of the new Districts. The KMEA Board will also be asked to approve candidates for President-Elect at the meeting in July. These candidates will go before their District memberships for vote in November and December. With the approval of the Executive Committee, the KMEA state level purchased new computers for each of the new Executive Directors.


- 19. The District Executives will meet during the Late Summer Board meeting. We will have books reviewed for the State and the Districts after the fiscal year ends on June 30. We are in the middle of a project taking 1.5 years to update, revise, and or write the District and State bylaws. I am in the process of reviewing bylaws for three of our Districts. By the July Board meeting, all Districts (including our two new Districts) will have updated bylaws ready for approval in the fall by their District memberships. At the July Board meeting, the KMEA Board will be asked to approve the new Northeast and East Central District bylaws since they don't have functioning Boards until March 1, 2018.
- 20. Voting members of the KMEA Board will be asked to sign both the Conflict of Interest and Whistleblowers Policy forms at the June Board meeting. These forms keep us in compliance with IRS regulations.
- 21. The project continues to scan historical documents onto our website, including Board meeting minutes back to 1946, all of our ISW Schedule booklets, and all of our All-State Concert programs. I have hired a student to continue scanning ISW documents this summer. Once we finish these documents, the plan is to scan all *Kansas Music Review* magazines dating back to 1946 onto the website.
- 22. I continue to implement the Document Retention Policy approved by KMEA.
- 23. I have completed the usual organizational activities, such as managing the financial accounts, paying bills, negotiating contracts, preparing for meetings (including this Board meeting), working with the IRS and our account manager, completing IRS forms for vendors, working with NAfME staff and leaders, and managing the KMEA staff, among other activities. Some new and replacement technology has been purchased during the current fiscal year.
- 24. We have wonderful KMEA employees who work for minimal salaries and dedicate countless hours to KMEA. Please thank the following KMEA employees when you have the chance.

The *KMR* is settling in to its new format. In September, we introduced a complete revision of the *KMR*. We a now a fully online journal that can be updated at any time that can accommodate smartphones and tablets.

Since the initiation of the new format, we have published 65 posts. This is a rate of over four posts per month.

As I reflect on the past year, I have arrived at the following goals:

- So far, only three of the sponsors have taken advantage of the opportunity to post sponsored articles. We will contact them to remind them of the multiple opportunities to have to get their name out to our readers.
- Our entries from our board members and affiliates have been inconsistent. I had a plan for publishing but didn't follow through. We will re-establish this plan and work toward sending out reminders on a regular basis.
- The idea of focus issues worked well when we were in an issue-based format. I have yet to figure out how this would work in our current format. I would like input from the board in this regard. Do you see a need for focus areas and is there a way in which you want this communicated?
- I found a great resource in soliciting articles from presenters at the national NAfME conference. I will continue to do so this year. These presenters are often young professors in need of publication and are willing to include video.

Readership: Troy maintains monthly analytics of visitors to the *KMR* site. We see a spike in readership after each monthly email blast. We have settled on sending out the e-blast on the  $1^{st}$  of each month. My plan is to start including other state journal editors and directors in future email blasts.

We still desire to publish articles from KMEA members. I presented a lightly attended clinic on publishing material through the *KMR* with the hope of growing a new set of home-grown authors. I also requested that all board members contact me regarding especially good ISW presentations and got no input. However, I did get input from my own students and solicited two articles as a result.

I presented our journal plan at the editors meeting at the NEB meeting in Washington DC last June and will follow up with them next month. We received a great deal of interest from participants at the time.

With the restructuring of the advertising to sponsorships we have 23 sponsors. Those 23 sponsors will provide \$7,800 of financial support of the *Review* for the 2016-2017 academic year. To date we have 2 sponsors that are unpaid for \$800.00.

There have been 3 sponsors that have used the monthly rate.

Those 23 sponsors have had 35 ad images displayed in the *Review*. There have been only 7 of the 23 that have had more than one image posted. I would like to see that increased. As sponsors become more aware of the value of being current with their information in the ad images, this may increase.

With those sponsorships comes the opportunity to put Articles on the Sponsored Article page. Several have taken advantage of that opportunity. With ongoing contact we hope that those will increase.

I hope we will get more sponsors to participate in the opportunities that come with the sponsorship.

#### **On-Site Registration**

The movement of the registration kiosk table into Expo Hall was mostly successful. The location was directly below a C-II wireless access point, which we used for most of our network connections. I had brought a network router to provide wireless service for our area, but had not had a chance to test it with the full complement of laptops due to lack of space at home. C-II's network manager, John Hale, was very attentive to our setup and we were very well taken care of. We did not experience any connectivity issues. Network speed was excellent throughout ISW.

#### **Membership Data**

I recently participated in a conference call with NAfME and their new CRM vendor Altai Systems. There will be changes in how we access our membership data for migration to the KMEA web server. For now, Altai is working to learn how each state operates before coming up with new processes. There is not yet a definite timeline for changes.

The 2017 In-Service Workshop attracted 100 exhibitors. Of that total about 10 were new exhibitors. I do think the exhibitors were pleased with the experience in the Expo Hall from a standpoint of both attendee traffic and the location to the rest of the workshop in general.

I think we will see some more creativity in the individual booth set-up next year. Since their space is a "blank canvas" I am anxious to see what exhibitors will do to make their spaces stand out.

I am making the following recommendations for next year:

- 1. Re-design the Expo Hall set-up including the registration, exhibits and concession area.
- 2. Continue the process of assigning booths by paid date.
- 3. Drop the lowest price tier (Select) and continue with two tier (Premier & Prime) pricing. Only 7 of the Select spaces were purchased.

The first issue is seeing if it is possible to raise the number of string entries for solo and ensemble festivals. The other is looking into the possibility of adjusting some dates in the future to allow more current string teachers the possibility of judging. The committee will have some survey information to look through at the next meeting to help in our discussion.

Orff-Schulwerk is a creative approach to teaching and learning music through speaking, singing, playing instruments, and moving. Created by composers Carl Orff and Gunild Keetman, the Schulwerk is an exciting way to teach and learn music.

Members in the organization receive discounted workshop registrations to the events. KOC workshops are open to anyone interested in learning about the Orff-Schulwerk model. KOC is proud to offer three workshops each year to allow teachers to expand and practice their knowledge. Workshops for 2017 include a six-hour session which was held in January with Corbin Trimble at Manhattan.
