I am pleased to report the following activity.

- 1. The arrangements for the 2019 ISW have been completed. Venues have been booked, scheduled and paid. Contracts for various artists and arrangements have been signed. Arrangements for performing groups and student musicians have been finalized. All food service and logistical arrangements have been made. The KMEA employees have completed preparations for their work during the ISW. I will soon pay the deposit on Century II for the 2021 ISW, and I will soon sign convention contracts at the Hyatt Regency (2022) and Broadview Drury (2020). It usually requires about three weeks to meet with ISW providers and pay bills after the convention closes.
- 2. I am in the process of completing booking for the 2020 and 2021 All-State conductors. I hope to finalize this early in the spring. I will begin work with the new All-State Assistant Chairs to complete the booking conductors for 2022 and 2023.
- 3. Since moving to Expo Hall for the Exhibits in 2017, we continue to update and improve the venue. Dana Hamant is again this year expanding the seating area for members to visit within the Exhibits. As of this year, the KMEA employees feel that the set-up we are using in Expo is set, and we will be ordering new signage for On-Site Registration and the Exhibits for the 2020 convention.
- 4. I again request that KMEA Board members walk through the Exhibits and personally thank those who have rented booth space. If you have a red Board ribbon, this is an important part of your responsibilities. The ISW would not exist were it not for fees paid by our Exhibitors.
- 5. With the election of a new KMEA President-Elect, I will be spending time training this new officer. The change of KMEA Presidents also brings new beginning and lauds for jobs well done. We say goodbye to Vice President Martha Gabel, and President Gretchen Bixler assumes the Vice Presidency. These are remarkable women who have led our organization with hard work, loyalty, a great concern for our members and their students. Both leave behind legacies of a KMEA that looks different than when they took office. Both also created aggressive Strategic Plans and executed those plans successfully for two years. I am excited about my new boss, Gae Phillips, as she assumes the Presidency of this great organization. This means that the Board will be adopting a new Strategic Plan in June.
- 6. I STRONGLY encourage all Districts and Affiliate Members to send their leadership to the Leadership Camp in June. KMEA will pay for members of the KMEA Board to attend (mileage and food). KMEA will also provide lunch for everyone in attendance. Thus, the Districts and Affiliate Organizations would only need to pay mileage for their leaders to attend (carpooling will save money). This event, over several years, will strengthen our organization and raise-up new and informed leaders.



- 7. KMEA purchases liability insurance through NAfME for Board members, District leadership, and Affiliate Boards. This insurance covers any lawsuits brought against leaders for decisions made as part of Board service. This is a gift KMEA offers to the District and Affiliate Boards. Any person who is elected to the Boards and is a voting member is covered.
- 8. Last year, we offered receptions for the families of two of our All-State ensembles on Saturday of the ISW the Orchestra and the 1234A Band. This year, we have added a third group, the 56A Band. Ticket have been available for purchase (\$1) to attend, and cookies and punch will be available. Families attending this event will have early seating access to Concert Hall for the concert. This will be an important advocacy activity for KMEA these are people who already believe in music in the lives of Kansas students and can speak to this issue in their communities. Vice President Martha Gabel presides at the receptions. Families will hear from their student's ensemble conductor, and Marcia Neel will provide some advocacy steps that parents can use in their local schools to support music education.
- 9. After months of discussion by the Board and the KMEA employees, the ISW All-State performance and rehearsal schedules for the 2019 ISW have changed. Three ensembles the high school Mixed Choir and the new high school Treble Choir, along with the 56A Band, will rehearse at the First United Methodist Church. The two high school choirs will perform on a single concert on Saturday at 11:00 AM in Convention Hall. The Jazz Band performs a little earlier, and the other ensembles performing in Concert Hall on Saturday have had their starting times moved to 2-hour intervals, with each ensemble having a Dress Rehearsal an hour before their concert. This also gives more time to clear Concert Hall between events, and more time for audiences to be seated.
- 10. There has not been word for some time on the updates to Century II Convention Center. A series of meetings were held to gather information. So far, the plans I have seen will positively impact the KMEA ISW. The City of Wichita is also razing Lawrence Dumont Stadium and will build a new stadium on the same property. There is information that the city is buying the Metropolitan Baptist Church, and that the church will be rebuilt nearby. We had planned to use Metro Church this year, but some renovations were not completed thus, the Kansas Intercollegiate Band is rehearsing at Friends University. Metro Church had committed to hosting the Kansas Intercollegiate Orchestra in 2020, but that may not be possible if the church is moved.
- 11. All the end-of-calendar-year taxes for the IRS and the State of Kansas were completed by the January 31 deadline. This included tax reports, 1099s, and W2s for employees, independent contractors, and clinicians at the State and District levels. Conflict of Interest Forms and Whistleblower Forms are being signed annually by all voting members of KMEA Boards at the District and State levels.



- 12. I am working on several long-range projects for KMEA. We are about halfway through the project to scan copies of past ISW Schedule Programs and All-State Concert Programs onto the website. A long-range goal is to scan the hard copies of the *Kansas Music Review* journals from about 1940-2011 to the website. I continue the shredding of records according to the KMEA Records Retention Policy.
- 13. The organization of the KMEA District Executive Directors continues to function. We will begin on several new projects in the summer to update policies, including record retention, and emergency contingency plans.
- 14. I want to extend a special thank-you to Kevin Findley for his service for many years as the KMEA Local Arrangements Manager. Kevin accomplishes remarkable results with accuracy and positive communications with our members. It would be hard to help even our Board members understand all that Kevin Findley accomplishes for the ISW. We will miss Kevin. Having said that, I am excited to announce that I have hired Todd Hollis of Augusta High School to replace Kevin following this convention. Todd has been shadowing Kevin for the past 9 months.
- 15. I also want to thank Past President Mike Quilling as he steps down as the KMEA Government Relations Chair and assumes his new position as NAfME Southwestern Division President. Kelly Knedler is assuming these responsibilities and combining them with his Advocacy work, and he and Mike have been working together during the transition. KMEA continues to fund advocacy for music education with our legislators. Kelly Knedler is making plans for our fifth Music Day at the Capitol in Topeka. This has become an important project as we make a presence for KMEA and a stand for music education in our schools at the Capitol in Topeka. C-NAfME students will again be assisting with the day, and breakfast will be provided for all legislators and their office staff. The Executive Council and Kelly Knedler will visit with legislators in their offices throughout the day. KMEA leaders will again visit the offices of our four Congress members and our two Senators in Washington, D.C., in June to advocate for national issues related to music education, including funding for the ESSA.
- 16. As many know, I am retiring from teaching in May, including 42 years of teaching (30 of which have been at Friends University). I will continue my work with KMEA, and I am excited that I will be able to focus on this organization and move us forward as I have more time.



17. We have the most wonderful employees working on behalf of KMEA. Please take a moment to thank all the KMEA employees when you have a chance. They are paid a minimal amount for their work, and they provide excellent service to our organization. I live in constant fear that they will grow weary and leave their posts!



We are currently in the third year of the new *KMR* format. We are now a fully online journal that can be updated at any time and can accommodate smartphones and tablets.

We have begun to send out Tweets on Twitter with each posting of a major article as well as monthly e-blasts of "What's New in the Kansas Music Review." We register a bump in readership with each e-blast.

Our Kansas advisory board members have been asked to submit 1-2 articles per year based on the calendar we have created. I send out reminders two months and one month before the articles are due. Most board members have submitted their articles, though we still have not reached 100% participation.

This year, we had difficulty in receiving annual reports from all district presidents. I will be more deliberate in the future about reminding presidents to submit their reports in December along with pictures of the annual award winners for the district.

We have a reciprocal agreement among all state MEA's that allows us to reprint articles from each states' journals. We have posted an average of one reprint per month.

We still desire to publish articles from KMEA members, but I need suggestions for potential authors. Last year, I requested that board members contact presenters at the 2018 ISW to write articles or create videos related to their sessions and received one suggestion. I hope to receive more suggestions this year so that we can create more home-grown articles. I am willing to help potential authors turn their presentations into posts.

Readership remains a concern, especially regarding the development of our sponsor base. We feel we must once again look at our sponsorship packages as well as how we market the journal.

### **Systems Upgrades**

The following upgrades were made to our various registration and manager systems this year:

- **All-State Manager** NAfME membership enforcement for state KMEA, as well as all districts. Built new reporting screens which create data tables for All-State chair reports (examples are in this board book).
- **Migration to Members Site** –District registration forms were moved into the KMEA Members site for the 2018-19 school year. The All-State Manager was not moved due to time constraints. This will be looked at for 2019-20.
- ISW Registration Manager continued to add more functions to ease the workload for managing the registration process, including improvement in the payment notification process. Our system now records an ISW payment received within 10 seconds of the transaction having been completed by the user. We always encourage members to complete online ISW pre-registration as early as possible, which reduces management time considerably.
- Executive Manager 2019 is the 3<sup>rd</sup> year for the ISW Schedule Builder in the Executive Manager system. The schedule builder generates a finished template of the full schedule for the printed conference program. The schedule database also feeds into the ISW site and Hall of Fame display screens in various locations around Century II.

### Hosting

In January 2016 we moved the KMEA account to Virtual Private Server (VPS) hosting within the same data center. The previous server was shared with about 100 other websites. On VPS, we are the only account thus all the resources of that server are dedicated to our processes resulting in improved performance for our sites.

Disk space usage is currently at 13% of capacity of our current VPS server, a reduction of 1.3% since this time one year ago. Several folders of archived mp3 files from old choral practice track lists at state and district levels were removed, which freed up drive space.

The state KMEA hosting account includes the websites for all KMEA districts, along with the Kansas Music Review, ISW website, and all Systems processes such as ISW registration. I do not anticipate a need to expand hosting capacity or bandwidth requirements in the foreseeable future.





Visitor Sessions (Feb. 2017 – Jan. 2018)











USA Visitor Locations (Feb. 2018 – Jan. 2019)



Kansas Visitor Locations (Feb. 2018 – Jan. 2019)






#### **Kansas Music Review**



### KMR Visitor Sessions (Feb. 2016 – Jan. 2018)




The following graphs represents the past two years for a direct comparison. The scale has increased due to much higher traffic this past year.

Feb. 2017 – Jan. 2018 (6,733 sessions – 12,645 pages)




Feb. 2018 – Jan. 2019 (11,101 sessions – 17,233 pages)






## KMR USA Visitor Locations (Feb. 2018 – Jan. 2019)

#### **KMR Advertising**

The advertising module in the new KMR does not have defined terms as we did when the KMR had "issues." The new version allows for overlapping ad displays with variable term dates. A query for ads which ended their display terms in 2018 found the following results, which indicate an increase in display totals over 2017. However, it also shows a drop in the number of clicks, which is what advertisers really want. An optimal click-thru rate would be in the 3-5% range.

She has served as President of the Southwest Division of the College Band Director's National Association as well as President of the Big 12 Band Director's Association. ## All-State Jazz Band Gary Leopold

The 2019 KMEA **All-State Jazz** ensemble auditions were organized and run by Gary Leopold, KMEA State Jazz Chair (Wichita High School Northwest). There was no Assistant Chair this year (Todd Hollis, who was Assistant Chair, accepted a position with KMEA to take over the equipment-moving/facilities position and will be shadowing Kevin Findley at this year's ISW). State Jazz Auditions were held Saturday, January 5 at Lakewood Middle School, Salina, KS. There were 132 scheduled auditions and 13 cancellations (auditions that didn't show up) this year. There were 125 auditions in 2018, and 115 in 2019. The 19-member, 2019 All State Jazz Band has the following representations: School size: 4A – 1 student, 5A – 8 students, 6A – 10 students. Grades: 10<sup>th</sup> grade - 4 students, 11<sup>th</sup> grade – 8 students, 12<sup>th</sup> grade – 7 students. KMEA districts represented are: NE – 3 students, SC – 6 students, SC – 6 students, NC – 3 students. Jazz judges were involved with four audition rooms: saxophone, trombone, trumpet, and rhythm section. A lead judge in each room was responsible for securing four judges plus door monitor. Audition times were assigned and given to students at the registration table (names, times, room numbers, and respective schools were printed on mailing labels).

This year's clinician is Dr. Allen Carter, Professor of Music at Minnesota State University Moorhead, where he coordinates the music theory curriculum and where he created their new undergraduate degree in Commercial Music. Dr. Carter is a Kansas native, having grown up in Ellinwood, KS, and holds degrees from Kansas State University and the University of Northern Colorado.

As a drummer/percussionist, Dr. Carter has performed with the Kansas City Philharmonic Orchestra, the Joffrey Ballet, Les Brown's Band of Renown, the Tommy Dorsey, Harry James, and Glenn Miller tribute (ghost) bands, Pat Longo's Big Band, Steve Speigl's Big Band and numerous other Los Angeles area big bands. He has worked with such vocalists as Nancy Wilson, Johnny Mathis, Marilyn Maye, Anita O'Day, Ray Charles, Melissa Manchester, Harry Connick Jr., Maureen McGovern, and Glen Campbell and has been involved in numerous recording sessions for records, films, and commercials.

Dr. Carter's work as a composer/arranger includes CBS Television's Motown Records specials, the cable television series Humonos, the Tournament of Roses Parade, the Miss America pageant, commercials, and documentaries for the department of Health, Education, and Welfare. In addition, he has written extensively for instrumental and vocal jazz groups at all levels.

Dr. Carter has recorded two critically acclaimed CDs as band leader; "Gifts" and "Time On My Hands" featuring some of the finest studio/jazz musicians in Los Angeles playing his compositions and arrangements

## All-State Orchestra Summer Miller

Auditions for the 2019 All-State Orchestra were held Saturday, January 5, 2019, at Lakewood Middle School. Judy Erpelding, Assistant Chair, recruited a wonderful group of teachers to hear and score the auditions, monitor rooms, tabulate scores, and guide students to their respective audition rooms.

The "Year One" audition materials (2019, 2022, and 2025) were used. Paper and pencil were used to tabulate scores in the audition rooms and scores were tabulated via a spreadsheet created by David Ohse. Orchestra auditions were completed by 3:00 PM. A "Year Four" cycle of audition material is being developed to be used as 9<sup>th</sup> graders are being allowed to audition for State Ensembles starting in 2019-20.

The shortened cello excerpts were used this year – in response to the concern of them being too lengthy. The overall feedback was very positive. The uniform scales were also used this year, again with positive feedback.

In terms of dividing the violinists into two sections, the four students with the highest score were placed in Violin 1 and the next four students in Violin 2. After the initial eight, the violin students were placed in the two sections in an alternating fashion, two by two. There are 21 first violins due to a tie in scoring.

The chart below shows the number of students who registered for auditions compared to the number of auditions that took place and the number of students accepted into the All-State orchestra. In all sections, roughly 1/3 of those who auditioned were accepted. The orchestra was kept at the same size as previous years due to concerns about the stage capacity by the fire marshal. Complaints voiced were much fewer than previous years.

The numbers of auditions were slightly up this year, due to the creation of two additional district orchestras in the NE and EC districts. The difference between the 2018 and 2019 audition numbers are indicated in the chart. We expect another increase in auditions for the 2020 orchestra, due to the allowance of 9<sup>th</sup> grade auditions next year.

The clinician for the 2019 KMEA All-State Mixed Choir is **Kevin Fenton.** He is professor of choral conducting and ensembles, and director of the FSU University Singers and the Chamber Choir.

A champion of new music, Dr. Fenton has conducted over thirty premiere performances—most recently Skip Stradtman's "Look Who Gathers at Christ's Table" and "Amazing Grace" (2015); Troy Robertson's "In Meeting We are Blessed" (2015) and "This Mystery" (2012); Eric Barnum's "In Paradisum" (2010); Sydney Guillame's "Au-Déla du Chagrin" (2010); Clifton Callender's "Reasons to Learn to Sing" (2010); and "The Soul's Passing" (2008) by Dominick DiOrio.

Dr. Fenton has conducted choirs in 35 states, including twenty-six all-state choirs and ACDA Divisional Honor Choirs. Internationally, Kevin conducted the Beijing International Choral Festival Choir with China's People's Liberation Orchestra and the Dublin International Choral Festival for Music Celebrations International. He taught choral conducting and conducting pedagogy at the Kenya Conservatory of Music as a part of the Fulbright Scholar program and at the National Youth Choir Symposium in South Africa.

Dr. Fenton has taught graduate and undergraduate courses in choral literature and choral conducting at Florida State University since 2000, and his textbook Foundations of Choral Conducting is used in beginning conducting classes throughout the country.

He is a recipient of the Florida State University Teaching Award for Excellence, the Delta Omicron Music Professor of the Year award, and the Wayne Hugoboom Distinguished Florida Service Award. Additionally, Dr. Fenton is the Artistic Director of the Festival Singers of Florida and a founder of the AVoice4Peace initiative (AVoice4Peace.org).

Mr. Leck is the founder and Conductor Laureate of the Indianapolis Children's Choir which he served as artistic director for 30 year. He is a world-renowned choral clinician and is well known as a specialist in young voices. I have seen Mr. Leck in action and I know our children will benefit from his artistry and expertise.

Our audition numbers grew to 810 entries, making 2019 our biggest year! The 160 voice choir with 10 alternates is comprised from students in 62 schools throughout Kansas. Selectee numbers by school range from 1 to 10 students with an average membership of 3-4 students per school. Since the Elementary Choir's beginning 3 years ago, the audition process has gone smooth. We updated to Festival Scores 2 years ago and love its easily accessible features for both the system administrators, choir chairs and teachers.

The auditions rolled in, however, seeking and securing high quality judges for this large number of entries always proves to be a challenge. This year we secured 10 judges. They listened to an equal number of entries. Each entry was given 2 scores and we used the average to determine our final list. The past 2 years we worked to refine a detailed rubric to guide all judges in the same basic direction. This proved helpful. Most importantly, we believe giving 2 scores per entry produces the most accurate end result.

Disqualifications included not playing the starting pitch on the recording, not beginning on the starting pitch and additional voices heard on the recording. In several instances it was evident that the starting pitch was spliced in. This brings us to the question: is there a way that submitting teachers could be notified of the disqualification so that they may learn from the mistake?

We look forward to an inspiring concert on Thursday, February 21 at 5:45 PM. The diverse music Mr. Leck selected for the choir has challenged our young musicians. I anxiously await the final product and invite everyone to attend

Assistant Elementary Choir Chair, Cindy Blagg, has been working diligently every step of the way. I am confident she will be a strong leader and improve upon what we have accomplished with the Elementary All-State Choir in its first four years.

The KMEA Fund is in its 10th year. Our current market value is \$124,526.20 as of February 2, 2019, down \$745.02 from this time last year. The 2018 market was volatile with our fund swinging over 10% in the 4th quarter alone. This will even out in the long run, but it will be adventurous on occasion. The KMEA Fund currently has the potential to award \$4,105. Our five state-wide KMEA scholarships total \$2,500. The KMEA Executive Committee will be establishing a task force to develop an application process for future grants and/or scholarships. In the meantime, we are working to keep growing.

We participated in the Greater Salina Community Foundation's 2018 "Match Madness" and did well! We had 13 families donate \$3,042.62 and had it matched with \$1,156.19 for a total additional \$4,198.81 to our Fund total. Realizing a 38% immediate bump to our donations is very special. The gifts ranged from \$25 and up, each gift contributing to the total.

I would like to offer a challenge to every person that is reading this report. The Greater Salina Community Foundation is having its 2019 "Match Madness" on March 21 where they will match up to 50% of all money donated that day. I will be representing the KMEA Fund. Here's how it works - you give me a check made out to "GSCF" with "KMEA Fund" in the memo line. It can be any amount from \$1 up to \$2,000. I will deliver all the collected checks on March 21 for the matching funds to apply. It's as simple as that! There is also an option to donate online on March 21 by going to "MatchMadnessGSCF.org" and following the directions. Be sure and designate Kansas Music Educators Association as the recipient.

The KMEA Fund is a forward-thinking idea that will assist our organization in serving the music students in Kansas. ## The Kansas Music Educators Association Turned 85 years old in November.

On November 2, 1934 a meeting of music teachers was called by David T. Lawson of Topeka. The meeting was during the Kansas State Teachers Association meeting in Topeka. At the meeting, the Kansas State High School Music Association was formed. David T. Lawson was elected president. There were 38 teachers at the meeting, with 19 paying dues to join the organization. A skeleton constitution was created and passed. The first meeting of the organization was held at Topeka High School on December 28, 1934. The constitution was expanded and a plan was written and passed to create 8 districts across the state. Dues were set at 2 dollars per year.

## The first KMEA Festival Band performed 60 years ago this month.

The first KMEA Festival Band performed at the SWMENC Convention in Wichita, Kansas on February 22-25, 1959. Fredrick Fennell was the conductor.

## The first Music in Our School Week was 45 years ago this month.

Governor Robert Docking proclaimed the week of February 17-23, 1974 Music Education Week in Kansas. This was the first such declaration in Kansas.

## The first Outstanding Administrator of the Year Award was given by KMEA 30 years ago.

The first Outstanding Administrator of the Year award was given by KMEA at the convention in Wichita on February 23-25, 1989. Don Pierce of Seaman High School was the first recipient.

## The In-Service Workshop expanded to Thursday 20 years ago.

The KMEA In-Service Workshop was expanded to include events on Thursdays in 1999. The Festival Groups began rehearsals 1:30 PM instead of the evening. The opening session was moved to Thursday afternoon and an evening concert was added.

## The KMEA President-Elect Strategic Plan began 20 years ago.

KMEA began organizing a strategic plan to plan and chart future goals. Gayle McMillen chaired the committee.

## Kansans Can School Redesign Project

In support of Kansas' vision for education, the Kansas State Department of Education is accepting applications for school districts to participate in the APOLLO Kansans Can School Redesign Project.

Districts selected for the **APOLLO** Project may designate one or more elementary and/or secondary school - to be redesigned around the five outcomes established by the Kansas State Board of Education, the five elements identified as defining a successful Kansas high school graduate and what Kansans told us they wanted schools to look like in the future.

These districts will serve as demonstration sites for other Kansas districts.

#### Vision:

Kansas leads the world in the success of each student.

### **Five outcomes:**

- Social-emotional growth
- Kindergarten readiness
- Individual Plan of Study (IPS)
- High school graduation
- Postsecondary success

### **Definition of a successful high school graduate:**

A successful Kansas high school graduate has the academic preparation, cognitive preparation, technical skills, employability skills and civic engagement to be successful in postsecondary education, in the attainment of an industry-recognized certification or in the workforce, without the need for remediation.

### To be considered for the Kansans Can School Redesign Project, districts must:

- Be able and willing to completely redesign one elementary and/or one secondary school around the vision, outcomes and definition of a successful high school graduate.
- Each district and school must provide evidence and have approval by their school board with a vote; faculty with a vote of 80 percent in each building being redesigned; and support from the local Kansas National Education Association (KNEA) or other professional organization.



- Be able and willing to launch a new school design in the 2020-2021 school year.
- Be willing to serve as a demonstration school/district for others in Kansas to study, learn and visit.

For planning purposes, if your school/district is selected to be part of the Apollo mission, you can expect the following during the Plan Year:

- 1. Weekly staff member time devoted to working on redesign. This includes both the biweekly, all-day regional workshops the school redesign team attends, as well as work done by the rest of the staff during the weeks between the workshops.
- 2. Costs for substitutes and transportation for staff attending the biweekly regional workshops and also for staff to visit other Redesign demonstration schools in Kansas.

Retired teacher transition to adjudicators and request for help to increase our adjudicator pool with outstanding and qualified persons. Email in May (David Will, KMEA Retirement Chair)



KSHSAA continues to sponsor 5 Regional Piano festivals with State at Wichita State University. We had 301 students participate which was down 32 students from 2018.

We also sponsor 17 Solo and Small Ensemble Regional Festivals, 15 State Large Group Festivals (added an Olathe Large Group Festival site for 2019) and 6 State Solo and Small Ensemble Festivals in April. These festivals require a total of 300+ adjudicators. This is the 12th year that we are completely web based concerning music adjudication updates and assignments. Priority is given to those adjudicators who update their files in August and who take the KSHSAA/KMEA online adjudicator training. As you hear of excellent music teachers who retire please encourage them to contact me and apply to become an adjudicator for our state. Adjudicators are currently paid \$200.00 per full day plus expenses and I have made a proposal to raise adjudicator pay for 2019-20.

We Really Need Your HELP! We continue to have a shortage of <u>orchestra and vocal adjudicators</u>. In the band area, woodwind & percussion adjudicator assignments are the toughest to fill as we have a greater number of student entries in this area. We are finding that when teachers retire they are less likely to put their name in our judging pool than in the past.

The National Federation of High Schools (NFHS) is doing a great job of reaching out to high school music teachers and music adjudicators in our nation. I want to make you aware of five free online music courses that are available at <a href="https://www.nfhslearn.com">www.nfhslearn.com</a>. James Weaver, NFHS Director of Performing Arts is a former orchestra director and South Dakota High School Activities Association Assistant Executive Director of Fine Arts. He has been instrumental in writing these music specific courses. The newest course is entitled *Band Safety*. Dr. Weaver will be presenting two sessions this year: Friday, February 22 at 9:00 am in Room 201 – "Music Copyrights" and Friday, February 22 at 2:45 pm in Room 208 – "Working with Your Administration and Advocating for your Music Program"

## **Understanding Copyright and Compliance**

This helpful course explains what copyright means and when there may be exceptions. It discusses Fair Use, when a piece of music might be in the Public Domain, copyright infringement penalties and much more. This unique course has been designed for your specific needs whether you are a Music Teacher, Spirit Coach or School Administrator. NAfME was one the partners with the NFHS to help and endorse this course.

### **Interscholastic Music Event Management**

Interscholastic Music Event Management is designed to provide an overview of management and best practices for hosting music events. As a contest, festival, or honor group manager, you serve a crucial role in creating a positive and efficient environment for student success. The skills taught in this course introduce and reinforce time tested guidelines and techniques that music event managers with any level of hosting experience can utilize to efficiently and successfully manage interscholastic music events.



### **Introduction to Interscholastic Music**

Designed to provide an overview of the best practices in the music classroom and interscholastic music competitions.

The skills taught in this course introduce and reinforce time tested guidelines and techniques that music educators of any level of proficiency can use in directing music programs across the United States. Although this course is useful at any point of a music teacher's career, this course is best fit for music educators in their beginning years.

Upon completion of this course, you will have the skills and knowledge necessary to develop the strategies and tools needed to be successful in the music classroom.

## **Introduction to Music Adjudication**

Designed to provide an overview of music adjudication and the best practices for many adjudicating situations. The skills taught in this course introduce and reinforce time tested guidelines and techniques that adjudicators of any level of proficiency have successfully used to adjudicate interscholastic solo and small ensemble music festivals.

### **Student Mental Health and Suicide Prevention**

It's widely known that stress, anxiety and depression create challenges for both society and individuals, including interscholastic students. And severe conditions can lead to the worst outcomes, such as suicide. The NFHS is proud to bring you this course on Student Mental Health and Suicide Prevention in response to this reality. With a focus on wellness, including both physical and psychological, this course highlights causes, strategies and provides helpful resources. For students, their peers and anyone responsible for their care and well-being, take the course Student Mental Health and Suicide Prevention.

### **Protecting Students from Abuse**

Abusive behaviors and misconduct do not belong within athletic and activity programs. To assist in creating an enjoyable and safe environment for students, the U.S. Center for SafeSport, in collaboration with the NFHS, has developed "Protecting Students from Abuse." The course presents definitions of several types of abusive behaviors and misconduct, the signs and symptoms of abuse, and the ways in which someone can report these behaviors. The course also includes some DOs and DON'Ts for making a report.



Besides these six NFHS courses, the KSHSAA and KMEA strongly recommend that all Kansas music adjudicators view the KSHSAA/KMEA Online Music Adjudicator Training videos. This adjudication training video is divided into two sections, Part 1: The General Adjudicating Philosophy with Rules and Regulations that will provide guidance to the novice adjudicator and also remind the veteran adjudicator of important information. It is divided into three five minute videos. Each video will be followed by a question and answer section that requires 100% accuracy in order to continue. Part 2: Offers hands-on instruction from qualified music adjudicators for Band, Choir, and Orchestra. Each different genre lasts approximately one hour to view. Part 2 videos may be viewed by anyone on the music page of the KSHSAA website at http://www.kshsaa.org/Public/Music/Main.cfm. This is a wonderful opportunity for young directors, more experienced directors and students to find out more about what adjudicators are listening for at Large Group Music Festivals.





# Mentoring, Recruitment, & Retention Janelle Brower, Holly Taylor, Lynn Unruh

Under the direction of President Gretchen Bixler, this year brought many positive changes to the Mentoring program in the quest to find and maintain mentor/mentee lasting and quality relationships.

This year, the KMEA State Mentoring web page was redesigned as well as the district mentoring web-page links. A Mentoring Banner was added to the front page of the KMEA website during the fall to highlight the mentoring program. In addition, Webmaster Troy Johnson added enhancements to the KMEA Systems manager to collect names and contact information for new teachers and mentors. One of the most helpful aspects of Troy's work was that he programmed the KMEA Mentoring Manager to create batch a batch e-mail list for each district. This allowed State and District Mentor chairs to communicate with mentees and mentors easily.

These efforts along with the outreach efforts of Ron Chronister (KMEA Past-President) and Craig Manteuffel (Assistant Executive Director, KSHSAA) resulted in 62 new Kansas Music Educators signing up for the KMEA mentoring program and 58 experienced teachers joining the mentoring network. Mentor teachers volunteered to serve in a variety of capacities including serving as one-to-one mentors for 1st and 2nd year teachers, supporting experienced teachers who are new to Kansas, attending district mentoring meetings and developing resources for new music educators. State Co-chairs plan to continue to reach out to these mentors to support our new teachers.

State Co-chairs, Lynn Unruh, Holly Taylor, and Janelle Brower launched fall Mentoring kick-off events in each district. While similar events occurred in a couple of districts in the past, this was the first year that they were held in every district. District Presidents, State Mentoring Co-Chairs, and mentor teachers provided new Kansas Music Educators with important information regarding KMEA and KSHSAA events and gave them the opportunity to make face to face connections with mentor teachers. Beginning Teachers and experienced teachers who are new to Kansas were in attendance. Many thanks to the KMEA Executive Board, District Presidents and District Mentoring Chairs for making these events possible. As a future program enhancement, state mentor co-chairs would like to consider implementing regional mentoring events for the 2019-20 school year.

The New Teacher Luncheon will look a bit different this year as we move to the morning and breakfast. The 15th Annual First year Teacher Breakfast is scheduled for Saturday, February 23 at 8:00 AM with the following speakers: KMEA President Gretchen Bixler and Gae Phillips, President-Elect, Vice President Martha Gabel, Craig Manteuffel Assistant Executive Director of the Kansas State High School Activities Association, John Taylor, KMEA Executive Director, Michael Raiber, Southwestern Division President and representing Kansas Music Merchants Association, Senseney Music President, Lori Supinie. Thank you to Fruhauf, the Kansas Music Merchants Association and KMEA for their continued support financially of this breakfast. This is a FREE breakfast for every person attending this event.

I submitted a formal proclamation for the Kansas governor to sign. It states the positive effects of music education in our schools and how music is directly related to success in education across curricula. It can be read at the opening session of 2019 KMEA ISW, if desired.



I contacted the national chair of MIOSM and will continue using that resource to help my colleagues throughout Kansas become their own best cheerleader and to draw attention to the need to keep music education in our schools and the benefits derived from that. I submitted an article to the *Kansas Music Review* detailing the resources available on NAfME's website and other ideas to celebrate MIOSM.

This year's MIOSM theme is "ALL MUSIC. ALL PEOPLE." There is a focus on diversity this year for Music in Our Schools Month and it's exciting! They have expanded the offerings this year, with the focus for a more inclusive lesson and enriching elements from a variety of cultures. Plus, this year, in October, they have added a informance element to it with a more casual teaching and sharing process. Parents and community members are able to see learning in action – a process NAfME is calling "Process into Product" – where activities such as composing and rehearsing are being done in a casual atmosphere. People can be involved in the process by asking questions and engaging the presenters in a discussion.

We are encouraging teachers and students to share how music includes all by sharing photos and videos of their celebrations throughout March on social media (Facebook, Twitter, and Instagram) using the hashtag #MIOSM. There also have shareable graphics for social media, along with a custom MIOSM profile picture, and they encourage NAfME members to change their profile pictures on their social networks for the month of March.

## Research Christopher Johnson

Research Posters were put up on Thursday in the foyer above the registration desk. This allowed people to browse through the research offerings all Thursday afternoon and on Friday until the session at 3:00. We were able to feature 19 projects that whole time. While, with this open forum for discussion, we have not been able to devise a method to easily determine how well the actual session on Friday afternoon was attended, it felt like we had a good flow of traffic.

Last year's general session featured four presentations of recent research in music education and the psychology of music. The first presentation featured Philip Payne, Wesley Lewis & Frank McKaskill from the Kansas State University discussing Looking Within: An Investigation of Potential Relationships Between Music Education Majors and Mental Health. The second presentation will featured **Jennifer Potter** from the University of Kansas. Her presentation is titled Classroom Management in Urban Music Classrooms: Preservice Music Teachers' Attitudes and Perceived Preparation. This presentation featured a study that examined the attitudes of preservice music teachers concerning strategies and preparation for classroom management in music classrooms in urban settings. The third presenter was Frederick Burrack from Kansas State University. His presentation, titled Changing the paradigm of measuring student learning in the USA: The National Pilot of the Model Cornerstone Assessments, will described the research methodology implemented to develop, revise, and pilot the recently published Model Cornerstone Assessments for the new National Standards for Music Education. The Final Presentation from the Wichita State University featured Kaitlin Exline, Dr. Elaine Bernstorf, Dr. Steve Oare, Dr. Marlene Schommer-Aikins, & Dr. Carmen Lemoine. Their presentation, titled Music Teacher Beliefs and Classroom Environments: Exploring Informal Learning Practices, discussed a mixed method study that examined alignment among things teachers feel should be happening in their classrooms and what observers will see happening in the room.

This year the general session will feature two presenters. The first is from the University of Oregon and features **Beth Wheeler**. Her study is titled: *The Impact of music instruction through errorless learning on the achievement motivation of students with emotional and behavior disorders:* A pilot study. The purpose of this study was to determine the effectiveness of errorless learning through Orff-based music activities on the achievement motivation of students with emotional and behavioral disorders. Participants (N=27) were primary level students (n=15) and intermediate level students (n=12) in a residential treatment facility for children who have been diagnosed with emotional and behavioral disorders or have suffered childhood trauma such as physical and/or sexual abuse. This study utilized a pretest/posttest design. Positive reinforcement combined with prompting strategies were used to teach musical skills. Data were collected week five and week eleven, and week fifteen after the program was established. The study is currently in the data collection phase.



The second presenter represents Emporia State University. **Gaile Stevens** will present her study titled: Social Justice in the United States as represented by Billboard top 100 songs. Dr. Stephens explicates how music with a message of social justice has a long history in the United States. Most popular music song lyrics, starting with spirituals and continuing through early Blues and Jazz, did not contain overt references to opposition against the white-dominated society due to the real danger of persecution. With the social movements of the 1960s, popular music began to address social inequality in lyrics coming through a convergence of folk music, Rock N' Roll, Rhythm and Blues as well as the start of Psychedelic and Counter-culture Rock. The current study is a look at lyrics of each year's Billboard top 100 songs from 2001-2015 in order to determine if the popular social justice music of the 1960's is now replaced by more simple lyrics with a catchy beat for dancing. Five themes emerged from the lyrics of analyzed songs: Resilience, Empowerment, Marginalization, Disillusionment, and Violence. This study is beneficial for professors and instructors in the classroom when addressing issues around racism, sexism, classism, and other social injustices.

Clearly this session will feature some of the finest work in music education currently available. It will occur on Friday, February 22 from 12:55-1:45 PM in Room 205 of Century II.

The Research Poster Session Meet the Authors session is scheduled for 3:00-3:55pm on Friday.

The 2018 Kansas Consortium of Music Teacher Educator Professors & Students (KCOMTEPS) met September 28 – October 1, 2018 at Senseney Music the first day and the second day at the Marcus Welcome Center on the Wichita State University campus. The featured clinician for the conference was Dr. Anne Marie Stanley, Associate Professor and Chair of Music Education at Louisiana State University. Dr. Stanley teaches general music methods courses and graduate research. In addition to publishing her research in many publications, she also active as a presenter and clinician for school districts and state conferences on general music ideas, motivation, collaboration, and teacher learning.

Dr. Stanley presented the general session on day one, *Engage your Core! Using Core Reflection for Immediate Improvements in Music Teaching and Learning.* On day two, she presented, *Asking Good Questions: 101 Ways to Foster Excellent Communication in the Music Classroom.* Both sessions were well received by our students and quite inspirational!

Attendance for KCOMTEPS conference once again increased from previous years and set a new record. Included were one-hundred twenty-one college students and nine faculty representing a total of eight colleges and universities. The KASTA Executive Board met on Sept. 22. A wide range of topics were discussed and a few actions were taken.

KASTA surveyed membership and enlisted the help of District Orchestra Chairs to reach non-members in November of 2018 to gather information regarding the addition of a second All-State String Ensemble. The full results are included with this report. While the majority of respondents to the survey were in favor of adding a second group, the details of such a group will require further examination.

KASTA is hosting our Solo Competition again this year at the KMEA-ISW. Thank you to KMEA for their help in this endeavor. I am pleased to announce a considerable increase in performers with 20 entries this year! This includes 1 Senior Division Entry, 12 Junior Division Entries, and 7 Preparatory Division Entries.

KASTA has and/or is in the process of compiling an additional year of audition excerpts for the All-State Orchestra Auditions. Committees have been formed for each of the stringed instruments and excerpts are being discussed. Summer Miller is working to create clean copies for adoption by KMEA.

KASTA is hosting our annual Summer Workshop. The event will be held on the WSU Campus on June 21 and 22, 2019 and will feature Mr. Bob Phillips. The event will also feature a music-reading session. Many thanks to Wichita State University and Dr. Mark Laycock for their partnership with KASTA to make this event happen.

KASTA has selected Dr. Jesse Henkensiefken from Kansas Wesleyan University to serve as chair of the Kansas Intercollegiate Orchestra. KASTA has also communicated with KBA with regards to the KIO/KIB rotation and is agreeable to hosting the KIO in 2020 and 2021 to help the KIB align with the National Intercollegiate Band.

Finally, many thanks to KMEA for their help in hosting the ISW. This is an important opportunity for music educators to collaborate and we are particularly grateful for all KMEA does to help KASTA make good use of this time. Thank you to KMEA for all you do!



### KASTA SURVEY RESULTS FROM NOVEMBER 2018

## **Question #1**

Sixty one (61) Kansan string educators took this survey; 42 (69%) were KASTA members and 19 (31%) were non-members.

## **Question #2**

Of the total participants, 39 (64%) agreed that a second orchestra should be added to the All-State Orchestra event (26 strongly agreed; 13 agreed). 13 (21%) of the participants disagreed with the proposal (9 strongly disagreed; 4 disagreed). 9 (15%) members indicated they were indifferent to the proposal.

When participants were disaggregated by membership (i.e., members and non-members), no distinct patterns emerged. Of the **non-members** ( $\mathbf{n} = \mathbf{19}$ ), 7 (37%) members disagreed with the proposal, while 9 (47%) members agreed; 3 (16%) were indifferent. Neither valence (agree or disagree) received a 50% majority. Of the **members** ( $\mathbf{n} = \mathbf{42}$ ), 30 (71%) members agreed with the proposal, while 6 (14%) disagreed and 6 (14%) were indifferent (see Table 1).

These findings suggest that a majority of both members and non-members believed a second orchestra should be added to the All-State Orchestra event.

### **Question #3**

Qualitative analysis identified primary arguments for and against the proposal. Those who were in support of the proposal stated that it offered more Kansan students the experience to be part of the All-State Orchestra. In doing so, the Kansas' All-State Orchestra would become more representative of Kansas musicians instead of, what some members expressed as, an "over-representation" of "one section" of Kansas.

Those against the proposal were concerned that adding a second orchestra to the All-State Orchestra would "watered down" the experience and become "less of an honor" for students. Subsequently, they were concerned that students' motivation to audition would decrease. Other teachers were concerned that beginning a second orchestra would increase teachers' already excessive workload with little to no benefit. Still others were concerned that the current level of violin playing in the state could not support a second orchestra.



These findings suggest that valid concerns still exist on both sides. Perhaps further discussion is warranted to arrive at some consensus.

## **Question #4**

Should a second orchestra be implemented, members overwhelmingly believed that both orchestras should be comprised of 9<sup>th</sup>-grade through 12<sup>th</sup>-grade students with 43 (70.5%) of participants ranking it first in their list. Options suggesting that the orchestras be divided by grade levels (e.g., 11-12 & 9-10 or 10-12 & 9) were ranked 2<sup>nd</sup> and 3<sup>rd</sup>, with the 11-12 and 9-10<sup>th</sup> grade option in 2<sup>nd</sup> place (see Table 2).

Despite overwhelming support for the 9-12 option, one member expressed one orchestra should be for 1-4A schools and another for 5-6A school.

## **Question #5**

A slight majority (52%) of participants also believed the orchestra should be strings-only instrumentation, with 25% indifferent, and 23% supporting a full-orchestra instrumentation.

## **Question #6**

Regarding the format of the audition process, a merit model received the most support (43%), followed by the festival model (28%) and the golden ticket model (21%). <u>Although the merit format was the clear favorite</u>, no option received a majority of 50%, indicating that this issue may still be up for further discussion.

The Kansas Bandmasters Association had a successful convention this past

KS. Dennis Fisher from North Texas presented on rehearsal techniques and curriculum for band programs. We also had presentations from Dr. Jay Gilbert from Doane College, Dr. Fred Burrach from Kansas State University, Dr. Alex Wimmer from Kansas State University and our KBA Middle Level Honor Band Guest Conductor/ Composer Brian Balmages. During the business meeting, we welcomed Madame KMEA President Gretchen Bixler, as well as Madame President-Elect Gae Phillips. The Kansas Bandmasters Association had a productive fall. Our fourth annual KBA Marching Band Championship was once again a successful event. # **Kodály Music Educators of Kansas Matt Hanne**

On August 25, KMEK hosted a Back-to-School picnic for the membership. This informal gathering took place at Pleasant Valley United Methodist church in Wichita, and involved group folk dances, games, and a potluck lunch. We had around 20 members who attended for at least part of the picnic.

On September 9, KMEK hosted its Fall Workshop. Our clinician was Aileen Miracle, who presented a workshop entitled "Assessment and Program Planning in the Music Classroom". This excellent workshop provided some novel methods of assessment, some involving technology, as well as a variety of approaches to planning Elementary music concerts. Due to travel difficulties, the workshop ended up starting late, and following a modified schedule, but attendees still learned a great deal and received excellent, practical ideas for their classrooms. Nearly 20 college students attended the workshop, from Wichita State and Emporia State, and we had around 45 attendees total.

On January 26, KMEK hosted its Winter Workshop - "A Kansas Sampler". For this workshop, it has become a tradition to feature homegrown talent from Kansas, and we feature presenters who will be or have recently presented at other conferences, or presenters who have special areas that they have researched. For this workshop, we had three presenters - Matt Hanne, Ben Rivers, and Ashley Reichenborn. Matt presented about two older, out-of-print Kodály resources. Ben shared ideas about teaching culture within the music classroom, and how to do so in age-appropriate and respectful ways as a means of building empathy and helping students to understand people who are different from themselves. Ashley taught about African drumming. She shared instructional sequences for drumming technique, improvisational methods, group rhythm patterns, and cultural information about African drumming. Both Ben and Matt will present their sessions at the upcoming National Conference for the Organization of American Kodály Educators in March. We had 32 attendees at this workshop, including 13 students from WSU.

KMEK's Spring workshop will be held on April 13. It will feature a morning filled with Contradancing, and a session on how to teach folk dance. The afternoon will involve preparation sessions for the summer certification courses held at Wichita State University (June 2-14, 2019).

Kansas Music Teachers held its annual State Conference and meetings at Emporia University, Wichita, on September 23-24, 2016. Through publisher support we were able to treat conference goers to the wealth of pedagogical selections of well-known composer, Dennis Alexander.

The Fall Auditions is a major offering of KMTA. Organized alongside the MTNA competitions, the state has expanded the number of involved teachers and students to include 3 categories for each of the age levels from grades 3 to grade 12. This year the number of students that participated at the district auditions typically exceeds 600; state auditions, more than 500 students.

In the spring, many associations will organize to host Music Progressions, our non-competitive comprehensive evaluation of progress in several written and performed areas. In addition, the state has increased what it distributes to \$3,500 each year in local association grants by application/selection. Local associations receive support for events ranging from multi-piano concerts and clinics, and master classes, extending to nearly 600 students.

Plans are underway for the next State Conference, planned for September 27-28 at Tabor College in Hillsboro, KS.

# **Choir Alignment Committee Board Report February 2019**

The choir alignment committee met twice this past year to discuss options for the alignment of the KMEA State Choirs. Data was collected from Troy Johnson showing the grade levels of each ensemble, number of students auditioning, and number of students selected for each voicing and grade level. This data was examined at the first meeting, and then committee members and district presidents took the information to their mini-conventions this past year and discussed with their district memberships.

From these discussions, and with additional data provided by the districts, the committee met again in January and considered the options as presented by the choir alignment committee members and district presidents. The committee unanimously decided to propose that the state choir alignment to be as follows beginning with the 2019-2020 school year:

Elementary choir: grades 3-5 Middle Level choir: grades 6-8 High School choirs: grades 9-12

In addition, with the Kansas Choral Directors Association waiting for a decision from the choir alignment committee with regards to the KMEA choir grade levels, we have suggested that the KCDA Treble Choir change to grade levels 6-9.

I would like to thank our committee members for their valuable input during our meetings and to our district chairs for their work collecting information for the committee. Also, thank you to President Gretchen Bixler and Executive Director John Taylor for their guidance throughout the process. Finally, many thanks to Troy Johnson for helping with data collection. Much appreciation to all!

## **ADDENDUM 2**

### KANSAS C-NAFME CONSTITUTION

#### **PREAMBLE**

It is our desire to enjoy the associations, to share the responsibilities, and to increase our interest and knowledge in all areas of music education through the National Association for Music Education.

#### **ARTICLE I - Name and Affiliation**

- Section 1. This organization shall be known as the Kansas Collegiate Member Chapter of the National Association for Music Education, C-NAfME.
- Section 2. This organization shall have affiliate relationship to the Kansas Music Educators Association.

## **ARTICLE II - Purpose**

It shall be the purpose of this organization to:

- a. Make available to members opportunities for professional development.
- b. Acquaint students with the privileges and responsibilities of the music education profession.
- c. Provide for its members opportunities to become acquainted with leaders in the music education profession as gained from participation in programs and demonstrations, discussions, and performing groups planned by this organization.
- d. Provide opportunity for contacts with individual MENC student members of this and other states.

## **ARTICLE III - Membership**

- Section 1. Membership shall consist of all registered Kansas C-NAfME chapters and their members.
- Section 2. Any student chapter member, upon complying with the registration requirements, may attend the conventions of the <a href="NAfME">NAfME</a>-National and Division, and the federated state association, with all the rights and privileges of active membership except those of voting or holding office. He/she may participate in activities



carried on by the NAfME student Member Chapters, its divisions and federated state associations, in connection with conventions and other meetings.

Section 3. Each member will receive the state student **NAfME** publications.

### **ARTICLE IV - Officers**

- Section 1. The offices of this organization shall be President, Vice-President, and Secretary-Treasurer.
- Section 2. The offices of President, Vice-President, and Secretary shall be filled by election.
- Section 3. Any candidate for office shall have been an officer of his/her local student chapter for at least one full semester (or quarter) prior to his/her nomination.
- Section 4. Each officer shall assume his/her office at the conclusion of the first meeting of the KMEA Board of Directors following the In-Service Workshop and serve through the first meeting of the Board following the In-Service Workshop the following year.
- Section 5. In case a vacancy occurs in the office of President, the Vice-President shall assume the duties of that office for the remainder of the term of office. The vacancy in the office of Vice-President, (at this time or any time), would then be filled by the candidate with the next highest number of votes from the election of the previous C-NAfME business meeting. Upon notification, he/she would assume office for the remainder of the term. In case a vacancy occurs in the office of Secretary-Treasurer, the current President shall fill the position by appointment.
- Section 6. These officers shall be considered the State C-NAfME Executive Council.

#### **ARTICLE V - Duties of Officers**

- Section 1. It is the duty of the President to represent the organization, uphold the principles of the constitution, organize regular business meetings of the State Executive Council and preside at those meetings, oversee nominations and elections for new officers, appoint committees subject to the approval of the State Board, encourage C-NAFME communications, report the chapter activities for publication in district, regional, state, and/or national periodicals, and attend all meetings of the KMEA Board of Directors—both the Outgoing and Incoming Presidents shall attend the first meeting of the Board following the In-Service Workshop.
- Section 2. It is the duty of the Vice-President to preside in the absence of the President, assist the other officers in planning activities, attend KMEA Board meetings at the request of the President, and chair any meeting as requested by the President.



Section 3. It is the duty of the Secretary to keep accurate records of meetings and business, keep current roll of student chapters, and keep in touch with members of this chapter and other chapters. Also, he/she is to be responsible for the collection of any monies of the organization and their record.

#### **ARTICLE VI - Elections**

- Section 1. Election of officers shall be held during the annual C-NAfME luncheon.
- Section 2. A quorum shall consist of those in attendance at the C-NAfME business meeting
- Section 3. A Chapter Information Sheet shall be sent to each registered C-NAfME chapter by the state faculty advisor or Executive Council. Space will be provided for nominations for the offices of President, Vice-President, and Secretary. Information sheets shall be filled out by the chapter advisor and sent back to the State President.
- Section 4. Any student registered in C-NAfME and present at the KMEA In-Service Workshop is qualified to cast one vote for each office.
- Section 5. Elections shall be by private ballot.
- Section 6. To be elected, a candidate must receive a simple majority of the vote cast for that office.
- Section 7. In the event that no candidate runs for the office of President, the candidate for Vice-President who receives the most votes will become President. In the event that no candidate runs for the office of Vice-President, the runner-up candidate for President will become Vice-President. In the event that no candidate runs for the office of Secretary, the current President shall follow the procedure as stated in Article IV, Section 5.

#### **ARTICLE VII - Recall**

- Section 1. All officers are subject to recall by a signed petition of at least 30% of the registered local CMENC chapters.
- Section 2. Should a recall election occur, Article IV, Section 4 will still apply.

#### **ARTICLE VIII - Executive Council**

Section 1. Management of this organization shall be vested in the State Executive Council responsible to the entire membership to uphold this constitution.



- Section 2. This Council shall consist of the officers of the organization and the advisor as an ex-officio member.
- Section 3. It shall have the power to make necessary decisions in all matters not specifically acted upon by the group.
- Section 4. It shall meet at least once between regular meetings of the entire organization and plan future activities.

## **ARTICLE IX - State Board**

Section 1. The State Board shall consist of one representative from each active chapter and the Executive Council.

## **ARTICLE X - Meetings**

- Section 1. There shall be three regular board meetings of this organization per year.
- Section 2. Special meetings may be called at any other time as determined by the President and/or faculty advisor.
- Section 3. Advance notice will be sent to all student chapters in the state for meetings.
- Section 4. Robert's Rules of Order, Revised, shall serve as a basis for parliamentary procedure.

## **ARTICLE XI - Sponsor**

Section 1. There shall be a faculty advisor appointed by the KMEA President who shall be a member ex-officio of the Executive Council.

### **ARTICLE XII - Amendments**

- Section 1. This constitution may be amended by a two-thirds (2/3) majority vote of this in attendance at a C-NAfME board meeting. Any amendments moved and accepted shall not become binding until ratified at the next council business meeting.
- Section 2. All chapters shall receive advance notice of the proposed amendment at the board meeting prior to the anticipated vote.
