IV. a – Executive | Please go to the Board Book for the June Board Meeting to read all reports in full. Only new and or updated notes will be included in the minutes.

- President, Martha Gabel Report stands as written. President Martha wished to highlight the Music Advocacy Day that took place on March 12, including the distribution of advocacy packets, serving breakfast to legislators, and meeting with Brad Neuenswander, the interim commissioner for KSDE. She also enjoyed the entertainment provided by Washburn Jazz combo and 1st Infantry Division Brass Quintet. She thanked those who participated in the strategic planning meeting. President Martha noted the meeting with the Kansas State Board of Education in May where KMEA provided them with information about the organization.
- President-Elect, *Gretchen Bixler* Report stands as written. President Elect Gretchen met with Dr. Taylor after the ISW to begin her training. She appreciates the faith that the members of KMEA have in her. Gretchen also noted that she has been working on preparing the listening rooms, which has near record numbers of entrants this year, particularly in the elementary room.
- Vice President, Avian Bear Report stands as written. Vice President Avian said she is enjoying being the KMEA Vice President and it has been a joy to watch Martha take over as President.
- Executive Director, *John Taylor* Report stands as written. Dr. Taylor noted that everything is booked for the 2016 ISW. He has signed contracts with the Hyatt through 2018. He is asking for a motion on the use of the Expo Hall for future ISWs and is excited about the features it will provide. Dr. Taylor announced that KMEA will continue to provide the bus to Old Town on Friday of the ISW and that Century II will no longer provide free Wi-Fi access. He indicated that KMEA will end the year with money in the bank and he was able to place \$20,000 in reserves (investments and the KMEA fund) Dr. Taylor noted that KMEA will not be raising membership dues this year. The All-State conductors are contracted for this year, and that a major scanning project of historical

	• Northwest District, <i>Stacey Williams</i> — Report stands as written. Stacey thanked Connie Reishus for diligently working on updating the bylaws.
	• Southwest District, <i>Lynn Unruh</i> – Report stands as written. Lynn announced that the SW District is trying something new in putting the Middle School Honor Choir and Elementary Honor Choir on the same day.
IV. c NAfME Collegiate President	NAfME Collegiate, <i>Alissa Gomez</i> – Report stands as written. Alissa noted that she has been in contact with Lori Supinie at Senseney Music to plan for the Sunday activities of KCOMTEPS. She also is excited to work with Jacob Dakon on booking the clinician for Monday. She is looking forward to traveling to Washington DC and is grateful to the leadership for being warm and welcoming.
IV. d – KMEA Staff	• KMR Editor, <i>Steve Oare</i> – Report stands as written. Steve noted that as this is the 4 <sup>th</sup> year for the online KMR, they are considering some adjustments and changes to the magazine. He discussed the possibility of moving to a continually published subject-based journal, rather than an issue-based one; Steve also mentioned they have considered changing from asking for advertisers to asking for sponsors. These and other possibilities will be discussed at length during several additional meetings with the KMR team in the coming year, and then they will approach the board with any new recommendations they have.



IV. d – KMEA Staff (continued)	Advertising Manager, Robert Lee – Report stands as written. Robert noted that the discussion about advertisers has come about because he has noticed a declining trend in the number of advertisers since going to an exclusively online publication. He explained that many advertisers do not feel they are getting enough "clicks" on their website link from their position in the online journal.
	• ISW Exhibit Manager, <i>Dana Hamant</i> – Report stands as written. Dana highlighted the exhibit questions he had in his report and asked for discussion from the board on the issues. A motion was requested for an institution of late fee charges on exhibitors who register after February 1. The board discussed when several stores are under one name, should they be considered one entity or individual stores and how they should be listed in the program and/or maps. Dana also offered requests for the return of the coat check for retired members, a catered lunch for exhibitors, and a raffle at the opening of exhibits.
	• Web & Technology Manager, <i>Troy Johnson</i> , - Report stands as written. Troy explained that the ISW website was the biggest change this year. It can be accessed on any device and allows people to answer many of their own registration questions. The onsite online registration handled about \$6000 in transactions at the 2015 ISW. Troy intends to archive each year's ISW website and remove any interactive elements. He also noted that Century II will not be supplying free Wi-Fi access this year. Troy expanded on some plans to develop a state manager system that can be expanded to handle all district level honor group auditions, where student profiles can be transferred from feeder schools all the way through 12 <sup>th</sup> grade. Lastly, he showed the board the advocacy video that was filmed at the 2014 ISW with the intent to share with legislators; the topic of the video is "What does music mean to me?"

Since the June Board meeting, I have the following items to report.

- 1. In June, I attended the NAfME NEB National Assembly in Washington, D.C. In July I attended the PBM luncheon. I will attend the NAfME Southwestern Division Board Meeting in Denver in November. I have also had meetings with Executive Committee members and with selected employees.
- 2. The fiscal year ended on June 30. At the writing of this report, the books for the fiscal year 2014-2015 are being reviewed by our CPA. We will finish the year in the black. Even with increasing costs during the ISW (use of facilities, adding additional facilities, etc.), I will not be recommending additional fee increases for the 2016 ISW. We will have some new software to purchase during this fiscal year for Troy Johnson for use on the KMR website. Additional funds will be expended soon for an update to the KMEA website and for the creation of the All-State Elementary Choir section of the website, which includes an audition program. A complete financial report for fiscal 2014-2015 will be given during this Board meeting. I will request approval of that report.
- 3. Our investments have decreased slightly this year, although losses occurred in the 3<sup>rd</sup> and 4<sup>th</sup> quarters of 2014. We are actually up for the first two quarters of 2015. The KMEA Fund is volatile, but it continues to increase annually in value. In June, I transferred \$10,000 from the checking account into the KMEA Fund and an additional \$10,000 into our Wells Fargo investments. We can now pay for 3 of our \$500 scholarships to students through the Fund. (In 2014, I erroneously reported that we could fund all of our scholarships due to some inaccurate information I had been given.)
- 4. The fiscal year review includes a review of the books from the six Districts. The Executives can present a review of their books to the District Boards. Our report to the IRS includes all State and District funds under one umbrella and one EIN not-for-profit number. This past December, I completed 1099s and W2s for the State and for the Districts. W9s are completed for all State and District salaried and fee transactions (both income and expenses). We hold two annual meetings with the District Executives one before this Board meeting and one on Thursday evening of the ISW in February. We are all indebted to our District Executives, who do excellent work to keep the District finances solvent. As I mentioned at the June Board meeting, I am starting discussions to review the structure and bylaws of the six Districts. My discussions are currently with the District Executives, but will progress to including the District Presidents probably starting in the summer of 2016.
- 5. All facilities bookings for the 2016 ISW are completed, including booking for the Garvey Center and the Metropolitan Baptist Church. Currently, all All-State ensembles are scheduled to be in the same locations as during the 2015 ISW. In addition, a number of hotel rate contracts have also been negotiated and signed. Costs continue to rise for use of the facilities and all the other services to the ISW. A contract to secure the rental of Century II for the 2018 convention was completed and a deposit paid in late June. I will be working



with some of our employees as we plan to utilize Expo Hall for our exhibits and registration for the 2017 ISW. I want to have these plans in place by the 2016 ISW. We will collect additional information from the exhibitors at the 2016 ISW, then finalize our plans next summer. I will continue to monitor the progress by the City of Wichita on the renovation of Century II Convention Center.

- 6. Free wireless internet will NOT be available in Century II for the 2016 ISW. The City of Wichita is switching to a paid internet service. Members will be required to register for this service if they wish to have access to the internet. This is a change from the past several years. District Presidents are encouraged to notify members of this change.
- 7. Contracting for guest artists and clinicians for the 2016 and 2017 ISWs is complete (some final paperwork is being secured). By the time of this Board meeting, I hope to have started the process of booking conductors and clinicians for the 2018 and 2019 with the new Assistant Chairs. The 2016 All-State conductors are: Eric Richards, Jazz Band; Eph Ehly, High School Choir; Elaine Quilichini, Elementary Choir; Andrew Boysen, 56A Band; Rodney Dorsey, 1234A Band; Jonathan Shames, Orchestra; and Jeremy Manternach, Middle Level Choir. Three Elementary Clinicians will be booked. Denise Gagne has been contracted, and Julie Sluyter is negotiating with the other two clinicians.
- 8. ISW onsite registration will continue to be paperless this year. We learned a valuable lesson at the 2015 ISW when the internet went down on Friday afternoon. Luckily, it did not have an impact on registration since traffic is very slow at that time. Troy Johnson and Michelle Postier are working to have a back-up plan to avoid this problem at 2016 onsite registration.
- 9. I have been working to bring the KMEA office into compliance with the new Records Retention Policy that the Board approved last summer. I should have this completed by the February Board meeting. I am bringing several items that the Board requested from me during the June Board meeting, including a request for a new scholarship in honor of Don and JoAnne Corbett, a proposal for a revamped Leadership Camp (in conjunction with Vice-President Bear) and a revised copy of the audition categories to perform at the ISW. The scholarship and audition requests will require a vote from the Board.
- 10. I have met with Steve Oare, the KMR Editor, to begin the final phase of our online journal. This is the final phase of a multiple-step program for the KMR. Steve will meet with Bob Lee and Troy Johnson to plan this transition. They will bring a tentative plan to the February Board meeting and then present a final proposal for approval at the June Board meeting. Tentatively, this plan will lead to an online website that is not tied to publication dates. Updates to the KMR will be made on an ongoing basis with regular notification to all KMEA members. Changes in advertising will also be included in the plan. The Executive Committee decided to discontinue the use of Desiree Kelsch's services as graphic designer for the KMR. Desiree has been notified. She has been very dedicated to the KMR work, but with the current format online, a graphic designer is not needed. Desiree was not a KMEA employee she was an outside contractor. Troy Johnson will be working on the template for the revised KMR website. I want to commend our KMR staff, including Steve Oare, Bob Lee, Troy Johnson, Desiree Kelsch, and our former Editor, Cathy Hunt. Each



year, the Editors from the various state MEAs meet. The first year that Cathy Hunt mentioned our move to online, none of the other Editors was interested. However, the next year, Cathy and Troy Johnson were asked to make a presentation about our online process. Currently, many states have gone to some form of online journal (albeit some are pdf-based). NAfME has also since moved to an online format for many of the national journals, including the MEJ, which will be online starting January 2016. This year, Steve mentioned the possibility that we will move to a web-based format that is not tied to issues. Many states were interested in hearing about our work. It is because of the efforts of our KMR staff that Kansas is a clear leader in not just quality of our journal but also in its technology usage.

- 11. As mentioned, I have begun a scanning process to get many of our important records onto the KMEA website, including Board minutes, ISW schedules, All-State programs, and KMR issues. The Board minutes back to the beginning of our organization have been scanned. Work has begun on the ISW schedules and All-State programs. We have ISW schedules back to 1939, with only a few missing years. The All-State ensembles began in 1960. Some of the records through 1990 are sketchy, and there are several years for which we have no records at all. The KMR scans will be the final step. They will appear as pdf scans on our website. We have KMRs going back to the 1940s. Alissa Gomez, our State Collegiate NAfME President, has been hired to complete the scanning project.
- 12. We have wonderful KMEA employees who work for minimal salaries and dedicate countless hours to KMEA. Please thank these people when you have the chance.


Our Honor Administrator and Outstanding Teachers have been selected but not yet notified. More information will be posted as they are announced.

We are in the beginning stages of implementing a recorded tryout for Mid Level Honor Band. The sub-committee will be bringing their recommendations to the district at our Downbeat Session.

After discussion of this issue at District Mini-Convention and also receiving feedback by e-mail from several directors from the District, we will be requiring a minimum for 33% of the total points on the audition rubric to be considered for selection to the District Band—currently that point total will be 41 out of the 125 points possible on the rubric.



  - o The board granted permission to move forward with presenting the bylaws to the membership of the northwest district.



Since the June 2015 KMEA Board Meeting, I have:

- 1. Attended the NAfME Collegiate Advocacy Summit in Tyson's Corner, VA, on June 24-26, 2015. Shannon Kelly and Christopher Woodside directed the convention, and I worked alongside 70+ collegiates from over 26 states to advocate for music education and the reauthorization of ESEA, Senate Bill 1177. The new bill, Every Child Acheives Act, was passed by the Senate on July 16.
- 2. Attended the NAfME National Assembly, June 24-29, directly following the Advocacy Summit. I participated in a district meeting as well as the strategic planning meeting for 2017-22. This also included a special tour of NAfME Headquarters from Marlynn Likens with Executive Director, John Taylor and President-Elect Gretchen Bixler. We spent quite a bit of time outside looking for the KMEA brick!
- A special thank you to the Martha, Avian, Gretchen, Mike, and John Taylor for so graciously including and involving me in this experience!
- 3. Updated the C-NAfME Online Rolodex.
- 4. Emailed all active C-NAfME chapter advisors requesting updated chapter contact information and activity reports, and emailed former chapter advisors (or music department faculties) of schools with inactive chapters to determine reactivation interests. Colby Community College, MidAmerica Nazarene, Bethany, Tabor, and Southwestern have expressed interest in starting or reactivating chapters.
- 5. Communicated with Executive Director John Taylor regarding the KCOMTEPS speaker, Jennifer Bailey- we have received her contract and she will be presenting during Monday's portion of the conference. I've also began coordinating a student panel to present at the KCOMTEPS conference.
- 6. Attended the KCDA convention in Topeka and represented KMEA and Collegiate NAfME members by presenting at two clinics and speaking about the NAfME National Assembly Hill Day at the Friday luncheon.

The KMR staff is currently preparing for a big change. In fact, the change has begun as our graphic designer, Desiree Kelsch, will no longer be working with us. It was determined that the online model we now use allows us to relatively easily absorb her duties. This move saves the KMR over \$4,000 per year.

Our staff is also considering a major re-design in the way the KMR presents content and operates advertising. Because of its online nature, we feel it is wise to move away from our traditional quarterly journal and toward a more dynamic one like that of for-profit online magazines. Our hope is to publish at least one article every two weeks and send out a mass email to KMEA members informing them of the new material. We predict that this frequency of email reminders will keep the KMR in the thoughts of our membership and therefore increase readership. Troy Johnson, Bob Lee, and I met on July 15 for over seven hours to discuss our vision for the journal, for advertising, and to create a subject map for the new web page. Part of the discussion focused upon the pros and cons with the ability for readers to comment on articles. We concluded that a win-win would be to include a "letters to the editor" page. The draft of our map is included below.

In regard to advertising, we considered two issues. First, we have historically charged our advertisers relative to our quarterly issues. As we eliminate the quarterly publications, we will need to move to a monthly or a yearly fee. Second, we are considering the difference between advertisers and sponsors. Based on our current list of advertisers, we realize that they advertise with us more as a means of supporting the KMR rather than as an effective marketing tool. Therefore, we feel it may be more appropriate to call them sponsors. Our initial plan is to offer sponsors who give the KMR a \$300 annual gift the opportunity to place 300x600 or 300x250 ads for their businesses at any time and to have their logo in the footer of every page. Other sponsors who support us at lower levels would be provided the opportunity to place 300x250 ads in the page for a specified period of time based upon the level of gift. We are currently researching the legal and tax ramifications of this idea.

Obviously, we still have a great deal of work to do in our planning. Once we design a new website, we will also need to seed our subject areas by transferring our past online articles into their respective areas. We plan to have a model website and a finalize sponsorship plan for the board at the February meeting.

The following work has been completed since the June board meeting, or is currently in progress:

#### **KMEA Website**

A new KMEA website is in development using WordPress as the CMS (Content Management System) for the public-facing pages. After the state website has been upgraded, new district websites will be built using the same template in order to create a unified look throughout the state. All sites will retain their existing URLs and essentially the same navigation tabs. There are a few minor differences in some of the tabs in order to make certain content quicker to find. For example, "All-State" will become a top-level tab in the new state site as it is one of the most visited sections of our website. The new state site should be ready to launch by mid-August, and district sites will then be upgraded as time permits.

#### **Manager Systems**

#### http://systems.ksmea.org

All "Manager" systems (registration, operational modules, et al) need to remain outside of the WordPress core. These minisites will be migrated to the new Systems site as needed during the 2015-2016 school year, based on the KMEA calendar. The three All-State Manager systems (Elementary, Middle Level Choir, High School) have been installed in their new locations in the Systems website and will be ready for launching in early August. District-level honor group registration will be moved to this site as well during the Fall 2015 semester since they cannot remain in their current locations due to the upcoming WordPress upgrades. Links will be updated on all sites to reflect each change as they occur.

#### **Kansas Music Review**

The KMR team met on July 15 to begin plans for a new KMR version. We are considering doing away with producing four issues each year in favor of more frequent content being posted in subject-based areas. The domain name KANSASMUSICREVIEW.COM has been secured and currently redirects to the existing KMR address (http://kmr.ksmea.org). This domain name would eventually become the only URL for the KMR upon launching a new version on a WordPress platform.



#### **Elementary Choir Manager**

An Elementary Choir Manager (online audition system) has been prepared in the Systems site to host auditions for the new KMEA All-State Elementary Choir. This system is styled after the KMEA Middle Level Choir Manager.

Teachers will record their auditions to mp3 format and upload them to the KMEA web server via a web interface. Judging will also be handled online via web interface. Judges will be able to listen to recordings at their own pace. They are not pressured to do all judging in one day. However, as a safeguard, the state chair is able to view the progress of each judge to ensure that judging is completed in time.

#### Teachers will...

- record their students' auditions to mp3 format files.
- register their students in our online database.
- upload the mp3 audition recordings to the database.

#### Judges will...

- login and listen to the auditions.
- score the auditions using the established rubric.
- be able to listen to each entry as many times as needed.
- identify disqualifying factors found in the recordings.

#### Judges will not...

- know who they are listening to.
- have access to any identifying information for each entry.

#### The KMEA All-State Elementary Choir Chair will...

- login and verify completion of judging.
- validate disqualifying factors as identified by judges.
- be responsible for taking questions regarding policy of the Elementary Choir
- generate the final roster for publication.
- notify teachers of selected students.

#### The KMEA Ensembles Manager will...

• receive audition and participation fees.

#### The KMEA Webmaster will...

- monitor data processes during the registration and judging timeline.
- be responsible for taking questions about using the Elementary Choir Registration site.
- post the final roster online when it has been released.

I'm making arrangements with the upcoming judges to provide their training via remote web connection. ML Choir judges can also receive remote training, if needed. The judging module is very self-intuitive.



## Membership Website http://members.ksmea.org

Under development is a new membership site which will serve as a host for member data and voting elements at both the district and state levels. This new site comes with a "responsive" layout, meaning it can be accessed on any device or screen size and utilizes touch-oriented controls for easy navigation on smartphones or tablets. The site works equally well on desktop computers. KMEA members are now able to create an account in this new system if they are current with NAfME. Members may now also



affiliate their account with a specific KMEA district. More information on this will be provided during my report at the meeting. The code work for elections is currently in progress. KMEA members will need a current membership in NAfME in order to participate in KMEA elections. My intent is to make it possible for district presidents to be able to generate ballot questions "on the fly" as well as obtain immediate results.

KMEA members will not be able to renew their membership via this system. That can only be completed at NAfME's site.

The 2015 KCDA Summer Convention, Choral Connections, was held July 9-11, 2015 at the Capitol Plaza Hotel and Convention Center in Topeka, Kansas. This year's event boasted a record breaking 215 and was our first to be held at the Capitol Plaza-Topeka. The venue change was very well received and was widely seen as an improvement from our previous convention locations. Our programming included over thirteen clinics and ten music-reading sessions addressed multiple levels and a variety of relevant topics. Convention headliners were Dr. Andre Thomas (Florida State University), Eric Barnum (Composer/University of Wisconsin-Oshkosh) and Mary Lynn Lightfoot (Composer). In addition, a host of choral directors from across the state served as session presenters. The event also featured the KCDA All-State Women's Choir, the first ever KCDA All-State Men's Choir and guest ensemble, Heartland Men's Chorus (Kansas City, MO). The All-State Women's Choir was conducted by Dr. Andrea Ramsey (University of Colorado-Boulder). The All-State Men's Choir, featuring 102 young men, was conducted by Jake Narverud (Emporia State University/Allegro Choirs-KC). KCDA recognized Eli Jones (Eisenhower Middle School, KCKS) with the 2015 Prelude Award for outstanding young directors in their first five years of teaching. The Harry Robert Wilson Award, recognizing a career of distinguished service to choral music in Kansas, was given to Mary Bodney (Retired, Blue Valley North High School, Leawood, KS). The close of the convention marked the end of Laura VanLeeuwen's term as KCDA president. She passes the office to new KCDA President, Dustin Cates. Finally, Dr. Cindy Sheppard was elected KCDA President-Elect.

*Kansas Sings!*, the 2016 KCDA Summer Convention, will be held July 7-9, 2016 at the Capitol Plaza Hotel and Convention Center. Current event details include presenters: Dr. Kevin Fenton (Florida State University), Dr. Ysaye M. Barnwell (Composer/Sweet Honey in the Rock), Mark Hayes (Composer), Dr. John Leavitt (Mid America Nazarene University) and performances by the All-State Men's and Women's Choir, a state-wide Church and Community Honor Choir and the Te Deum Chamber Choir from Prairie Village, KS.

The new KCDA board met on July 11, 2015. Agenda items included a review of the convention and a discussion of changes being proposed by Elise Peterson and Dr. Dwayne Dunn to the format of the KMEA All-State Choir. The board endorsed the need to explore All-State Choir changes but opted not to endorse any specific alteration until data from the All-State Choir Survey is made available. The board will meet again on September 26, 2015 for a Strategic Planning Retreat.

#### **Definitions**

#### State location

Only schools located in Kansas are eligible to audition to perform at the ISW.

#### Elementary

All elementary schools that include some or all of grades K-6. Sixth grade-only ensembles are considered Middle School groups.

#### Middle School

All middle schools/junior high schools that include some or all of grades 6-9.

Sixth grade-only ensembles are considered Middle School groups.

Ninth grade-only ensembles are considered High School groups.

#### High School

All high schools that include some or all of grades 9-12.

Ninth grade-only ensembles are considered High School groups.

#### Community College

All two-year colleges (public or private)

#### Private University

All privately-funded four-year universities or colleges

#### Small University

All publically-funded universities not classified as Large Universities that have a fouryear undergraduate program.

#### **Performance Group Categories** (continued)

#### Large University

Kansas University Kansas State University Wichita State University

#### Community/Professional

Community or Professional ensembles are those that include one or more ensemble member(s) who are non-student members and/or members from more than one school building.

#### Master Works

Ensemble combinations that wish to perform a master work(s) together.

The audition recording must be a master work(s) performed by the combined ensembles. Audition recordings will need to be approved by Listening Committees in all genres on the recording (e.g., choral and orchestra, choral and band, etc.)

#### Minimum size

Ensembles must include 3 or more members to be eligible to audition to perform.

#### Band

Concert Bands of 25 or more members (perform in Century II Concert Hall)

#### Choir

Concert Choral Ensembles of 25 or more members, including choral ensembles of all genders (these ensembles perform in Century II MJT Little Theater).

#### **Show Choir**

Any choral ensemble that sings only popular music literature and utilizes choreography/movement for a majority of their musical selections (these ensembles will perform in Century II MJT Little Theater).

#### Orchestra

String orchestras, full orchestras, or combinations of these two ensembles (these ensembles will perform in Century II Concert Hall). Orchestras that will perform at the ISW with a combination of full and string selections must have at least one full orchestra selection on the audition recording.

#### Jazz

Traditional big bands, combos, and jazz choirs (these ensembles will perform in the Jazz Room - usually Hyatt Ballrooms F-H).



#### **ADDENDUM**

### **Performance Group Categories** (continued)

#### Chamber Ensemble

Any ensemble of 24 or less performers, including all genres (these ensembles will perform in a Century II or hotel meeting room).

#### Friday night concert

Only university or college bands, choirs or orchestras with four-year undergraduate programs are eligible to perform on the Friday night ISW Concert.



## ADDENDUM Don and JoAnne Corbett Scholarship

The Don and JoAnne Corbett Scholarship is a \$500 award given annually to honor the service of the Corbetts to KMEA and NAfME. Don served KMEA in various offices before serving as President of KMEA from 1971-1973. Don later became NAfME Southwestern Division President, and served as NAfME President from 1986-88. Don served as KMEA Executive Director from 1992-2002, and continued to serve as the ISW Exhibits Manager. JoAnne served KMEA faithfully for many years, and was eventually named the Assistant to the Executive Director. Don Corbett entered the KMEA Hall of Fame in 1997 and in 2003 became a NAfME Lowell Mason Fellow.

This scholarship is awarded to a Music Education major who is a Collegiate NAfME member at a four-year college or university in Kansas. The award is granted during the semester of student teaching. It is given to assist students at the completion of their programs when their expenses are high, the time to work a job is often limited, and when they usually don't qualify for new scholarship funding. The award is presented to the student, and may be used for any expenses incurred during student teaching, including but not limited to tuition, travel expenses, or living expenses.

The deadline for application is February 1, and the student will be notified during the C-NAfME Luncheon at the In-Service Workshop following the application deadline. Students will apply to receive the award during the semester of student teaching, which must be in the fall or spring semesters during the school year following the February 1 deadline. If a student does not student teach during one of these semesters, s/he forfeits the scholarship.

Students must compete the Corbett Scholarship Application and submit an essay of 500 words or less describing why s/he wishes to be a music educator.

- I object to the statement that Students are not having a great experience in the State Choir only some students!
- sight reading for auditions I'm increasingly hearing about teachers who teach k-12 everything and don't see their students every day. Teaching sight singing to be able to use it as an audition tool is simply not feasible in many of these situations. Also, Kansas does not require that music teachers be licensed or even trained in music, and today at KCDA I sat by such a teacher. There are more and more of them being employed in our state, and there's no way on earth they are going to be able to teach sight singing to their students...
- I teach in a small 3A in the NC district, and I strongly support the two equal choir idea. Just because a student is from a 1-4A school does not mean they are not capable of singing at a high level.
- Mainly, I would like all districts competing on an equal footing. Presently, the NC doesn't even show up in January. We also have a component...that may or may not get voted out at the next District meeting, that allows one student make an Honor group from every school. For HS...and an honor group...I believe this has no place. There should be a minimum score and a higher standard...or we may as well go to a paper audition like most MS honor groups. I believe the NC is the only district that does not have choir audition in January. ALL HS honor group members should be based on one criteria only...that being the quality of the audition. Other factors should be tossed. HS KMEA honor groups should have the best auditions possible making the group based only on the quality of their audition.
- having two choir (not north/south split) would create the issue of having to prepare double the amount of lit am I thinking correctly on this? I would like to second the report from the 1 4A and 5 6A bands that it took about 2 years, and the quality of the 1 4A bands is very high, and that it really does depend on the literature and the all-state clinician as to how their performance goes. It's not a 1 4A "lesser" quality band.
- I would support a women's choir and a mixed choir at the state level. More girls than boys audition at the district level.
- As we discuss bringing district audition procedures into alignment with one another, an element not previously mentioned is that some districts release the cuts a week in advance, while others announce cuts just prior to the audition. Having seen/heard exceptionally talented students tank an audition, (due to confusion, unfamiliarity, forgetting paper clips, flow, etc.,) I can't help but wonder how much better they might have done had they been able to focus their energies on the particular cuts the final week before auditions. We do want our kids to have their best shot, don't we? Having taught in districts where each of these methods was used, I, along with my students, preferred knowing the cuts beforehand.
- Instead of 1234/56 split, what about the second choir being a Women's Choir like they do in SC district? food for thought There are many variables that need open discussion. Any changes need to carefully thought through and explore all possibilities
- Music is fun!



- It is difficult enough for me to get students to audition for honor choir, as music is viewed differently in our area's culture. The sight-reading component would deter my already shy students from being willing to audition.
- I think if we go with the 1-4A and 5-6A choirs they need to be separate performances like the bands. It's too easy to compare groups that are back to back and I don't think that's fair to either group.
- I am strongly in agreement with adding a Women's Choir to correct that disparity, rather than separate 1-4, 56.
- Perhaps we could do a 9-10 choir and an 11-12 choir. What do other states do for their process. Sight singing will aid in the learning of the music (which we have very little time to teach), and for crying out loud this is All State Choir! It should be the best of the very best!
- I think if we go to 1234 and 56 choirs, the SC District should do away with the Women's Choir so some girls wouldn't have to learn two sets of music.
- I am not on Facebook, so I will communicate with Elise. I am the only 5A school in SEK. I will have an unusual and complicated impact with the upcoming changes. It was difficult to answer many of these questions because I don't know how the audition process would affect me if we split to an1-4 and 5-6 choir. How could the process be fair and consistent for my situation?
- I strongly agree that we need two choirs. I strongly disagree in making another audition date in January to make this possible. I would really like to find a way to keep it as on audition in November
- I think the logical choice is two choirs, like band. The extra audition causes problems because I currently teach both band and choir. I am up for helping in any way possible. I just want what is best for my kids.
- I think you have to limit the number students who try out from each district. Our district allows one student from each school to be represented in the district ensembles, no matter their skill. Directors need to use common sense and only allow their best to audition for state.
